### Govt to introduce water taxi in Mumbai region shortly : Nitesh Rane

Mumbai, April 16 (UNI): The government plans to introduce water taxi services across the Mumbai Metropolitan Region (MMR), said state Ports Minister Nitesh Rane.

Talking to media persons on Wednesday, he said a Detailed Project Report (DPR) has already been prepared, with eight to nine routes identified for this innovative transport system.

He further said these vessels will not only help decongest the roads but also reduce pollution in the region.

Existing wooden boats will continue to operate, giving commuters the freedom to choose their preferred mode of water transport, much like road-based aggregator services.

"We have seen the success of the Mumbai Metro. On those lines, we will be starting water taxis in the MMR," he added.

### Six-year-old boy sexually assault near Mumbai railway track

Mumbai, April 16 (UNI): A six-year-old boy was allegedly abducted and sexually assaulted by a 22-yearold man, police said here on Wednesday.

According to police, the victim was abducted and was sexually assaulted in the bushes near BPT railway tracks adjacent to Wadala Railway Station in south Mumbai Central between 1:05 PM and 3:15 PM on April 15, and on the same night an offence was registered under Sections 137(2), 115(2), and 351(3) of BNS along with Sections 4, 6, and 8 of the POCSO Act.

The accused, identified as Gulfraz Jiul Alam (22), who worked as a labourer alongside the victim's father, is a resident of Katihar, in Bihar, and was immediately arrested after the offence was registered, police further said.As per the complaint, the accused forcibly took the minor without the consent of the boy's parents, undressed him, and sexually assaulted him. When the child screamed, the accused slapped him multiple times and threatened to kill him if he told his parents about the assault.

New Delhi, April 16 (UNI): Prime Minister Narendra Modi today spoke with the President of Finland Alexander Stubb, during which they discussed elevating the bilateral ties and also exchanged views on Ukraine.

PM Modi said in a post on X:

"Had a fruitful conversation with President Alexander Stubb. Finland is an important partner country in the EU. We are committed to elevating our ties.

"Exchanged our perspectives on regional and global issues, including the situation in Ukraine."

The Finland President said in a post on X:

"Had a good phone conversation today with Prime Minister of India @narendramodi."We discussed, among other things, bilateral relations, Russia's war of aggression against Ukraine, and the geopolitical shifts and their implications for the multilateral system."In these turbulent times, the friendship between Finland and India is more important than ever."The discussion on Ukraine comes as US Secretary of State Marco Rubio and White House envoy Steve Witkoff are traveling to Europe for talks about ending the Ukraine conflict and laying the groundwork for a nuclear deal with Iran.Rubio and Witkoff are slated to meet with European counterparts in Paris to discuss the Ukraine war, the State Department said in a statement.

# Mob pelts stones at police in Nashik during dargah demolition; Sanjay Raut says deliberate ploy by BJP

Nashik, April 16 (UNI): A mob pelted stones at Nashik police on Wednesday, injuring some policemen, during the demolition of an unauthorised dargah in the city. The police had to use force to bring the situation under control. Shiv Sena (UBT) MP Sanjay Raut strongly criticised the BJP over the demolition.

The Nashik Municipal Corporation (NMC) personnel removed the unauthorised Satpeer Baba Dargah in Kathe Galli area of the city, following an order of the Bombay High Court, the police said. The demolition drive comes as the Shiv Sena (Thackeray group) is holding a day-long Nirdhar camp in Nashik today.

MP Sanjay Raut reacting to the police action, said that "there is an attempt to create obstacles in the holding of the camp. The intention is to scare us. Why did they choose today for the action on the dargah? All these are tactics to distract attention.'

He further said, "An attempt is being made to spoil the atmosphere in the city by driving a bulldozer on the dargah. If you have the courage, come forward and fight. We are ready."Raut raised the issue that a 15-day notice had already been given to the dargah authorities, but why was the action taken on the day of the Shiv Sena (UBT) camp? "The BJP always sets the right time, decides in advance when to create riots," he alleged.

Meanwhile, Tuesday's meeting between Deputy Chief Minister Eknath Shinde and MNS president Raj Thackeray has become a topic of discussion. On this, Raut said, "They must have met to eat Amaras Puri. Let's see if an alliance is formed. Currently, Amit Shah is running three parties."

# New Waqf law against federal structure, INDI should oppose: Mamata

West Bengal Chief Minister Mamata Banerjee on Wednesday urged INDI Alliance constituents to unitedly oppose the Waqf Amendment Act passed by the Centre's BJP-led dispensation, alleging the legislation "undermines" the country's federal structure. "They have snatched away the fundamental rights. This law is anti-federal. Through you, I will appeal to the INDI Alliance, let us be united and let us fight together boldly. This is not an individual matter; it will affect each and everybody. Today, they are targeting one group. Tomorrow, they will target another. They are talking about the Uniform Civil Code after this...," said Banerjee, who is also the Trinamool Congress supremo.The Chief Minister who was speaking at a conference of the Imams, Muazzims and intellectuals at the Netaji Indoor Stadium here, forcibly," Banerjee said.

Kolkata, April 16 (UNI): accused the BJP of "destroying" the basic fabric of India's federal structure."Dr. B. R. Ambedkar drafted this Constitution for the entire nation. The BJP must understand that it belongs to India, not to any one party. You may be forcibly taking away my rights, but this cannot go on forever," she said.

PM Modi had met with the US VP Vance and Usha Vance and their three children, Ewan, Vivek, and Mirabel, during his visit to Washington in February, and had presented gifts to the children.

The US VP "will discuss shared economic and geopolitical priorities with leaders in each country", the VP's office said.

The visit comes amid trade discussions between the US and India, with the two sides trying to stitch up a Bilateral Free Trade Agreement.

# **Study finds** common genetic variants linked to drug-resistant epilepsy

Certain common genetic changes may explain why some people with focal epilepsy become less responsive to seizure medications, finds a new global

Focal epilepsy is a condition where seizures start in one part of the brain. It is the most common type of epilepsy.

Antiseizure medication is usually prescribed for people with the condition. However, for one in three people with epilepsy (around 20 million individuals worldwide), current antiseizure medications are ineffective. This means that people will continue to have seizures despite taking medication -- a condition called "drug resistance."

It is associated with additional significant health risks in epilepsy, including a higher risk of sudden unexpected death in epilepsy, alongside substantially higher healthcare costs.

Researchers at the University College London in the UK and the University of Texas-Health Houston in the US found the reason in some specific common genetic variants in two genes: CNIH3 -- which helps control how certain brain receptors function; and WDR26 -- which is involved in various cell processes.

The study, published in the journal EBioMedicine showed that people with genetic variants in CNIH3 and WDR26 had a higher risk of having drug resistance in focal epilepsy. The variants also determined a person's response to antiseizure medications.

"The findings of our study offer new insights about why some people have seizures that are resistant to existing antiseizure medications," said Professor Sanjay Sisodiya from UCL's Queen Square Institute of Neurology.

"Recognising these genetic variants, which are frequent in the general population yet strongly influence treatment outcomes, underscores the need to expand genetic testing and future therapies to address polygenic epilepsy (a type of epilepsy that is influenced by multiple genes)," added Costin Leu, Assistant Professor at UTHealth Houston).

For the study, the researchers examined data on 6,826 people with epilepsy. They compared the genomes of those who had drug-resistant epilepsy (4,208 individuals) with those whose seizures were successfully controlled with antiseizure medications (2,618 individuals).

The findings are particularly important as these genetic signatures can be determined at the onset of epilepsy, rather than after several antiseizure medications have been tried without success. This could eventually help to predict which individuals with epilepsy are likely to develop drug resistance and avoid unnecessary exposure to ineffective medications and their associated side effects, said the team.

# Why Selective Censorship?

(By Kalpana Pandey) Phule," directed by National Award-winner Ananth Mahadevanrenowned for films such as "The Storyteller," which combine sensitivity, depth, and artistic merit—has become embroiled in controversy even before its release. Originally scheduled to premiere on April 11, 2025, the film was postponed to April 25, 2025, following objections from certain Brahmin organizations Maharashtra accusing it of

promoting casteism. At the heart of "Phule" is the pioneering work of Jyotirao and Savitribai Phule—founders of the first school for girls in India and champions of so-called "backward" castes whose efforts for education and social justice are chronicled against the backdrop of nineteenthcentury India. Pratik Gandhi portrays Jyotirao Phule, while Patralekha plays Savitribai Phule. The film documents their tireless struggle against caste and gender discrimination, including establishment of India's first girls' school in 1848. Ananth Mahadevan's aim is to foreground the Phules' crusade for equality and to bring their fight against caste and gender injustice into the mainstream.

In response to the groups' objections, the Central Board of Film Certification (CBFC) has recommended cuts and modifications: removing or altering castespecific terms such as "Mang," "Mahar," and "Peshwai," and changing the dialogue "three thousand years of slavery" to "many years of slavery." suggestions effectively dilute the harsh historical realities of caste oppression central to the Phules' movement. Such cuts undermine the integrity of the Phules' ideological legacy and do a disservice to the historical struggles of marginalized communities. Various social organizations have criticized the CBFC's decision as hypocritical and

Controversial films with provocative statements—such as "The Kerala Story" and "The Kashmir Files"—were granted CBFC approval without significant cuts, whereas a film about social reformers Jyotirao and Savitribai Phule, whose work directly confronted Brahmanical and casteist values, is being asked to make numerous changes. Given that Jyotirao Phule was born on April 11, it is also significant that the film's intended release date coincided with his birth anniversary, suggesting commercial considerations may be at play. The delay and suggested edits ostensibly to protect boxoffice prospects—reveal that the CBFC does not enforce its guidelines evenly. Films endorsing certain viewpoints face fewer obstacles, while addressing challenging subjects encounter hurdles. This selective approach calls the CBFC's impartiality into question and imposes constraints on artistic freedom and the truthful

The second point is that caste remains an extremely sensitive issue in India, and discrimination based on caste persists even today. Films like "Phule," which confront these questions head-on, have been obstructed in various ways. If one examines the names and backgrounds of the members of the censor board, it becomes clear without needing further explanation—that the CBFC's actions are being taken under political pressure or in the name of maintaining social stability. Imposing stringent rules on a film like "Phule" demonstrates that the CBFC wishes to control films advocating social reform while granting leeway to divisive narratives.

The third significant point is that the denial of timely certification for "Phule" is largely due to complaints from certain Brahmin organizations.



These groups contend that the film—based on the lives of Jyotirao and Savitribai Phule—depicts Brahmin community unfavorably, portraying Brahmins as villains or subjecting them to unfair criticism. In response to these objections, the CBFC has questioned the film's release, taken exception to certain scenes and dialogues, recommended changes, thereby delaying its certification. However, filmmakers assert that the film is historically accurate, includes sympathetic Brahmin characters who support the Phules' work, and has no intention of defaming any community. Nevertheless, the CBFC prioritized the Brahmin organizations' complaints, insisting on altering casterelated terms or episodes while disregarding the filmmakers' claims of historical fidelity. This selective deference casts doubt on the CBFC's impartiality, suggesting that it values the sentiments of one group over artistic integrity and filmmakers' creative vision. Consequently, one must ask whether the CBFC is making independent decisions or acting under external pressure. If the CBFC coerces changes to historical truths or artistic perspectives, filmmakers' original message is weakened and

the audience's right to informed understanding is compromised. It is therefore both natural and necessary to question the CBFC's

procedures and credibility. The fourth issue concerns artistic freedom. Since the Phules' mission fundamentally involved reforming an exploitative social order, significant opposition and social conflict were inevitable. These mandated cuts undermine the film's historical accuracy and do a disservice to the filmmakers' artistic vision and the audience's right to unfettered access to information. This struggle represents a collision between the artistic expression of social trauma grounded in historical fact and the constraints imposed by the current

political establishment. Regardless of whether the film is ultimately approved or blocked, one thing is certain: "Phule" holds up a mirror to our social history by bringing its painful realities to light. It portrays the woman who fought for girls' education, the teacher who shattered caste barriers, the Hindu social order rooted in Brahminical supremacy, the horrors of social ostracism and religious terror indeed, the life and work of Mahatma Jyotirao Phule himself.

Mahatma Phule's work could not have been

contributions of his wife, Savitribai Phule. He educated a young, married girl who had received no formal schooling and empowered her to become India's first woman teacher. She, in turn, stood firm against social exclusion and kept the flame of education burning bright. Together, the Phules tore down the walls of a caste-based educational system, establishing separate for untouchable, Dalit, and Shudra children. In those schools, caste was never asked—a revolutionary act for its time. Through writings such "Gulamgiri," the Phules exposed the realities of the caste system and launched a direct attack on Brahminical rule, declaring, "Until society is educated, it will remain enslaved." Mahatma Phule's social

accomplished without the

movement was a direct challenge to the ruling caste hierarchy, and as a result he faced immense opposition from society. His family severed ties with him, and he was ostracized by his community. The insults and filth hurled at Savitribai did not deter them. They endured religious intimidation as well, and even questioned the nature of gods, religion, and rituals—declaring plainly, "God is not the creator of man; man is the creator of God." For these views they were branded "atheists" and "enemies of religion," yet they never abandoned their convictions.

Mahatma Phule's work extended far beyond education. By founding the Satyashodhak Society, he opened a new path toward social equality. He wrote and acted on a range of issues—widow remarriage, the necessity of girls' education, exploitation in agriculture, and the dominance of the Brahminpriestly class. He never ceased his struggle, establishing Satyashodhak Society with the core aim of securing intra-caste equality and opposing Brahminical supremacy.

Under Satyashodhak banner,

Through a poignant story

funerals—were performed without Brahmin priests. The Society initiated traditions of communal dining and gatherings without regard to caste. People of all castes came together and identified themselves as "Satyashodhaks." For the first time, Dalits, Shudras, and women found a social platform where they truly belonged, and movement brought education into community. Though his health

declined with Mahatma Phule's energy for social work never waned, Satyashodhak movement continued after his death. Leaders such as Shahu Maharaj, Dr. B.R. Ambedkar, and Periyar were later inspired by Satyashodhak ideas. Even today, murders are committed in the name of caste, blind faith grows under the guise of religion, and the rights of women, Dalits, and OBCs are still under assault.

The intellectual battle they began remains profoundly relevant today. Every step toward education, equality, and justice is guided by Mahatma Phule's inspirational legacy.



# Govt to provide Rs 4 lakh ex-gratia to kin of deceased in sunstroke

Hyderabad, April 16 (UNI): Declaring Sunstroke as "state-specific disaster" the Telangana government on Tuesday issued orders to provide Rs 4 lakh ex gratia to the families of deceased persons.

The state government, having taken into consideration all the facts, has decided to declare are vulnerable to heat heatwave/sunstroke as a "State Specific Disaster" henceforth for the purpose of providing relief to the families of the victims..." according to a GO issued by Special Chief Secretary to Government Arvind Kumar. Heatwaves remain a "hidden hazard" whose impacts are underrecognised due to measurement and valuation challenges. There is underreporting of deaths and severe impact of heat waves, especially in the vulnerable sections of the population, including women, children and the old aged, it said.

According to GO, in Telangana, during the year 2024, it was observed in Telangana that except for five districts, all the remaining 28 districts had at least 15 days of heatwave, with Nalgonda, Mancherial, Peddapalli and Jagtial having more than 30 days of heatwave.

People, especially the

construction workers and daily wagers in Hyderabad, Warangal, all the Municipal Corporations, Hyderabad Urban Agglomeration and all the Urban Local Bodies waves and sun strokes, it said. While all the districts have prepared a districtspecific heat wave action plan and have equipped vulnerable points with ORS packets and drinking water kiosks, they are issuing required advisories on dos and don'ts.In the absence of a specific ex gratia, the state until now was providing assistance of Rs.50,000 under the Apathbandhu scheme to the family of the deceased who died due to

heat wave/sunstroke. The District Collector will ensure that the appropriate authority/ authorities shall diagnose the heat-related death based on the history of exposure to high ambient temperature and the reasonable exclusion of other causes of hyperthermia, the GO added.

# Set your house in order or resign: Badal to Mann

### US judge blocks Trump administration from deporting Indian student

Washington/New Delhi, April 16 (UNI): AUS federal judge has barred the Trump administration from deporting an Indian undergraduate student whose student visa was cancelled on April 4, just weeks before he was set to In a ruling on Tuesday

in the Madison court, US District Judge William Conley ruled that Krish Lal Isserdasani, 21, a UW-Madison international student, could not have his student visa terminated and that the Trump administration could not take any legal action against him as a result, including deportation.

The request for a temporary restraining order the Trump administration's deportation move was brought by Madison attorney Shabnam Lotfi after Isserdasani's record was terminated in the government's Student and **Exchange Visitor Program** (SEVIS) database.

In his 12-page order, Judge Conley wrote the Trump administration had wrongly terminated Isserdasani's visa one month before he was set to complete his bachelor's degree in computer engineering and had robbed him of any form of due process to contest the visa cancelation, wiscnews

"Given the amount of Isserdasani's educational expenses and potential losses from having to leave the United States without obtaining his degree, the court concludes that Isserdasani credibly demonstrates that he faces irreparable harm for which

he has no adequate remedy at law in the absence of injunctive relief," Conley wrote.Isserdasani is one of at least 26 international students and recent alumni at UW-Madison, and 40 across all Universities of Wisconsin campuses, whose visas have been abruptly cancelled.

UW-Madison has not been informed of the visa cancelations by the Trump administration; instead, staff have been finding the visa cancelations as they search databases every few hours, every day, to learn which of their students have been impacted.

The Trump administration cancelled the visas of more than 1,000 international students nationally since January.

When entry visas are cancelled, students are subject to deportation and are recommended to leave the US immediately.

Isserdasani's would only be authorised till May 2, forcing him to leave eight days before UW-Madison's spring commencement.

The ruling doesn't say when the visa would have expired naturally but notes that, with it cancelled, Isserdasani could not file for an extension so he can search for work.

In recent weeks, the Trump administration has attempted to force out international students across the country over myriad reasons, such as for participating in pro-Palestinian protests and for traffic infractions.

In his order, Conley wrote that Isserdasani's visa seems to have been canceled over an arrest on a misdemeanor disorderly conduct charge, which he admitted to in court documents.

The incident, which took place on November 22, 2024, occurred when Isserdasani and a group of friends got in an argument with another group of people while walking home from a bar.

While police had referred a charge of disorderly conduct, Dane County District Attorney Ismael Ozanne never brought charges against Isserdasani. He never appeared in court for it and believed the matter wouldn't affect his student visa, Conley wrote.



# **CR Glorious 172 Years of Pioneering Journey**

Mumbai, April 16 :Indian Railways completed 172 glorious years. The first train in Asian subcontinent (and India) which ran between Mumbai and Thane on April 16, 1853 was flagged off from Boribunder (the place where CSMT presently stands). As the years passed, the Great Indian Peninsula Railway which ran the first train merged with the Indian Midland Railway Company in 1900 and extended its frontiers from Delhi in the North, Kanpur and Allahabad in the North-east and Nagpur in the East to Raichur in the South-east.

On 5 November 1951, Central Railway was formed by integrating Nizam State, Scindia State and Dholpur State Railways. Presently Central Railway with its 5 divisions i.e. Mumbai, Bhusaval, Nagpur, Solapur and Pune has a network over 4322.55 route km in the states of Maharashtra, Madhya Pradesh and Karnataka. CR serves these states through 492 stations.

From the first train in April 1853 to the most modern train of India, Vande Bharat Express, Railways have successfully expanded its network in last 172 years. Presently Central Railway runs 10 Vande Bharat Express trains, viz. CSMT-Sainagar Shirdi, CSMT-Solapur, CSMT-Madgaon, CSMT-Jalna, Nagpur-Bilaspur, Nagpur-Indore, Nagpur Secunderabad, Kalaburgi – Benguluru, Pune – Hubli and Pune - Kolhapur Vande

Central Railway is also at the forefront with achievement of many firsts.

Some notable achievements among them are: first Shatabdi Express, first Jan Shatabdi Express, first Tejas Express to name a few. It has definitely come a long way with some of the oldest trains like Punjab Mail still running and popular among its passengers even after 100 years.

Running the first electric train service in India between Bombay VT and Kurla Harbour on 3rd Feb 1925 laid the foundation of Electrification of Railways.

Today, Central Railway has achieved 100% electrification and the suburban network has also steadily increased. Presently Central Railway five suburban corridors. The suburban services which started from 3 coaches have gradually increased to 9 coaches, 12 coaches even services with 15 coaches. AC suburban services have also been introduced to make travel more convenient and comfortable. From today onwards 14 more AC services have been introduced taking the total number of AC Services to 80 on Mumbai suburban. The originating loading

which was 16.58 million tonnes at the time of formation, has now increased to 82.52 million tonnes in the year 2024-25. Apart from this, infrastructure works like construction of new railway lines, doubling, construction of bridges, and 80 stations being upgraded under the Amrit Bharat Station Scheme (ABSS).

The Neral-Matheran Light Railway has also completed its glorious 118 years. The Neral-Matheran railway construction started in 1904 and the two feet gauge line finally opened to traffic in 1907. As a precautionary measure, the line used to be closed during the monsoons, however, shuttle services between Aman Lodge and Matheran were introduced from 29.9.2012, to run even in monsoon. Central Railway has undertaken several infrastructural works on this section to ensure a safe and comfortable ride to its passengers and services on Neral – Matheran NG line.
