ACB officials nab acting headmaster of Kolhapur school for accepting bribe

Kolhapur, April 17 (UNI): Anti Corruption Bureau (ACB) officials today arrested the acting headmaster of Kolhapur Municipal Corporation's (KMC) school no-24, for accepting a bribe of Rs 3,000 for giving a school leaving certificate.

The arrested person, identified as Sanjay Jaysing Narvekar (52), is the acting headmaster of Shelaji Vannaji Vidhyalay, KMC school no 24, Ravivar Peth, in the city.

The ACB in a press release, said the complainant had applied for school leaving certificates of his father and his (father's) five brothers (complainant's uncles).

The acting headmaster Narvekar demanded Rs 3,000 as bribe in exchange.

The complainant informed the ACB officials about this, and they laid a trap at the school this morning and arrested Narvekar red-handed while accepting a bribe amount of Rs 3,000 from the complainant, the release said.

Woman's body found in a suitcase near railway stn

Mumbai, April 17 (UNI): The decomposed body of a woman was found inside a suitcase near the Monkey Hill area on the Mumbai-Pune railway route lying close to railway tracks, official said on Thursday.

The suitcase was first spotted by a passenger on a train travelling from Mumbai to Pune. As the train passed the Monkey Hill point, the commuter noticed the oddly placed suitcase near the tracks and alerted the railway police.

Govt sacks 442 medical officers absent for over a year

Mumbai, April 17 (UNI): The the top court, led by Chief adding "The situation Maharashtra government has issued a directive terminating the services of 442 medical officers who were found absent from duty for a year, officials said on Thursday.

An order issued by the public health department late Wednesday said, "At a time when there is a paucity of doctors at staterun medical centres, primary health centres, rural hospitals, and district hospitals, these 442 doctors were missing at the places of In the interim, the their appointments. Sources said these doctors might have preferred private practice, but their action (Contd on page 2) led to blocking the positions for over a

year, which is unethical. A final proposal for terminating the officers' services was put up before the department on April 4. The order came on April 16, sources said.

Of the 442 sacked medical officers, 84 were attached to the Nagpur regional office, 75 to the Akola office, 26 to the Kolhapur office, 48 to the Thane office, 85 to the Latur office, 28 to the Pune office, 23 to the Chhatrapati Sambhajinagar office and 66 to the Nashik regional office. The highest number of such doctors was from the Nagpur office, which comprises comparatively backward districts of Gondia, Gadchiroli, and Chandrapur. As many as 74 doctors did not report for work in the Akola region, which includes districts with a sizeable tribal population in Yavatmal, Amravati, and Washim.

Won't allow Hindi as mandatory language in State: Raj

Maharashtra Navnirman Sena (MNS) chief Raj Thackeray said on Thursday that he would not allow Hindi as a mandatory language in the state. As per the state school curriculum plan, Hindi has been made mandatory in the state from the first grade. "I say in clear words that the MNS will not tolerate this compulsion. We will not allow the Central government's efforts to spread Hindi everywhere," said Raj. "Hindi is not a national language. It is a state language like other languages in the country. Why should it be taught in Maharashtra from the first grade", questioned the MNS chief.



Not reform but retaliation dressed as regulation, alleges Singhvi

New Delhi, April 17 (UNI): The Congress on Thursday welcomed interim relief given by the Supreme Court on the recently passed WaqfAct, saying the Act was not aimed at improving but "infiltrating" and "controlling" the institutions.

Addressing a press conference at the AICC office here, senior Congress leader Abhishek Manu Singhvi and Imran Pratapgarhi said, "We are extremely grateful to the Supreme Court for having spent considerable time and passed an interim order which will of course be subject to further hearing".

Singhvi slammed the government's claims of reform, saying, "It is retaliation in the guise of the reform. It is retaliation meticulously scripted, strategically timed and constitutionally questionable". The Waqf Amendment Act, the senior Supreme Court lawyer said, is not an exercise in efficiency as it pretends to be."It is an exercise in eraser behind the bland language of governance lies, the bold ambition of control where religious autonomy is being reduced to state administered protocol and community rights are being redrawn with bureaucratic pens," he noted, while remarking, "let us be clear this is not about improving institutions, this is about infiltrating them, controlling them and closing them."Observing that it should not be treated as a particular community specific issue, Singhvi said that the party was not defending just one community.

- No denotification of Waqf properties, including Waqf by user

The situation regarding registered Waqf properties under the 1995 shall remain undisturbed. The matter will now be heard after the responses are received.

The Court reiterated that only five lead petitions will be heard, while all other connected matters have been disposed of.

The next date of hearing is May 5 at 2 pm.

Solicitor General of India Tushar Mehta, appearing for the Union government, urged the court not to pass a "harsh step" and requested a week's time to file a preliminary reply.

Underlining that the government answerable to the people, he said, "Villages and villages are taken as Waqf (land). It is a considered piece of legislation... Lakhs of representations were received."

When asked about controversial provisions overriding judicial decrees, Mehta admitted, "I don't know why those words have come. Ignore that part."

Giving an assurance to the top court, he said, "We will not make any appointments. If any State does, it may be treated as void."

Regarding the Waqf-by-User aspect in the new Act, Mehta said, "If Your Lordships say something about Waqf by user, it will have consequences."

The bench was hearing writ petitions challenging the constitutional validity of the 2025 amendment to the Waqf Act.

The petitioners include: Mohd. Jawed (Congress MP), Asaduddin Owaisi (President, AIMIM), Amanatullah Khan (MLA, Aam Aadmi Party), Association for Protection of Civil Rights (APCR), an NGO, Maulana Arshad Madani, head of Jamiat Ulema-i-Hind, Samastha Kerala, Jamiathul Ulema, a prominent Muslim organisation from Kerala and Anjum Kadari, activist

and legal scholar. Appearing for the petitioners, Senior Advocate Kapil Sibal raised sharp constitutional objections. He argued that the new provisions threaten the "essential and integral part of Islamic faith", particularly those that abolish 'waqf by user', limit claims, and shift adjudicatory powers from courts to executive bodies.

"What is sought through Parliamentary legislation is to interfere with an essential and integral part of faith," Sibal submitted. "If a Waqf was created 3,000 years ago, they will now ask for a

Section 3C, annulling government land declared as Waqf

Section 36, abolishing Waqf-by-user unless registered Section 61, imposing a two-year limitation to raise

Waqf claims Section 7A, which Sibal noted may take "20 years to establish a claim"

He argued, "The phrase 'per law' cannot be used to take away essential religious practices. These are core aspects protected under Articles 25 and 26 of

the Constitution.' The CJI weighed in on the complex implications and said, "We are told Delhi High Court is built on Waqf land. We are not saying all 'Waqf by-User' is wrong, but there is genuine concern.'

In a pointed remark on composition of the Waqf Boards, Justice Khanna remarked: "Say it openly! Why not have non-Muslims in Hindu endowment advisory boards then?'

The law has stirred deep concern in religious, political, and civil rights circles, with critics alleging it effectively nullifies centuries-old Waqf rights, curbs judicial oversight, and vests disproportionate power in executive hands.

In Parliament, during the debate on the new legislation, Union Minority Affairs Minister Kiren Rijiju had argued that the law was aimed at streamlining property management and was not intended to interfere with religious rights.

"The provisions of the Waqf Board have nothing to do with the management of any mosque, temple, or religious site," Rijiju clarified during the floor debate.

Leopard kills girl in Maha's Jalgaon

The leopard attacked Ratnabai while she was sleeping with her mother, Jijabai who heard the crying sound of her daughter when the animal attacked her.

People gathered around the mother and chased the leopard. However, the carnivore ran into the banana field. The child's body was found some distance away.

After receiving the information, forest officer Vipul Patil and other employees rushed to the spot. Yaval police inspector Pradeep Thakur made a panchnama and sent the girl's body to a rural hospital.

Farmers are angry because the leopard has emerged as a major threat in the area. They are demanding the Forest Department to catch the man-eating leopard.

HC cancels transfer of NIA Judge A K Lahoti

Mumbai, Apr 17 (UNI) The Bombay High Court on Thursday cancelled the transfer of special NIA Judge A K Lahoti, who had been conducting daily hearings in the 2008 Malegaon bomb blast trial for past few years and was nearing conclusion of the case.

With most arguments already completed, he was transferred to Nashik in midst of trial. The registrar of the Bombay high court in its order not only cancelled the transfer order but also extended his tenure till August 31.

Following this, Judge Lahoti today directed all the parties in the case to file their written submission before April 19. Earlier, oral arguments were made both by the prosecution and the defence. It is expected the court may deliver its final verdict before August 31.

The transfer order was cancelled after the victim of the said bomb blast had made a representation before the high court, requesting to extend the tenure of the present Presiding Judge, A K Lahoti, till completion of the trial in the interest of justice. Six people were killed and over 100 injured on September 29, 2008, after an explosive device strapped on a motorcycle exploded in sensitive Malegaon town of Nashik district.



Muslims hail Supreme Court stay on implementation of new Waqf Act

Mumbai, April 17 (UNI) Prominent Muslim intellectuals and religious scholars here on Thursday lauded the Supreme Court's stay on implementation of new (Amendment) Act.

Among them are State Congress leader M Arif Naseem Khan, Markazul Ma'arif Education Research Centre (MMERC) director Maulana Burhanuddin Qasmi, All India Ulema Council (AIUC) general secretary Maulana Mahmood Daryabadi and petitioner Mohamed Jameel Merchant.

Khan accused the

Centre of pushing through the 'unconstitutional' Waqf Bill on the strength of its majority, but the SC has taken cognizance of the serious issues raised by the Congress and other organisations, and "now the law should be scrapped, and a new one should be framed".

"The BJP has no concern for the interest of Muslims though it passed the law in the name of welfare for the poor in the community. It is indulging falsehoods misinformation to justify it. When the BJP's Muslim leaders are now sidelined

their destroyed, Prime Minister Narendra Modi and Home Minister Amit Shah have no right to speak on such things," said Khan sternly.

Qasmi said he had predicted a fortnight ago that the SC would grant an interim stay on merits as the new Waqf (Amendment) Act has flouted the fundamental rights of citizens.

"We are happy that by this order, the SC has taken the step to uphold the Constitutional spirit of our forefathers when they had drafted the Constitution and expect the apex court

to take further decisions on the merits of the case," he added.

Daryabadi cautioned that this is just the beginning of the long haul and it would be appropriate to comment when a final verdict is given, "but our struggle will continue till the logical conclusion".

The first petitioner in the Waqf cases from Mumbai, Jameel Merchant, described it as a very positive

development but called upon Muslims to refrain from any premature celebrations, as the route to full justice is still very long.

The 'breakthrough' in the 1.65 km long underground tunnel of Metro Route 7A from Chhatrapati Shivaji Maharaj International Airport (T2) to Andheri East, proposed by the Mumbai Metropolitan Region Development Authority, successfully completed in the presence of Chief Minister Devendra Fadnavis on Thursday.

Minister of Skill, Employment, Entrepreneurship and Innovation Mangal Prabhat Lodha, MLA Parag Alwani, Metropolitan Commissioner of Mumbai Metropolitan Region Development Authority Sanjay Mukherjee and Additional Metropolitan Commissioner Ashwin Mudgal were present.

Chief Minister Fadnavis initially learned about the project from the officials.

The underground tunnel is on the downline of Metro 7A. This tunnel will be between Chhatrapati Maharaj Shivaji International Airport station and Airport Colony station. This metro connection will be an important milestone for the entire metro network in the Mumbai Metropolitan Region. With this metro line, Mira-Bhayander and further Vasai-Virar parts of Mumbai Metropolitan Region will be connected with Chhatrapati Shivaji Maharaj International Airport by metro. Thane and Navi Mumbai International Airport will also be connected by metro. Over 59 per cent of the work of this metro line has been completed. The length of this metro line is 3.4 km, of which 0.94 km is elevated and 2.50 km is underground. There will be two stations on this line -one at Airport Colony on the elevated line and the other at Chhatrapati Shivaji Maharaj International Airport underground. The elevated metro line will be 0.57 km long, the length of the double tunnel is 2.035 km.

The first drive of the downline tunnel began on September 1, 2023. The length of this tunnel is 1.65 km and 1180 rings have been installed for lining. The diameter of the tunnel is 6.35 meters and specially designed precast rings have been used in six areas.

India saved Rs 3.48 lakh crore as **DBT** cut leakages in last 10 years

India's Direct Benefit Transfer (DBT) system has resulted in cumulative savings of Rs 3.48 lakh crore through a reduction in leakages that were taking place earlier, and a 16-fold expansion in beneficiary coverage from 11 crore to 176 crore since its launch by Prime Minister Narendra Modi-led government, according to a report released.

Since the money goes directly into the bank accounts of beneficiaries the leakage as been curbed which has resulted in a halving of subsidy allocations from 16 per cent to 9 per cent of total expenditure.

"The DBT has redefined welfare delivery by enhancing transparency, curbing leakages, and ensuring precise fund distribution," the study states.

This policy document evaluates a decade of data (2009-2024) to assess DBT's impact on budgetary efficiency, subsidy rationalization, and social outcomes.

The newly developed Welfare Efficiency Index (WEI), which quantifies fiscal and social gains, surged from 0.32 in 2014 to 0.91 in 2023, underscoring systemic improvements, the policy document states. According to the document, despite a rise in welfare budgets from Rs 2.1 lakh crore in 2009-10 to Rs 8.5 lakh crore in 2023–24, subsidy allocations declined proportionally, reflecting DBT-driven efficiency.

It points out that food subsidies accounted for 53 per cent of total savings (Rs 1.85 lakh crore), while programs like MGNREGS and PM-KISAN achieved 98 per cent timely wage transfers and Rs 22,106 crore in savings, respectively. Aadhaar-linked authentication eliminated ghost beneficiaries, enabling coverage expansion without proportional fiscal expenditure. The study employs a mixedmethods approach, synthesizing Union Budget data, DBT portal records, and secondary sources. Analytical tools include correlation analysis, Granger causality tests, and the WEI—a composite metric weighting DBT savings of 50 per cent, subsidy reduction of 30 per cent), and beneficiary growth of 20 per cent.

The policy recommendations emanating from the study include expansion of DBT coverage through the transition of remaining subsidy-based schemes to direct benefit transfer.It also recommends the strengthening of digital infrastructure and the prioritisation of rural and semi-urban banking access to bridge inclusion gaps.

Besides, the study has come out in favour of leveraging advanced analytics with the integration of AI-driven fraud detection to further minimize leakages.

It also recommends the need to improve grievance redressal through the establishment of robust mechanisms to address exclusion."Contrary to critiques of reduced welfare spending, DBT has optimized resource utilization, enabling broader beneficiary reach with lower fiscal outlays. By replacing inefficient subsidies with targeted transfers, India has achieved measurable gains in welfare efficiency," the report states. Future efforts must focus on scaling up DBT's reach, harnessing technology, and sustaining inclusive growth to ensure equitable welfare governance, the report concludes.

Taiwan detects 34 aircraft, 6 vessels of Chinese army in 24 hours: Defense Ministry

Beijing, April 17 (UNI): The Taiwanese Defense Ministry said on Thursday that they had detected 34 aircraft and 6 vessels of the Chinese People's Liberation Army (PLA) over the past 24 hours.

"34 PLA aircraft, 6 PLAN vessels and 2 official ships operating around Taiwan were detected up until 6 a.m. today [22:00 GMT on Wednesday]," the ministry said. The ministry noted that 14 out of 34 Chinese aircraft crossed the median line and entered Taiwan's Air Defense Identification Zone. Taiwan has been governed independently of mainland China since 1949. Beijing views the island as its province, while Taiwan, a territory with its own elected government, maintains that it is an autonomous country, although it has stopped short of declaring independence. Beijing opposes any official contacts by foreign states with Taipei and considers Chinese sovereignty over the island indisputable.

EU expects Trump-Meloni meeting to clear US tariffs demands: Reports

Moscow, April 17 (UNI): European Union (EU) trade negotiators hope that Italian Prime Minister Giorgia Meloni's trip to Washington and her meeting with US President Donald Trump can shed light on the US tariffs demands, The Financial Times reported on Thursday. The bloc's negotiators reportedly complained that they had not been provided with US demands and are now hoping that Meloni's trip will bring some clarity, the paper said.

At the same time, Italy's former ambassador to NATO, Stefano Stefanini, believes that Meloni "has an advantage on the EU mediators" as she is talking to "the decider," and is on good terms with Trump.

Unnamed diplomats from four EU states told the paper that Italy's soft stance on reciprocal tariffs is criticized by some member states, but pointed out that Meloni's good relationship with Trump can be valuable. The Italian prime minister publicly supported Brussels' offer to drop all tariffs on industrial goods if Washington does the same, however the diplomats briefed on the talks reportedly said that the US was not interested in reducing the tariffs and that the declared 10% tariff rate is likely to stay.

Meloni and Trump are going to meet in Washington on Thursday. Earlier this week, Politico reported that the Italian prime minister would seek to achieve some concessions from Trump. However, if she fails it might undermine her authority in the EU.

The base tariff rate was established at 10%, with higher rates applied to 57 countries based on the US trade deficit with each specific nation. On April 9, Trump declared that a baseline tariff of 10% would be imposed for 90 days on over 75 countries that had not retaliated and had requested negotiations, except for China. As the trade war progressed, US tariffs on Chinese goods hit 145%, while China's tariffs on American imports reached 125%.

Türkiye conducts anti-drug operation, detaining 525 suspects: minister

Ankara, April 17 (UNI): Turkish authorities on Thursday detained 525 individuals in an anti-narcotics operation in the capital Ankara, marking "the largest drug crackdown" in the nation's history, according to Turkish Interior Minister Ali Yerlikaya.

The operation, which began early Thursday, targeted over 625 locations across the capital. It involved 4,768 police officers, 1,461 teams, 40 specially trained detector dogs, four unmanned aerial vehicles, and air support elements, Yerlikaya said on social media platform X.

The operation was the culmination of six months of technical and physical surveillance, he said, adding, "Our target in the operation was street dealers, who sell drugs in neighborhoods and streets through internet-based communication platforms."The operation came one day after a Europe-wide crackdown, coordinated by Türkiye, on international drug and money laundering networks, which resulted in over 230 arrests and the seizure of 400 million U.S. dollars in assets across several countries, including the Netherlands, Germany, Spain, Belgium, and Türkiye.

Russia removes Afghan Taliban from list of terrorist organisations

Moscow/Kabul, April 17 (UNI): Russia today officially lifted its two-decade old ban on the Afghan Taliban, removing the group from its list of designated terrorist organisations.

The move, confirmed by Russian state media on Thursday, marks a significant shift in Moscow's diplomatic posture toward the de facto rulers of Afghanistan.Russia's Supreme Court on Thursday removed the Taliban's designation as a "terrorist organisation", a symbolic gesture aimed at building friendly ties with Afghanistan's rulers.

The Islamist group seized power in Afghanistan in August 2021, after American forces pulled out.

The Russian Supreme Court's decision to lift the ban, imposed in 2003, takes effect immediately and paves the way for broader engagement between the Kremlin and the Taliban.

Although no country has formally recognised the Taliban-led government since it seized power in

704 climbers permitted to climb Nepal peaks this spring



Kathmandu, April 17 (UNI): Nepal has issued permits to 704 climbers, including 156 females, for ascending 21 mountains in the country during the spring climbing season which runs through May, an official said on

Among them, 253 males and 58 females were allowed to scale Mount Qomolangma, the world's tallest peak at 8,848.86 meters, which straddles Nepal and China.

"We have been receiving applications daily, mainly for Mount Qomolangma," Liladhar Awasthi, director at the Department of Tourism, told Xinhua.Nepal has earned 3.84 million U.S. dollars in revenues by issuing the permits, with 3.38 million dollars from Mount Oomolangma alone.The Nepali government is to raise foreign nationals' climbing fee for Mount Qomolangma from 5,500 dollars to 7,500 dollars from September 1, when the autumn climbing season starts.

Trump says 'big progress' made in trade talks with Japan

(UNI): US President Donald Trump said that "big progress" had been made in trade talks with the Japanese delegation at the White House.

"A Great Honor to have just met with the Japanese Delegation on Trade. Big Progress!" Trump said on Truth Social.

Japan was among the 15 countries with which the US could quickly sign new contracts.

Meanwhile, Japanese Prime Minister Shigeru Ishiba has called the talks "constructive and honest," but expressed doubt that further discussions will be

Trade war with US may cost Germany \$330bln by 2028 : Reports

Washington, April 17 euros between 2025 and (UNI): The trade war initiated by US President Donald Trump could cost Germany 290 billion euros (\$330 billion) by 2028, equivalent to an annual loss of 1.6% of the country's GDP, the Handelsblatt newspaper reported, citing a study by the German Economic Institute (IW).

At the same time, the US tariffs could cost the entire European Union 1.1 trillion

Iran, US to hold second round of indirect talks in **Rome: Official**

Tehran, April 17 (UNI): Rome will be the venue for the second round of negotiations indirect between Tehran and Washington, Iran's Deputy Foreign Minister Kazem Gharibabadi has said.

"Up to this point that we are speaking, we have received no new request from the other side for changing the location of the negotiations and Rome will be the venue for the second round," Gharibabadi said in a live televised interview on Wednesday.

The location of the talks was not a sensitive issue for the Iranian side. "We should concentrate on the main content and job," he

Regardless of the negotiations' venue, Oman will continue to facilitate and mediate them, the official added.

Iranian Foreign Minister Seyed Abbas Araghchi met with US special presidential envoy Steve Witkoff in Oman's capital Muscat on

nuclear program, with both sides describing the meeting as "constructive".

The talks in Muscat followed US President Donald Trump's statement in early March that he had sent a letter to Iranian leaders, delivered through the United Arab Emirates, proposing negotiations on Iran's nuclear programme. Iran later agreed on indirect

Iran signed a nuclear deal in July 2015 with six major countries -- Britain, China, France, Germany, Russia and the United States. Under the deal, Tehran agreed to limit its nuclear activities in exchange for sanctions relief. However, Trump unilaterally pulled his country out of the deal in May 2018 during his first term and reimposed sanctions on Iran, prompting Tehran to scale back its commitments under the deal. Since then, efforts to revive the nuclear agreement have Saturday over Tehran's made little progress.

NKorean defense ministry threatens to raise 'level of danger' for US over provocations

Pyongyang, April 17 (UNI): North Korea will respond to Washington's provocative deployment of strategic bombers over the Korean Peninsula by raising the "level of danger" to the United States, the state-run Korean Central News Agency (KCNA) reported on Thursday, citing the North Korean Defense Ministry.

On Tuesday, the Yonhap news agency reported, citing the South Korean Defense Ministry, that Washington and Seoul conducted a joint air force exercise over the Korean Peninsula, involving a US B-1B strategic bomber and F-35A and F-16 fighter jets from both countries.

A statement of the defense ministry's spokesperson, titled "The US reckless bluffing military demonstration is a futile act of increasing the security threat to its mainland only," criticized the participation of a US B-1B strategic bomber in the recent drill, calling it a blatant threat to Pyongyang's security and "a grave provocation that raises the military tension in the region to an extreme dangerous level.""The DPRK [North Korea] will exercise the overwhelming deterrence and continue to make the US recognize that its unannounced deployment of strategic means is a reckless and unnecessary abuse of strength, and get the US realize by itself that the higher the level of provocation against the DPRK is, the greater the level of danger returning to the US will be," the statement was quoted by the KCNA.

Similar exercises are conducted on a regular basis, which indicates that the US is practicing "tactics and procedures for attacking" North Korea, as well as "completing preparations for going into real action at any time," the spokesperson said, warning that such actions would have serious negative consequences for the US security as well.

Afghan police destroy 3 drug labs, discover over 1,100 kg illicit drugs

Kabul, April 17 (UNI): Afghan security forces have smashed three clandestine processing labs and discovered over 1,100 kg of illicit drugs in western Afghanistan's province, the office of the Deputy Minister of Interior for Counter-Narcotics said in a statement on Thursday.

Units of counter-

narcotic police launched separate operations on the outskirts of Ahmadkhail district of Ghor province, destroying the three drug processing labs and discovering 1,119 kg of illicit drugs, the statement asserted. The statement added that the drugs were used in manufacturing heroin.Security personnel have arrested three people on charges of smuggling 20 kg of illegal drugs of the opium type in northern Badakhshan province, the ministry said in a separate statement. The Afghan interim government has stepped up its crackdown on illicit drugs and those involved in the business, vowing to fight the menace until the country is free from poppy cultivation and substances used in the manufacturing of heroin.

Iranian FM says to discuss **US-Iranian** talks with Russian side

Tehran, April 17 (UNI): Iranian Foreign Minister Abbas Araghchi said on Thursday that he plans to discuss the US-Iranian talks on Tehran's nuclear program with the Russian side during his visit to Moscow."This visit has several purposes ... First, the trip was planned to deliver a written message from the Supreme Leader of Iran [Ali Khamenei] to Russian President [Vladimir Putin]. At the same time ... we will discuss the indirect talks that have taken place between Iran and the United States,' Araghchi's office quoted him as saying.

Khamenei's message to Putin concerns developments in the world and the Middle East, the minister said earlier.

California leads US states in challenging Trump administration's social security cuts

Sacramento, US, April 17 (UNI): California, along with a coalition of 21 other US states, is challenging the federal government's sweeping changes to the Security Social Administration (SSA), arguing that the cuts harm millions of Americans who rely on the programme for basic income and essential

California Attorney General Rob Bonta, along with 21 other state attorneys general, filed a legal brief in the case 'American Association of People with Disabilities v. Dudek', arguing that the Trump administration's

abrupt policy changes and staffing cuts at the SSA are causing serious disruptions and delays for people trying to access their benefits.

The coalition highlighted that these changes are especially harmful to older adults and people with disabilities. who depend on Social Security to pay rent, buy food, and afford medicine.

The administration of President Donald Trump has mandated a reduction of SSA staff from approximately 57,000 to 50,000 employees, a cut of more than 12 percent. Many of these reductions are

expected through buyouts and early retirements, though layoffs are also anticipated. Additionally, the administration plans to close six of 10 regional offices and consolidate dozens of field offices, shifting more services online or to automated phone systems. Critics argue these moves will make it more difficult for people to get the assistance they need.

"These actions threaten the roughly 6.3 million Californians who receive critical Social Security benefits, more than any other state in the nation," said Senator Alex Padilla

from California in a letter to the administration.

"Slashing staff and eliminating field offices will put Americans at risk of missing their earned benefits when they need them most, and prevent them from getting answers when they have questions about those benefits," Padilla said.

Internal documents and reports from employee unions, as cited by The New York Times on April 9, suggest that these changes are already causing longer wait times, crowded offices and confusion for people who need help with their benefits.

Over 5,500 Afghan refugees return from Pak, Iran in single day

Kabul, April 17 (UNI): A total of 1,072 Afghan families comprising 5,671 people returned to their homeland from neighbouring Iran and Pakistan on Wednesday, Afghanistan's High Commission for Addressing Returnees Problems said in a statement Thursday.

According to the statement, the refugees returned home via the Torkham border crossing in eastern Nangarhar province, the Spin Boldak border crossing in southern Kandahar province, and the Islam Qala border point in

western Herat province. Reportedly, about seven million Afghan refugees, most of whom are undocumented migrants, are currently living abroad, with most living in Afghanistan's neighbouring Pakistan and Iran.

The Afghan interim government has been repeatedly calling upon Afghan refugees to end living abroad as refugees and return home to contribute to the rebuilding of their war-torn homeland.

companies already operating in China.

China's e-commerce industry has been booming, with companies like Alibaba Group Holding Ltd and JD.com Inc benefitting from a rising middle class with more disposable income.

Other players include US online retailer Amazon.com Inc, Vipshop Holdings Ltd and US supermarket chain Wal Mart Stores Inc, through its stake in shopping site Yihaodian.

Allowing full foreign ownership "supports our country's e-commerce development, encourages and brings in the active participation of foreign investment, and further excites market competition," the ministry said.



So does the boss man purposely throw roadblocks in front of you to prevent you from successfully completing a project? Now, this is a major act of bullying.

How to deal?

Once you've come to the realisation that you're a victim of bullying -at work, or life-it's important to know what kind of re course you have. Here are possible actions that you could take.

- Speak to a trusted authority in the organisation: A good start may be human resources. They should be able to help you under stand, if you're actually being bullied. If it's determined that a bullying situation exists, they can also provide guidance on how to deal with it. Alternatively, you may feel more comfortable speaking with a higher authority senior colleague.
- Know your rights: If you feel that you're not being heard within your company, you might seek external counsel.
- Find another job: This should be a last resort. But sometimes it's not worth the fight -emotion ally and financially. Respect your self. Look for new employment with a company possessing a strong culture of integrity. Such companies have zero tolerance policies.

No cuts to Afghanistan Cricket **Board funding planned by ICC**



Kabul, April 17 (UNI): The Afghanistan Cricket Board will not see any of its funding from the International Cricket Council cut or diverted to exiled women's cricketers. An initiative to support the displaced Afghan players was announced by the ICC following its board meeting in Zimbabwe last weekend.

However, as reported by ESPN Cricinfo, cricket's global governing body will not reduce or siphon off money earmarked for the ACB, even though part of the criteria for full membership of the ICC is to support women's cricket, the BBC reported. The ICC will support the Afghan women through a separate funding mechanism, while the ACB will continue to receive a payment believed to be in the region of £13m per year. All of that funding

will go towards men's cricket in Afghanistan, with women's sport outlawed in the country since the Taliban returned to power in 2021. The ACB is the only full ICC member not to field a women's team.

Instead, Afghanistan's women's cricketers will be funded by the ICC in conjunction with the England and Wales Cricket Board (ECB), Cricket Australia and the Board of

(BCCI).An Afghanistan Women's XI played an exhibition match in Melbourne in January and want to be recognised as a refugee team.

But the ICC is understood to have acknowledged that the prospect of Afghanistan's women playing official international matches in the near future is a distant one as it would need to be sanctioned by the ACB.

Afghanistan's women have been promised a robust high-performance programme offering "advanced coaching, world-class facilities and tailored mentorship" which the ICC hopes will "help them reach their full potential". Afghanistan's men's team have retained their Test status, reached the semi-finals of last year's T20 World Cup and participated in the Champions Trophy earlier this year.

MI survive late wobble to seal win over SRH

Mumbai, April 17 (UNI): Mumbai Indians overcame late drama to notch their third win of IPL 2025, defeating Sunrisers Hyderabad by four wickets in a pulsating Match 33 at the Wankhede Stadium here on Thursday.

Chasing a target of 163, the hosts reached 166/6 in 18.1 overs, thanks to blistering cameos and a reverseswept boundary from Tilak Varma to finish the job.

Having opted to bowl first, MI found themselves on the back foot early as SRH raced to 59 for no loss. Abhishek Sharma set the tone with a fluent 40 off 28 balls before Hardik Pandya broke the stand. From there, SRH's momentum stuttered despite Travis Head's gritty 28 and Nitish Reddy's brief resistance. SRH were struggling at 113/4 until Heinrich Klaasen hammered 22 off one Deepak Chahar over, lifting them past 140. But it was the 26 runs off the final nine deliveries including two sixes from Aniket Verma and one from skipper Pat Cummins – that gave SRH a competitive 162/ 5. Jasprit Bumrah (1/21) and Jacks (2/14) were the standouts

In reply, Mumbai's start was typically aggressive. Ryan Rickelton (31 off 23) set the early pace with four boundaries off Eshan Malinga in the sixth over, but fell soon after to Harshal Patel. Rohit Sharma looked in sublime touch, smoking three sixes – including a signature pull off Mohammad Shami – before falling to a mistimed drive straight to Head at cover.

Jacks (36 off 26) and Suryakumar Yadav (26 off 15) kept the innings on course with an exhibition of fearless strokeplay. SKY delighted the spectators with two sixes, including a slog sweep and a scoop, but perished attempting to finish the game early. Jacks too fell to Pat Cummins in a bid to accelerate.

The late chase took a dramatic turn when Hardik Pandya (21 off 9), after clubbing two fours and a six, holed out at deep midwicket off Malinga in the 18th over.

Naman Dhir followed two balls later in bizarre fashion - adjudged LBW, he reviewed the decision but was already walking back before the third umpire confirmed three reds, leaving spectators confused and booing. Yogi slams opposition over 'silence' on Murshidabad

Lucknow, April 17 (UNI): Uttar Pradesh Chief Minister Yogi Adityanath on Thursday severely criticised opposition parties over their "silence" on recent incidents in Murshidabad in West Bengal following violent protests against the Waqf Act and other communal incidents in Bangladesh.

While speaking at an event titled 'Uttar Pradesh: Towards a Glorious Century' at Indira Gandhi Pratishthan here, the CM said that the Opposition's "lack of response" has completely exposed their double standards.

He hit out at opposition for issues such as corruption, casteism and mafia rule during previous regimes. "The people who were

involved in scams and built hotels in London using public money are the ones who looted the state and divided people along caste lines," he

"Those who built their political empires on corruption, casteism, mafia power and dynastic politics are now silent on incidents like Murshidabad," said the Chief Minister.

Highlighting the progress made under his leadership in UP, he said infrastructure development and the elimination of mafia rule were the thrust areas of the BJP rule. The state is much safer and more peaceful, he added.

The CM alluded to the years when he alleged mafias

controlled districts. "They took government contracts, caused riots and harassed women and businessmen. People were scared during festivals. Today, festivals in UP are celebrated peacefully and with grandeur," Yogi said.

Speaking about healthcare, Yogi pointed out his government's successful fight against encephalitis in eastern

"Over the past 40 years, the disease claimed the lives of nearly 50,000 children, mostly from minority communities, but no leader ever showed concern," he said.

"The opposition never cared about encephalitis because

children are not vote banks." The CM noted the

shift from 'one district, one mafia' to 'one district, one medical college', highlighting the state's improved health services. He mentioned the

Purvanchal Expressway project as an example of efficient governance. He said that the project was launched in 2016 without proper planning and was full of irregularities, but his government cancelled and redesigned it, completing the project for Rs 11,800 crore instead of the earlier Rs 15,200 crore.

Highlighting UP's rapid development, he said the state now has some of the best

infrastructure in the country, including highways, expressways, railways and metro systems. He said that the state's Gross State Domestic Product (GSDP) has grown from Rs 12.75 lakh crore in 2017 to nearly Rs 30 lakh crore today.

Yogi said, "The per capita income has more than doubled from Rs 46,000 to over Rs 1.10 lakh and is expected to cross Rs 1.25 lakh soon.

The state has successfully brought in investments worth Rs 15 lakh crore. Through the 'Nivesh
