

## Extend support to MSMEs: CM to bankers

Vijayawada, April 29 : Chief Minister Mr Chandrababu Naidu here on Tuesday made it clear that the State Government is taking up projects on a massive scale with the sole aim of the overall development of the State in the coming four years, creating wealth and eliminating poverty.

Continuing to work in line with Swarnandhra-2047 vision on the one hand and on the other focus will also be laid on completing the projects by 2049 and achieving other goals, the Chief Minister told the 231st State-Level Bankers Committee (SLBC) meeting held at the State Secretariat at Amaravati near here.

Though the total credit plan for the 2024-25 financial year is set at Rs 5,40,000 crore it has been crossed and loans sanctioned to the tune of Rs 6,83,672 crore. This is 127 per cent growth in the target. The priority sector



has been sanctioned Rs 4,14,824 crore and for non-priority sector Rs 2,68,848 crore. In the farming sector, the credit plan for the previous fiscal was set at Rs 2,64,000 crore and the banks have exceeded this and extended Rs 3,07,089 crore.

Chairing the SLBC meeting, Mr Chandrababu Naidu sought the full cooperation of the bankers to reach this goal and make efforts to surpass the credit plan targets set for 2025-26.

The Chief Minister who discussed with the bankers

the results achieved during the 2024-25 fiscal set the target for 2025-26 financial year. Congratulating the bankers on exceeding the 100 per cent target to be on top in South India, the Chief Minister unveiled the 'AP Annual Credit Plan' for 2025-2026 financial year. Mr Chandrababu asked the bankers to contemplate what best can be done for the progress of Dwcra women, tenant farmers, SC, ST, BC and Minorities.

Since Andhra Pradesh is an agri-based State and

majority of the people depend on farming for their livelihood, the State Government stood by the farming sector, the Chief Minister said. He also stated that steps are being taken to strengthen the agriculture-allied sectors.

Micro, Small and Medium Enterprises (MSMEs) are being set up in every Assembly segment with the sole aim of reaching the target of 'one entrepreneur for every family', he said and stated that Ratan Tata Innovation

Hub too is going to be established. He told the bankers that stringent efforts are being made to implement 'zero poverty P-4' to remove economic imbalances by eliminating poverty by 2029. For wealth creation and for infrastructure development, the PPP system is being widely implemented in the State, the Chief Minister observed. He also wanted the bankers to focus on petro-corridor and that fishermen should be sanctioned loans directly as

they are suffering heavily due to the involvement of middlemen. Observing that there are huge opportunities in the maritime economy, Mr Chandrababu felt that if they are utilised properly, miracles can be achieved and that this needs bankers' support. The bankers informed the Chief Minister that the credit plan is being implemented in line with his goal to have one entrepreneur for every family and expressed confidence that they will certainly reach the target during this fiscal. They also told the Chief Minister that women entrepreneurs are being given top priority and that huge amounts of loans are being sanctioned for self-help groups. Similarly, special focus is being laid on education and housing loans, they added. The Minister for Finance, Mr Payyavula Kesav, asked as to why the growth rate is coming down every year in credit plan implementation.

## Rahul Gandhi inaugurates solar power plant, attends 'Disha' meeting

Rae Bareli (UP), April 29 (UNI) : Leader of Opposition in Lok Sabha and MP from Rae Bareli Rahul Gandhi on Tuesday inaugurated a two mw solar roof power plant at Visakha Factory in Kundanganj.

He also unveiled the statue of leader Subhash Chandra Bose at Civil Lines.

The administration had made tight security arrangements for Rahul. The police administration was keeping a proper watch on his convoy. He talked about 'inclusive development' and appealed to take everyone along.

After that he left for the Disha meeting at Bachat Bhawan at Collectorate. Amethi MP Kishori Lal Sharma was also present with him as well as Minister of State in Uttar Pradesh government Dinesh Pratap Singh were also present.

During the meeting, various schemes including Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGA), Pradhan Mantri Awas Yojana (Rural), National Rural Livelihood Mission, PM Awas Yojana, Gram Sadak Yojana, National Social Assistance Programme, Swachh Bharat Mission, National Rural Drinking Water Program, Krishi Sinchai Yojana, Mid Day Meal Scheme, Integrated Child Development Programme were discussed and reviewed. Sources said during the meeting Rahul called on women helpline number 181, which was received immediately and

the MP expressed satisfaction when he spoke to the working personnel.

At the end of the meeting, Minister of State (Independent Charge) Uttar Pradesh Dinesh Pratap Singh proposed to observe two minutes of silence to express condolences to the victims of the tragic incident that took place in Pahalgam, Jammu and Kashmir.

Coming out of the meeting of Disha, Dinesh Pratap Singh attacked Rahul Gandhi and said that he comes to Rae Bareli for a picnic. He said that the meeting of 'Disha' is a continuous process which is organised for the supervision and monitoring of the schemes funded by the central government.

He accused Rahul Gandhi that he comes to these meetings to remain in the news. But he is not available to the general public. He does not even answer the questions of the journalists.

After the meeting, Rahul went to inspect the Rail Coach Factory located in Lalganj and meeting with Congress workers is also a part of his tour.

It may be noted that this is a two-day tour of the Leader of Opposition, during which he will stay at Bhuye Mau Guest House in Rae Bareli and then leave for his former parliamentary constituency Amethi and then back to Delhi on Wednesday.

## 'Those who love Pakistan can go to that country': Dy CM

Vijayawada, April 29 : Deputy Chief Minister and Jana Sena Party President K Pawan Kalyan asked those 'who love Pakistan to go that country' and called upon Indians to be united irrespective of religion to oppose terrorism.

The Jana Sena party organised a meeting here on Tuesday to mourn the death of two persons, Somiseti Madhusudhan Rao and JS Chandramouli from AP, who were killed by the terrorists at Pahalgam in Kashmir.

Pawan Kalyan announced and ex-gratia of Rs 50 lakh each to the two bereaved families on behalf of Jana Sena party and assured of extending all help.

He also promised to speak to Chief Minister N

Chandrababu Naidu to extend financial assistance from the government.

Addressing the meeting, the Deputy CM vehemently condemned the brutal killings of innocent tourists in Pahalgam in Kashmir. "Those who love Pakistan, why are you here, you can go there. Secular does not mean appeasement," he rued.

He pointed out that 'the law and order situation had started deteriorating after elections were held and the government was formed in Kashmir.

As long as Kashmir was under the President's rule, the situation there was calm and peaceful,' he claimed.

Pawan Kalyan recalled that Madhusudhan Rao's wife told him that for the first three days, she wore

modern dress but on the fateful day, she sported bindi which helped the terrorists identify them as Hindus. After confirming that they were Hindus, they killed Madhusudhan, he lamented.

"When you are targeted based on your religion, you must expose it as it is not a hatred of anybody," the Deputy CM asserted.

Pawan Kalyan opined that too much lenience and patience are also not good to any nation. He noted that the Muslim population in India is equal to the Pakistan population but India has never shown any partiality, he acknowledged. The Deputy Chief Minister also decried the recent attacks on Hindus and the destruction of Hindu temples in Bangladesh.

## Three masons fall to death from 5th floor

Tirupati, April 29 : Three masons died when they fell off the fifth floor of an under-construction building at TUDA quarters at Mangalam area here on Tuesday.

Police said the deceased were doing plastering work on the fifth floor of the under-construction building. The platform on which they stood was made of bamboo sticks which collapsed and the three masons fell down, resulting in their death.

The three masons were identified as Botathotti Srinivasulu (40), Vasanth (41) and K Srinivasulu (35).

Police have registered a case and shifted the bodies to the HIG for postmortem. Meanwhile, municipal corporation officials said the building owners are constructing the fourth and fifth floors without permission.

New Delhi, April 29 (UNI) : Prime Minister Narendra Modi on Tuesday held detailed discussions in a high level meeting with the Defence Minister, National Security Advisor (NSA), Chief of Defence Staff (CDS) and the Chiefs of the three services.

According to sources, Defence Minister Rajnath Singh, National Security Advisor Ajit Doval, Chief of Defence Staff General Anil Chauhan, Army Chief General Upendra Dwivedi, Air Force Chief Air Chief Marshal A P Singh and Navy Chief Admiral Dinesh Tripathi attended the meeting held at the Prime Minister's residence at 7, Lok Kalyan Marg this evening. This is the third meeting of the

Prime Minister with the Defence Minister, since the dastardly terror attack on tourists in Jammu and Kashmir's Pahalgam on April 22, that claimed 26 lives.

In the meeting, the Prime Minister was given detailed information about the current security situation and the preparations of the forces.

This high-level meeting, held ahead of the Union Cabinet's security meeting on Wednesday, is being considered as highly significant.

Earlier, Union Home Secretary also held discussions in a high-level meeting with the Border Security Force, Assam Rifles and other security agencies.



## Over 50 Pakistani nationals staying in Kashmir deported

Srinagar, Apr 29 (UNI) More than 50 Pakistani nationals who were staying in Kashmir were deported on Tuesday, officials said.

The deportation took place in compliance with an order by the Union Home Ministry that directed all Pakistani nationals to leave the country.

Those deported included women from Pakistan and Pakistan occupied Kashmir who married to former Kashmiri militants who returned over a decade ago under a government rehabilitation scheme.

Those deported included men and women from several districts of the valley.

National Conference legislator from Uri, Sajad

Shafi, on Tuesday appealed to Union Home Minister Amit Shah to reconsider the recent directive on the deportation of Pakistani nationals residing in India, citing humanitarian concerns.

"In Jammu and Kashmir, many women who came from Pakistan have been living here for decades. Their families, including children, are settled here, and some of these women have no one left in Pakistan. Where will they go now?" Shafi said.

He added that in his constituency of Uri, several such women have been asked to leave without delay, despite having legally resided in India for years.

Shafi urged the Home

Minister to revisit the policy on compassionate grounds, saying, "Those who are here legally and have built their lives over decades should not be uprooted or separated from their families."

Meanwhile, J&K Police has denied reports circulating on social media regarding the alleged repatriation of the mother of late Constable Mudasir Ahmad

"The reports are false, baseless, and categorically denied," a police statement said. Mudasir, who died while fighting militants in 2022, was awarded Shaurya Chakra posthumously in 2023. Home Minister Amit Shah personally visited their home in Uri, weeks after his death.

A meeting was organized under the chairmanship of Deputy

Chief Minister Ajit Pawar in the Deputy Chief Minister's Committee Room in the Ministry to review various issues related to the State Waqf Board. In this meeting, Medical Education Minister Hassan Mushrif, Minority Development and Auqaf Minister Dattatray Bharane, Additional Chief Secretary of Planning Department Dr. Rajagopal Deora, Principal Secretary, Finance Department, Saurabh Vijay, Secretary, Minority Development and Auqaf Department, Ruchesh Jayavanshi, Secretary, Medical Education Department,

Dheeraj Kumar, District Collector, Beed, Vivek Johnson (via video conferencing), Chairman of the Waqf Board, Chhatrapati Sambhajanagar, Sameer Kazi, Chief Executive Officer, Junaid Syed and other senior officers of the department were present.

The government is committed to ensuring that the Muslim brothers in the state get quality education, health care and other necessary facilities. Through the Maulana Azad Economic Development Corporation, schemes will be effectively implemented keeping in mind the needs

## 21-yr-old Indian student, daughter of AAP leader, found dead in Ottawa

Ottawa/New Delhi, April 29 (UNI) : A 21-year-old Indian student in Ottawa, Canada, the daughter of an AAP leader from Punjab, has been found dead.

Vanshika Saini, the daughter of AAP leader Davinder Saini, was from Dera Bassi in Punjab. She had gone missing since April 25. Her body was found on the beach near her college.

The Indian High Commission in Ottawa said on X that the matter is under investigation.

"We are deeply saddened to be informed of the death of Ms. Vanshika, student from India in

Ottawa.

"The matter has been taken up with concerned authorities and the cause is under investigation as per local police.

"We are in close contact with the bereaved kin and local community associations to provide all possible assistance.

"A massive search effort had been underway since the student, Vanshika, went missing on April 25."

Earlier, the HCI posted about her going missing.

"HCI Ottawa is in touch with local partner Indo Canadian community associations and concerned authorities

regarding a missing person alert for an Indian student in Ottawa. If any one has any information, please provide the same to the contacts as given below", it said with links to its facebook page.

Surjeet Singh Aujla, Congress Lok Sabha MP from Amritsar, condoled the death on X:

"Deeply saddened by the tragic and mysterious death of Vanshika Saini a bright student from Derabassi, Punjab, found dead in Ottawa. My thoughts are with her family, especially her father Mr Devinder Singh ji of @AamAadmiParty.

"Urging @HCI\_Ottawa & Canadian authorities for a thorough, transparent investigation."

Vanshika had been studying in Ottawa for the past two and a half years.

A grieving Davinder Saini, an aide to AAP MLA Kuljit Singh Randhawa, told the media:

"My daughter Vanshika went to Ottawa in 2023... She wanted to win big in life... The last I talked to her was on 25 April when she was on her way to work... On the morning of 26 April, I received a message that she has gone missing... She was preparing for her IELTS exam."

## SP leaders' take on terror attack 'shameful', akin to Pak rhetoric: CM

Deoria (UP), April 29 (UNI) : Uttar Pradesh Chief Minister Yogi Adityanath on Tuesday condemned recent remarks by Samajwadi Party (SP) leaders on the Pahalgam terrorist attack, terming them 'shameful' and akin to Pakistani rhetoric.

Addressing a public meeting at Deoria during inauguration of 341 out of 501 development projects worth Rs 676 crore and laying of foundation stone for 160 others, the CM criticised SP leaders for dismissing the killing of Shubham Dwivedi and for divisive statements like labelling it a 'Hindu killing Hindu' incident. He accused SP and Congress of using caste-based politics and appeasement, warning that such tactics jeopardize national security.

He claimed that some leaders of SP and Congress are acting as spokespersons of terrorists in the Pahalgam terror attack. Yogi reflected on the region's grim state before 2017, marked by lawlessness, disease and neglect. He highlighted how peaceful festival celebrations were impossible, youth had to migrate for work and farmers faced extreme distress.

"Marginalised communities like Musahar and Vantangiya endured starvation, while those in power remained indifferent and isolated," he recalled.

On the occasion, he also distributed benefits under various government schemes. These included loan cheques under the Mukhyamantri Yuva Udyami Yojana, Rs 7.87 crore to members of self-help groups, keys to homes under the CM Rural Housing Scheme, tractors, and land lease papers to 37 beneficiaries under the Patta Yojana. He also handed out cheques for Divyang and destitute pensions. Highlighting the progress made under his government, the CM recalled that before 2017, thousands of children in Deoria died of encephalitis every year.

"Today, that reality has changed. Deoria, like the rest of UP, is progressing rapidly under the leadership of Prime

Minister Narendra Modi," he claimed.

He announced the inauguration of a four-storey government degree college at Deoria, the first of its kind in the region, offering simultaneous Arts, Science and Commerce classes.

"A new degree college will also open at Pathardeva with Commerce courses, while a new auditorium will be constructed at Gauri Bazar to support academic activities," he said.

Yogi said, "Earlier, no one imagined that self-help groups could thrive in rural areas, today, they are a reality. Deoria, once known for riots and disease, is now recognised for highways, railways and world-class expressways. This is the new face of UP," he said.

He said that a four-lane highway is being constructed from Deoria to Gorakhpur, ensuring seamless connectivity to Delhi and other major cities.

"In addition, the Gorakhpur-Ballia route is also being upgraded to four lanes, while roads connecting Deoria to Kasia and Padrauna are being widened to improve regional connectivity. These infrastructure projects will significantly reduce travel time from Deoria to Delhi and Shamli and are progressing swiftly toward completion," he said. The CM said that Deoria is not only witnessing the establishment of medical and nursing colleges but also is seeing rapid expansion in welfare initiatives aimed at the underprivileged.

"Marginalised communities like the Musahar and Vantangiya are being actively linked to various government schemes to ensure their upliftment," he added.

Taking a strong stand against the SP, he criticised its leadership for focusing solely on their own families and engaging in caste-based politics.

"When they were in power, they gave the state nothing but poverty, unemployment and insecurity," he alleged.

## Mangaluru woman doctor booked for allegedly posting anti-national comments

Mangaluru, April 29 (UNI) : A case has been registered against a woman doctor for allegedly posting anti-Hindu and anti-national comments on social media, City Police Commissioner Anupam Agarwal said here on Tuesday. Addressing

reporters, Agarwal said the woman, identified as Dr Ateefa, is employed at Highland Hospital in the city. "Two days ago, a social media post by her went viral in Mangaluru. The content of the post contained remarks that were either anti-Hindu or

anti-national in nature," he stated.

"Following a complaint, we contacted the hospital administration and registered a case against the woman under various sections of the Bharatiya Nyaya Sanhita (BNS)," the Commissioner said. He

further said the doctor has been called in for investigation and that the mobile phone used for posting the comments has been seized. "A forensic examination of the device is underway. Further investigation is in progress," he added.

## Cong acting like Lashkar-e-Pak: BJP's Gaurav Bhatia

New Delhi, April 29 (UNI) : "Sar tan se juda has been the ideology of the Congress," BJP spokesperson Gaurav Bhatia alleged on Tuesday, launching a sharp attack on the opposition party over a controversial social media post that depicted Prime Minister Narendra Modi without a head.

Terming the post "extremely sad and worrisome", Bhatia said, "Even though Congress is an Indian political

party, it constantly reveals its two faces and transforms into Lashkar-e-Pakistan Congress."

The post, captioned "Gayab" (missing), was widely circulated on social media, drawing strong reactions from BJP leaders and supporters. Bhatia said the image surfaced at a time when Prime Minister Modi had given a strong message to Pakistan, and alleged that the Congress tweet sought to undermine the country's position globally.

## Father shoots MBBS daughter, injures son-in-law for marrying class XII pass

Mumbai, April 29 (UNI) : The investigation into the murder of a 24-year-old woman allegedly by her father in Jalgaon revealed that as his MBBS daughter had married a class XII pass-out, the accused took the extreme step of killing his daughter and injuring his son-in-law, police said on Tuesday. On April 27, a retired sub-inspector of

police from Central Reserve Police (CRP) allegedly shot at his daughter and son-in-law at Chopda in Jalgaon district of Maharashtra.


In this incident that occurred at 10 pm on Saturday during a family function, the daughter died on the spot, while the son-in-law was seriously injured and is currently undergoing treatment at a

nearby hospital. The accused father, who opened fire during the function, is in serious condition and on a ventilator after being beaten up by attendees.

According to information received, Kiran Mangle, a retired PSI shot his daughter Trupti and her husband Avinash Wagh during the 'haldi' (pre-

wedding) function of one of his relatives which was attended by his daughter, son-in-law and other relatives. Trupti Avinash Wagh (24) and Avinash Ishwar Wagh (28) from Kothrud, Pune, had a love marriage two years ago. The girl's father, Karan Arjan Mangle (48) from Shipur, did not approve of the marriage and was angry about it.

What PM Modi's free hand to armed forces against terror means for cross-border action?

Prime Minister Narendra Modi’s unambiguous message during a high-level security meeting - ‘India is determined to deliver a crushing blow to terrorism’ - marks more than just a strong statement of resolve.

The Prime Minister’s message portrays a strategic phase where decisive military options are firmly on the table. The option that also includes cross-border strikes, in response to the Pahalgam terror massacre that killed 26 people, most of them tourists.

PM Modi’s assurance of “full operational freedom” to the Indian Armed Forces to choose the “mode, targets, and timing” of India’s response is of deep strategic significance. It indicates a positive phase where political will and military capability are perfectly aligned. This strategy gives India’s defence establishment the freedom to act not only defensively but pre-emptively and offensively, based on ground intelligence and evolving operational realities.

In the strategic calculus, such a directive also removes bureaucratic delays that traditionally constrain swift military retaliation, says the security experts. It empowers commanders on the ground to act when the opportunity arises - be it via precision strikes, covert operations, or cyber disruption of terrorist networks, they add.

This isn’t the first time India has contemplated trans-border action. Following the Uri attack in 2016, India conducted surgical strikes across the Line of Control, targeting terrorist launch pads in Pakistan-occupied Kashmir (PoK).

In 2019, after the Pulwama attack, Indian Air Force jets penetrated deep into Balakot, conducting airstrikes on terror infrastructure, marking the first aerial strike inside Pakistani territory since 1971.

In view of this precedent, the current developments suggest a possible revival or expansion of the surgical strike doctrine, this time potentially in a more sustained and escalated form.

Government sources confirm that troop readiness has increased significantly along the LoC and the international border. Surveillance drones, satellite tracking, and electronic intelligence gathering have intensified, monitoring terror camps and movement across PoK.

The intelligence apparatus appears to be working in tight coordination with the military, pointing to the possibility that actionable intelligence may already be in hand.

Pakistan-based terror groups like Lashkar-e-Taiba and Jaish-e-Mohammed are under heightened scrutiny. The Pahalgam attack, due to its targeting of civilians and tourists, is being interpreted as an attempt to disrupt peace in Kashmir and damage India’s global image.

In response, India appears to be preparing for targeted retaliation not only against the foot soldiers but also their financial and logistical enablers.

India has already taken strong diplomatic steps, such as suspending the Indus Waters Treaty and ordering the expulsion of Pakistani nationals with short-term visas. These moves indicate a multi-pronged strategy - military, diplomatic, and economic - to pressure Pakistan and isolate it globally.

Should India proceed with a visible military response, it will likely be accompanied by an international diplomatic outreach, emphasising India’s right to self-defence under Article 51 of the UN Charter.

While the national mood demands action, the Modi government’s strategy appears measured but resolute. By giving the military full operational autonomy, the Prime Minister has decentralised tactical decision-making.

With the Pahalgam massacre acting as a turning point, India seems poised to redefine the rules of engagement in its fight against cross-border terrorism. The Prime Minister’s message, described as one of the clearest and most assertive in recent years, sets the stage for what could be a landmark counter-terror operation.

Whether it takes the form of another surgical strike, a covert hit, or a multi-dimensional offensive, one thing is certain - India is done absorbing the blows. It’s ready to strike back.

Terror attack in Pahalgam calls for a new strategic response

The massacre of 26 Hindu tourists and injuring of many others at Pahalgam on April 22, by a group of 4 Pak-directed terrorists - three from Pakistan and a local- who appeared from the adjoining jungle wearing army fatigues and carrying automatic rifles, compel a review of the counter-terror strategy of India to make it a multi-prong response that would create an effective long-term deterrent for Pakistan.

An ex-soldier of Pakistan is said to be the head of the group that carried out the Pahalgam carnage. The publicised environment of improved security in Kashmir in which tourists were encouraged to visit Kashmir on one hand and the palpable rise of tension in Indo-Pak relations on the other- with India reiterating that the only agenda on J&K was to complete the unfinished part of liberating the Pak-occupied Kashmir and integrating it with the Indian state and the Chief of Pak Army Gen. Asim Munir announcing once again that Kashmir was the ‘jugular vein’ for Pakistan that his country would fight for till the end, provide the backdrop to the Pahalgam killings.

In an extremely communal outburst recently, the Pak General raked up the ‘two nation’ theory by declaring that ‘we are not Hindus’ and thus not only voiced his hatred against India but in an unspoken way showed his determination to get the Pak ISI to carry out a covert offensive to demolish the Indian claims of improvement in Kashmir. The crowd of tourists at Pahalgam was an easy target for the terrorists who owned responsibility for the act identifying themselves as members of The Resistance Front (TRF ) -an offspring of Pak-based Lashkare Toiba(LeT) that had appeared in the Valley in the period following the abrogation of Art 370 by India.

The planned terror attack directed from Pakistan saw the attackers identifying the Hindu targets by name before shooting them in the head and at least in one case telling the wife that she was being spared to tell the government about why her husband was killed.

The Pahalgam killings are a reminder of how in 1990, the Pak ISI-directed militants forced the ouster of Kashmiri Pandits from the valley as Pakistan wanted to strengthen its claim on the territory on communal grounds.

The army once again controls Pakistan and it has tried to position itself differently in a geopolitical sense to deal with the repercussions of its inimical actions against India.

Pakistan is now strategically aligned with China- the Pak Army Chief Gen. Asim Munir made a significant visit to Beijing in 2023 to strengthen cooperation in Defence- while Indo-US relations have stalemated with President Trump categorically denouncing ‘Islamic terrorism’ and ordering visa curbs on countries and regions known to be fostering it.

Pakistan would have noted that many top appointees in the Trump administration took pride in their Hindu ancestry including Tulsi Gabbard, Director of National Intelligence, Kash Patel, Chief of CBI and the Second Lady, Usha Vance herself.

On the other hand, Pakistan having played a role in reinstalling the Taliban Emirate at Kabul in 2021, managed to bring about a ‘give and take’ arrangement between Taliban and China whereby China would extend its Belt & Road Initiative(BRI)

to Afghanistan for the economic betterment of the latter and Taliban would maintain silence on the issue of treatment of Muslim minorities in China particularly in Xinjiang next door.

Since radical Islam does have a place in the spectrum of faith, Pakistan has been able to harness Islamic radical forces for its covert operations against India.

Way back in 1993, following the success of Afghan Jihad- for which the US-led West gave a lot of credit to Pakistan- the Pak Army-ISI combine made a bid to replicate it in Kashmir and sent in Harkatul Ansar(HUA) which had Taliban as its primary component, to step up a revivalist campaign in the valley.

Islamic radicals carry the historical memory of the 19th century ‘Wahhabi revolt’ against the British who exemplified the Western encroachment on ‘Muslim lands’ and this is the reason why HUA targeted Western tourists visiting Kashmir, took them hostage and killed many of them before a rescue operation could be launched.

The mainstream of militants used for cross-border terrorism against India however, comprised the ISI-harboured groups like Jamaate Islami’s Hizbul Mujahideen (HuM) and Saudi-financed Lashkar-e-Taiba, which had the legacy of being on the right side of the US. This is what produced the strange phenomenon of American policymakers drawing a line between ‘good terrorists’ and ‘bad terrorists’ for some time before wise counsels prevailed.

The US went after the radical forces of Taliban and Al Qaeda during the ‘war on terror’ in Afghanistan and Iraq. This ‘war’ produced a new competitor of Al Qaeda in Iraq- Syria belt called the ISIS that remains a formidable force

even today, long after Osama bin Laden Leader of Al Qaeda, was eliminated in a midnight American SEAL team operation near Abbottabad where he was being sheltered by Pakistan in 2011.

Both Islamic radicals as well as the Jamaatis -the latter considered by the US as a representative of ‘moderate’ Islam -want an Islamic state for Muslims but the radicals want to strictly revive the puritanic Islam of the period of the four Pious Caliphs whereas the Jel line is that an Islamic State could live ‘in competition not conflict’ with the West. It may be recalled that Jel had become the main instrument for late Gen.

Ziaul Haq established, what he called, Nizami Mustafa in Pakistan and it went on to lead the anti-Soviet armed campaign in Afghanistan much to the liking of the US. For India, all streams of Islamic extremism are equally harmful for they create the danger of communal militancy giving way to Islamic terrorism.

Developments in the Middle East must be particularly noted for the indicators they provide of how geopolitical alignments are affecting the Muslim world. Pakistan’s position has become increasingly ambiguous.

The Islamic radical forces of Iran and Hamas, inimical towards the US have joined hands and shifted to the China-Russia camp. All of them consider Israel-an ally of the US- as their first enemy. Leading Arab countries including Saudi Arabia, UAE and Lebanon are with the US and even inclined to favour Abraham Accord with Israel.Syria, Yemen, Iraq and Afghanistan are the territories where Islamic radical forces have their strongholds even today. India has done well to maintain an even bilateral

relationship with the three major players in the Middle East-Saudi Arabia, Israel and Iran- and welcomed peaceful coexistence in the region. It has unequivocally condemned terrorism of all kinds and spoken against it at all international forums.

Biden Administration seemed to ignore the Pak-Afghan region, perhaps out of some comfort distance but fortunately, President Trump makes no bones about his utter disdain for Islamic terror. Both the US and Russian President have condemned the Pahalgam killings and this strengthens India’s hands in taking appropriate action to eliminate terror bases beyond its borders, in one go.

On the domestic front, India needs to put down with heavy hands all forums and leaders that subverted the Indian Constitution by demanding special ‘political’ rights for any religious minority beyond the implementation of ‘one man one vote’ and grant of full freedom to practice faith.

The pro-Pak elements claiming leadership of Muslims need to be curbed in Kashmir and elsewhere as they facilitated the adversary’s work of creating ‘ sleeper cells’ on our territory. While Jel members should be specially screened in this context, Darul Uloom Deoband- established by the protagonists of the failed Wahhabi Jihad, in 1876- deserves a close scrutiny. The institution claimed a nationalist profile on the ground that it had participated in the anti-British campaign but at the root of that fight was the belief that the Muslim rulers of India lost to the British because they had adopted un-Islamic practices and deviated from the path of pristine Islam that had to be restored.

Deobandis are taught a communal doctrine of supremacy of Islam in all spheres- personal, socio-

political and even economic- and this has to be effectively countered. There are groups in the minority community that are not taken in by the ‘religious exclusivism’ promoted by certain leaders and who believe in communal harmony- they should be patronised by the democratic state.

National security has to be protected in these critical times not merely by show of force by uniformed men in the troubled border states-which has its own importance-but by strengthening the security and intelligence set up in a manner that makes it possible to watch the agents of the adversary in lanes, localities and forest inhabitations, even in peace times.

Local Intelligence Units(LIUs) have acquired unprecedented importance. This perhaps is the most important learning from Pahalgam. The country should also move towards granting the Intelligence agencies a certain action-taking capability so that the gap between ‘information’ and ‘action’ was minimised.

It is reported that there was an intelligence warning about suspicious activity in Pahalgam suggesting a possible targeting of tourists flocking there-it would be important to know what action was initiated on it by the Lt Governor who heads the Union Territory with special powers as also by the elected Chief Minister at Srinagar.

Security often fails not due to the absence of information but due to a lack of adequate action on available intelligence. It is a universal principle of Intelligence that whatever little becomes known should be regarded as the proverbial ‘tip of the iceberg’ and acted upon in that light.

Venezuela denounces U.S. "kidnapping" its toddler

Caracus, April 29 (UNI) : The Bolivarian Republic of Venezuela on Monday denounced the U.S. authorities for "kidnapping" a two-year-old Venezuelan girl, who was separated from her mother when "boarding a repatriation flight to Venezuela."

According to a government statement, the kidnapping of the girl named Maikelys Antonella Espinoza Bernal, committed by the United States, violated "the rights of our migrants and in contravention of international norms, and most especially the Universal Declaration of the Rights of the Child and the Charter of the United Nations."

The statement said that the United States has "once again committed the extremely serious offense of separating families and removing a minor from her emotional environment and, in particular, from her biological mother."

The father of the girl was also kidnapped and sent to a concentration camp in El Salvador without any form of trial or court action, it added. "Venezuela will resort to all legal, political and diplomatic mechanisms, as well as all multilateral actions, aimed at ensuring that the sacred integrity of our families is respected and that international laws are upheld, so that the infant Maikellys Antonella Espinoza Bernal is returned safe and sound to her country," the statement said.

Amazon sends first batch of satellites into space

Los Angeles, April 29 (UNI) : Amazon launched the first batch of satellites for its "Project Kuiper" on Monday, marking a key step in the company's efforts to expand global broadband access.

The satellites were launched aboard a United Launch Alliance (ULA) Atlas V rocket from Cape Canaveral Space Force Station in the U.S. state of Florida at 7:01 p.m. Eastern Time.

The mission, codenamed "KA-01," plans to deploy 27 satellites at an altitude of 450 kilometers above Earth, according to Amazon. The mission represents the beginning of Amazon's "Project Kuiper" to deploy a constellation of over 3,000 satellites in low Earth orbit, aimed at delivering high-speed, low-latency internet access to customers and communities worldwide.

2 killed, 1 wounded in blast at plant in central Iran

Tehran, April 29 (UNI) : Two people were killed and another injured on Tuesday in an explosion at an industrial facility belonging to a chemical company in the central Iranian province of Isfahan, the official news agency IRNA reported.

The blast occurred at 10:30 a.m. local time (0700 GMT) in a plant in Shahinshahr County, IRNA reported, citing Mansour Shishehforoush, director general of the provincial crisis management department. He said the injured person had severe burns and was transferred by helicopter to a hospital, noting that the cause of the incident would be announced after the investigations are complete. According to IRNA, the company was involved in the production of fireworks.

Iran condemns US strikes on Yemen, including Migrant Detention Cente: FM

Tehran, April 29 (UNI) : Iran categorically condemns US strikes on Yemen, in particular the strike on the African migrant detention centre in the city of Sadah, the Iranian Foreign Ministry said.

On Monday, the civil defence service in northern Yemen said that 68 people were killed and 47 were injured as a result of US airstrikes on a migrant detention centre in northwestern Yemen. The Yemeni Interior Ministry accused the United States of committing a war crime due to the bombing of the migrant centre, where 115 people were being held.

"[Iranian Foreign Ministry spokesman] Ismail Baghaei categorically condemned the US strikes carried out last night on various regions of Yemen, in particular the strike on the detention centre for African migrants in the city of Sadah, which resulted in the death and injury of more than a hundred innocent people," the ministry said on Telegram on Monday.

At the same time, the UN's International Organization for Migration (IOM) has called on all parties to the conflict in Yemen to fully comply with international law. "It is imperative that all efforts are made to avoid harm to civilians and to protect those most vulnerable in these challenging circumstances," the organization said. On March 15, US President Donald Trump ordered the military action against the Houthis after they renewed attacks on Israel-linked ships in the Red Sea in response to the blockade of the Gaza Strip. The Houthis' leader, Abdul-Malik al-Houthi, said earlier in April that the US had conducted over 900 airstrikes in Yemen in a month.

Over 20 people killed in NE Nigeria from IED: Reports

Abuja, April 29 (UNI) : More than 20 people were killed in Borno State in northeastern Nigeria as a result of a terrorist attack using an improvised explosive device (IED), the Vanguard news portal reported, citing a source.

"The victims include women and children. But some said over 20 people were killed, with several others injured," the source was quoted as saying by the newspaper on Monday.

The bomb was presumably planted by the Boko Haram terrorist group, the report added.

Iran condemns U.S. lethal airstrikes on Yemen



Tehran, April 29 (UNI) : Iran's Foreign Ministry on Monday strongly condemned the U.S. deadly airstrikes on Yemen's capital of Sanaa and Saada province, including a center where African migrants were kept.

In a statement, Foreign Ministry spokesman Esmaeil Baghaei denounced Sunday's bombings, which killed at least 78 people, including

68 African migrants held at a detention center in Saada, and wounded dozens of others.

Baghaei described the U.S. military attacks against civilian targets, vital infrastructure and people's houses in different parts of Yemen as "war crimes," "which have killed hundreds of innocent people."

He criticised the United Nations and international

human rights organisations for their "silence and indifference towards this flagrant law-breaking and the frequent violations of Yemen's sovereignty and territorial integrity."

Baghaei called on Islamic states to take effective actions to stop the killing of Yemen's Muslim people and stop the continuation of Israel's "genocide" in Gaza and the West Bank.

Measles health alert issued for Australian state of Victoria

Sydney, April 29 (UNI) : Authorities in the southeastern Australian state of Victoria have issued a health alert for measles amid a spike in cases.

The Victorian Department of Health on Monday said that a new measles case has been reported in a returned traveller who visited Pakistan and was infectious on a flight from Dubai to Melbourne on April 24. The department said on Friday that there had been 22 confirmed cases of measles in Victoria in 2025 - more than in 2023 and 2024 combined. It said the majority of cases have been acquired locally in Melbourne and surrounding areas.

Victoria is Australia's second-most populous state with a population of

over seven million. Tarun Weeramanthri, Victoria's Chief Health Officer, said on Monday that there is an "increased risk" of measles in greater Melbourne and the neighboring Mitchell Shire. "A growing number of measles cases have acquired their infection locally in Victoria," he said in a statement. "The majority of recent cases have arisen in people who have not had two documented doses of the MMR (measles-mumps-rubella) vaccine."

He said that there is also an "ongoing risk" of measles being imported into Victoria by overseas travellers due to rising cases globally. Anyone who spent time in greater Melbourne or the Mitchell Shire from early April has been urged to monitor for

symptoms of measles, including fever, cough and feeling generally unwell followed by a rash that usually starts on the face. Measles can spread through airborne droplets or contact with nose or throat secretions. According to the World Health Organisation, over 107,000 people died from measles globally in 2023 - most of whom were unvaccinated or under-vaccinated children younger than five.

The Victorian Department of Health said that measles vaccination coverage across Australia has fallen below the 95 percent national target since the COVID-19 pandemic. The MMR vaccine is free in Australia for anyone who has not previously received two doses.

Russian Air Defence destroys 91 Ukrainian drones since evening of Apr 28: Ministry

Moscow, April 29 (UNI) : The Russian air defence systems destroyed 40 Ukrainian drones over the past night, while 91 drones were shot down since Monday evening, the Russian Defence Ministry said on Tuesday. "During the past night, air defence systems destroyed 40 Ukrainian fixed-wing drones: 11 drones over the Ryazan Region, eight drones over the Nizhny Novgorod Region, seven drones over the Oryol Region, four drones over the Republic of Crimea, four drones over the Black Sea, two drones over the Moscow Region, two drones over the Belgorod Region, one drone over the Kaluga Region and one drone over the Bryansk Region," the ministry said.

The ministry added that in total, from 20:00 Moscow time on April 28 to 06:00 Moscow time on April 29 (from 17:00 GMT to 03:00 GMT), the air defence systems destroyed 91 Ukrainian drones.

Islamabad, April 29 (UNI) : At least one person was killed and over 40 others were injured when an oil tanker exploded in Pakistan's southwest Balochistan province on Monday, police and government officials said.

The incident happened in Noshki district of the province when a fuel tanker parked at a truck

depot caught fire, resulting in an explosion and injuring multiple people standing nearby, Noshki Senior Superintendent of Police Hashim Momand told Xinhua.

He said that among the injured were police personnel and fire fighters, who have arrived at the scene to manage the situation and put out

'21 terrorists killed in western Mali'

Bamako, April 29 (UNI) : The Malian army announced on Monday that it has killed 21 terrorists during an operation in west Mali's Sebabougou area.

Sebabougou is now under control thanks to "airstrikes targeting a terrorist hideout, destroying several of their bases," the army said in a statement. During their retreat, the terrorists left behind 21 bodies, dozens of weapons with ammunition and accessories, vehicles, and communication equipment, the army said. "Search operations are continuing to track down the many wounded and fleeing criminals," the army said, adding that five soldiers were injured during the clashes.

3 Kurdish security personnel injured in unknown drone attack in N. Iraq

Baghdad, April 29 (UNI) : An unknown drone attack on Monday wounded three members of the Peshmerga, the military of the Kurdistan Regional Government, in Iraq's semi-autonomous Kurdistan Region, a Kurdish security source said. The incident occurred in the afternoon when an unidentified booby-trapped drone struck a Peshmerga position in a village near the town of Amedi in Duhok province, a Peshmerga officer told Xinhua.

The officer said that Peshmerga personnel at the site fired at the drone, but it detonated within their position, wounding three security personnel. No group has yet claimed responsibility for the attack, and the Kurdish security authorities have initiated an investigation into the incident, the officer added.

Trump govt has shown contempt for universal human rights: Amnesty International

London, April 29 (UNI) : The first hundred days of incumbent US President Donald Trump has been "catastrophic" to racial and gender justice, global health, as also for climate action and multilateralism, Amnesty International warned in its annual report launched on Tuesday.

The report highlighted the rise in authoritarian practices and suppression of dissent around the world. "The Trump effect has compounded the damage done by other world leaders throughout 2024, eating away at decades of painstaking work to build up and advance universal human rights for all and accelerating humanity's plunge into a brutal new era characterized by intermingling authoritarian practices and corporate

greed," the human rights watchdog said in its analysis of the situation in 150 countries.

Agnes Callamard, Amnesty International's Secretary General, expressed concern over disregard of multilateral institutions and international law.

She also highlighted the need for government and civil society to work together with urgency to "lead humanity back to safer ground." "One hundred days into his second term, President Trump has shown only utter contempt for universal human rights. His government has swiftly and deliberately targeted vital US and international institutions and initiatives that were designed to make ours a safer and fairer world," she added.

Death toll from Sunday's overnight U.S. airstrikes on Yemen's capital rises to 12

Sanaa, April 29 (UNI) : The death toll from Sunday's overnight U.S. airstrikes on three houses in Yemen's capital Sanaa rose to 12, with 4 others injured, Houthi-controlled health authorities said in a statement late Monday night.

The toll included women and children, the statement said. The Houthi-run al-Masirah TV reported 15 airstrikes throughout Monday, targeting several locations across northern Yemeni provinces, including the capital Sanaa.

Meanwhile, casualties from U.S. dawn strikes on a migrant center in the northern province of Saada have risen to 68, all of them undocumented African migrants, according to the Houthi television. The U.S. military was reportedly investigating the incident. The Houthi group has been controlling much of northern Yemen since a civil war in Yemen broke out in late 2014. Tensions between the Houthis and U.S. forces have escalated sharply since March 15, when Washington resumed airstrikes on Houthi targets in Yemen, a campaign criticised by many regional governments as a threat to wider stability.

Pro-Khalistani Jagmeet Singh and his NDP suffer humiliating defeat in Canadian elections

Toronto, April 29 (UNI) : Pro-Khalistani leader Jagmeet Singh, leader of Canada's New Democratic Party (NDP), was defeated in the just-concluded Canadian federal elections and has resigned.

The elections saw Prime Minister Mark Carney's Liberal Party emerging victorious.

Jagmeet Singh was defeated from the Burnaby Central seat in British Columbia, and his party could get only seven seats in the 343-member new parliament, thus losing its national political party status.

The NDP could get only two percent of the votes.

The New Democratic Party had 24 seats in the previous parliament.

After the results, Jagmeet Singh said, "I am disappointed that we could not win more seats, but I am not disappointed in our movement. I am hopeful for our party."

According to hospital sources, at least 16 people are in critical condition, with some suffering 70 to 80 percent burns. The severely injured people are being shifted to the provincial capital city of Quetta for better treatment.

it engulfed the fire brigade vehicle present at the scene and critically injured fire brigade personnel, Spokesperson for Balochistan Shahid Rind told local media.

"A state of emergency has been declared in all the hospitals in the district ... the incident is unfortunate and investigations are being conducted," Rind added.

Australian researchers advance genetic tools to better predict inherited cancer risk

Sydney, April 29 (UNI) : Medical researchers have developed advanced computational tools that significantly improve the accuracy of genetic testing for inherited cancer risk, an Australian government research institute has revealed.

The accuracy of genetic testing has been significantly improved particularly in people with Li-Fraumeni Syndrome, a rare, inherited cancer predisposition syndrome caused by faults in the TP53 gene, which significantly increases the risk of developing multiple types of cancer, according to a news release of the

QIMR Berghofer (formerly the Queensland Institute of Medical Research) on Monday. The study by researchers at QIMR Berghofer, collaborating with Spain's Hospital Clinico San Carlos and US--based Ambray Genetics, shows how integrating new computer-based predictions with existing genetic models enhances the classification of genetic variants, helping distinguish between harmless mutations and those likely to cause cancer. These improved methods can guide more accurate diagnoses and enable targeted clinical

management, such as early screening and preventative treatment, said the study published in the American Journal of Human Genetics.

"Li-Fraumeni Syndrome is rare, but for the people affected it's extremely important to give them certainty," said lead author Nitsan Rotenberg from QIMR Berghofer. Accurately identifying harmful variants allows individuals to receive intensive monitoring and early interventions, Rotenberg said. Their approach includes using tools that predict structural changes in

proteins caused by gene variants and assess how these changes affect protein stability. This combined method reduces uncertainty around TP53 variants, crucial for high-risk families where the chance of developing cancer by age 60 can be as high as 95 percent, said the research team led by QIMR Berghofer Prof Amanda Spurdle.

Using protein structure predictions enhances the ability to interpret the growing number of unclassified variants, ultimately improving care and informing global clinical guidelines, Spurdle said.



# Irrigation Minister holds BRS govt responsible for Kaleshwaram project collapse

Hyderabad, April 29 : After the National Dam Safety Authority (NDSA) in its report confirmed the structural collapse of all three barrages of Kaleshwaram project, Telangana Irrigation & Civil Supplies Minister Capt N Uttam Kumar Reddy on Tuesday squarely blamed the previous BRS government for the collapse of the said project, calling it the biggest man-made disaster since independence and the most expensive engineering failure caused by any state government in the country. Releasing the final report of the NDSA at Dr B R Ambedkar Telangana Secretariat here, Uttam said the findings confirmed the structural collapse of all three barrages— Medigadda, Annaram and Sundilla— and exposed the inefficiency, negligence, and deliberate mismanagement of the previous regime under former chief minister K Chandrashekhar Rao (KCR). Uttam said the Kaleshwaram project was not based on scientific principles but on a campaign of lies,



propaganda and false publicity. The NDSA report also confirmed that safety protocols were ignored, borehole investigations were inadequate and maintenance records were absent, in violation of legal mandates. The NDSA report recommended urgent stabilisation, repair and rehabilitation of the damaged structures, and the Minister stressed the need for expert-driven technical intervention. He assured that the Congress government would take necessary steps. “All decisions will be

taken after Cabinet discussion. Action will follow as per law. Those who gave the orders that led to this disaster will be held accountable,” he said. “Technical institutions like WALAMTARI, which once trained irrigation engineers, must be urgently strengthened. We are working on a scientific plan, with expert inputs and no political interference,” he said. “This is not politics. This is a rare and gross failure of public infrastructure. A judicial commission has already been constituted and will take note of these facts,” he said. Uttam said Telangana

is currently paying Rs 16,000 crore annually towards interest and installments on high-cost loans borrowed during the BRS regime for this faulty project, placing an enormous burden on the State’s finances and its farmers. He reminded the public that the original plan was the Dr B R Ambedkar Pranahita-Chevella Project at Tummadihatti, for which even the then TRS government had sought national project status. However, KCR abandoned it and instead reengineered and redesigned everything to launch Kaleshwaram, falsely promising that both

projects would be completed, he said. Instead of sustainable planning, the previous regime opted for hurried execution funded by high-interest loans, resulting in massive financial losses he alleged. “All three barrages have structurally collapsed, he said that the barrages were originally designed to regulate just 2 TMC of river water. However, over 10 TMC was stored in each, driven purely by a publicity agenda, causing foundational damage and eventual collapse. “Signs of seepage and damage were noticed as early as 2019, but the BRS

government ignored them. This criminal negligence caused financial losses of thousands of crores to Telangana,” he pointed out. Uttam said “The Kaleshwaram collapse is not a natural tragedy. It is a direct result of the BRS government’s irresponsible decisions. It has dealt a serious blow to Telangana’s finances and to the lives of farmers. Adviser Adityanath Das is currently reviewing the feasibility of reviving the original Tummadihatti-based Pranahita-Chevella project. The Minister said this was a moment of reckoning for Telangana, and the Congress government would ensure that no such betrayal happens again. “This is not politics. This is a rare and gross failure of public infrastructure. A judicial commission has already been constituted and will take note of these facts,” he added. Ministers Ponnam Prabhakar and Jupally Krishna Rao, Adviser to Telangana Government Mohammed Ali Shabbir, TPCC Working President Jagga Reddy, Lok Sabha MP Balram Naik, and senior officials were also present.

# Need to integrate all technologies in food chain: Vemuri

Hyderabad, April 29 (UNI) : Leading agri-scientist Vemuri Chowdary on Tuesday said that under Agriculture 4.0 there is a need to integrate all technologies in the food chain. Chowdary, Group Director – Agri Sciences & Applications, National Remote Sensing Centre (NRSC), ISRO, while addressing the inaugural session of Agri Vision 2025, said precision agriculture is predominantly for high-value commercial crops, and it would help in reducing the cost and increasing the yields. The third edition of the conference with the theme “Digital Agriculture for Enhancing Productivity and Sustainability” was organised by CII Telangana here. Chowdary said climate change is impacting agriculture in a big way, and instead of focusing on a policy level approach, the country needs to adopt a farmer focused approach. Monitoring through satellites will help in

understanding the harvest progress and estimate the yield outputs which will reach the markets, he added. In his address, Amit Vastyayan, Parter & Leader- Social & Skills Sector, EY, said technologies should be accessible to marginal farmers and women farmers. In India, productivity is a big challenge as the country was nowhere close to global yields, he said, adding that many startups are working to provide solutions for the problems faced by the farming community. He also said that 4 C’s could play a major role in driving the future of agriculture -- cost, collaborations, competitiveness, and commercially viable products. Agri Vision brought together key stakeholders – industry leaders, policymakers, agri-tech innovators, financial institutions, and progressive farmers – and explored strategies for making agriculture more sustainable, technology-driven, and globally competitive.

## ACB caught Shamirpet SI for accepting Rs 22,000 bribe

Hyderabad, April 29 (UNI) : Anti-Corruption Bureau officials caught M.Parushuram, Sub-Inspector (SI) attached to Shamirpet Police station under Cyberabad Commissionerate when he demanded and accepted a bribe of Rs 22,000 from the complainant. The SI demanded the bribe from the complainant for showing official favour – “to exclude the complainant and his worker, from the cheating case registered by the shamirpet police station and to return the complainant’s cell phone”. The accused officer had already accepted Rs 2 lakh as bribe from the complainant, ACB said in a release here on Tuesday. The SI was arrested and produced before the Principal Special Judge for SPE and ACB cases court at Nampally here. The case is under investigation.

## Two nursing students killed as car runs amok in Telangana

Hyderabad, April 29 (IANS) : A car ran amok in Telangana’s Gadwal town on Tuesday, killing two nursing students and injuring some others. The incident occurred on Tuesday evening when students of a nursing college were waiting for a bus at a bus stop to go to their hostel. According to police, the SUV rammed into the students waiting at the Housing Board Turning Bus Stop in the Gadwal district headquarters. Two female students died on the spot, while three others were critically injured. They were shifted to the government hospital, where the condition of two of them is stated to be critical. Two children, who were also waiting at the bus

stop, sustained grievous injuries and were also admitted to a hospital. The deceased have been identified as Maheshwari, a resident of Makthal, and Manisha, who hailed from Wanaparthy. After the accident, the SUV driver escaped from the spot, leaving behind the vehicle. Locals said the driver lost control of the vehicle as he was drunk. Police officials rushed to the spot and shifted the injured to the hospital. The bodies of the two deceased students were also shifted to the mortuary at the government hospital for autopsy. Police registered a case and took up an investigation. A police officer said they were trying

to apprehend the person who was driving the vehicle. The incident sent shock waves among parents of the students of the nursing college. Gadwal MLA Bandla Krishna Mohan Reddy, district Collector B. M. Santosh and Superintendent of Police T. Srinivasa Rao visited the government hospital. Health Minister Damodar Raja Narasimha has expressed shock over the accident. He condoled the death of two nursing students. He spoke to the Gadwal MLA over the phone. The Minister directed officials to ensure the best possible treatment to the injured. He also asked them to provide assistance to the families of the deceased students.

## Guinness world records holder unveils Origami masterpiece of Lord Venkateswara Swamy

Hyderabad, April 29 (UNI) : Guinness World Records holder Ravi Kumar Toleti unveiled a breathtaking masterpiece of Lord Venkateswara Swamy, at Kendriya Vidyalaya , Tirumalagiri, here on Tuesday. Origami, the art of paper folding, has evolved far beyond its traditional roots. This artwork of Lord Sri Venkateswara Swamy is crafted entirely through the intricate technique of origami folding. Each unit, composed of 15 precise folds, is interlocked to bring the divine form to life. These folded units are meticulously mounted onto a paper card, and the entire piece is proposed to be framed elegantly with teak wood and glass. The grand image is divided into nearly 40 sections, with each segment, ranging from 2’ x 2’ to 4’ x 2’, designed separately on grid paper. Every part is vividly coloured using sketch pens to perfectly capture the details of that portion. Speaking on the occasion, Ravi Kumar said “My ultimate dream is to see this artwork adorning the sacred walls of Lord Venkateswara’s holy abode at Tirumala.” Vidyalays Incharge Principal K Lalithkala Saseendran, felicitated Ravi Kumar who is a teacher at Kendriya Vidyalaya.

## Police bust inter-state drug peddling racket, arrest 4

Hyderabad, April 29 (UNI) : The city police have busted an inter-state drug raked by arresting four people, including two city-based peddlers, police said here on Tuesday. On credible information, the city police jointly with the HNEW (Hyderabad Narcotics Enforcement Wing) team and the Nallakunta police on Monday conducted joint operation and nabbed – inter-state drug supplier Harshvardhan Shrivastava alias Harsh (30) from Jabalpur (Madhya Pradesh) and inter-state drug peddler Srinivasa Rahul (30) alias Rahul, resident of Chennai, and

local peddler Abhishek (26), a software employee, and sub-peddler Dhawal, an architect (both from Secunderabad). Seized 1,380 grams of hydroponic marijuana, LSD blots (44), six mobile phones, two motorbikes and other material, worth Rs 1.4 crore from their possession, said P Vishwaprasad, Additional Commissioner of Police (Crimes and SIT), Hyderabad City, in a release here. Harshvardan Shrivastava sourced high-quality cannabis from the darknet marketplace “Dread Market” using encrypted platforms like Signal App. He acted as a middleman, buying the drug at Rs

15,000 per ounce and selling it for Rs 25,000 through courier services. Payments were made via cryptocurrency and hawala, funding his lavish lifestyle. Srinivasa Rahul, initially consumed marijuana, but later became a transporter, sourcing it through Snapchat and supplying it to peddlers in Chennai, Bengaluru and Hyderabad. Abhishek, an IIIT-Raipur graduate, procured the drug from Harshavardan via Signal App and sent money through hawala. He supplied drugs to Dawal in Secunderabad and other customers by hand at higher prices to earn easy money.

## MP Shiksha Parishad, cornerstone of Gorakhpur University

Gorakhpur, April 29 (UNI) : Deen Dayal Upadhyay University, the first state university of Uttar Pradesh post-independence formerly known as Gorakhpur University, is set to celebrate its 75th anniversary on Wednesday. Established on May 1, 1950, with the foundation stone laid by then-CM Pandit Govind Ballabh Pant, the university will mark its platinum jubilee with a grand celebration, attended by Chief Minister Yogi Adityanath as the chief guest. The CM’s presence at the event carries both official and personal significance. As the current Mahant of Gorakshpeeth, which played a key role in the university’s founding through the Maharana Pratap Shiksha Parishad, his involvement underscores the deep historical connection between the institution and the Peeth. The Maharana Pratap Shiksha Parishad was founded in 1932 by the then Mahant of

Gorakshpeeth, Mahant Digvijaynath. At a time when the idea of setting up a university in Gorakhpur was still in its infancy, Mahant Digvijaynath had already opened two degree colleges under the banner of the Parishad, one for men and another for women, both named after Maharana Pratap. Principal of Maharana Pratap Degree College Dr Pradeep Kumar Rao said that after India gained independence in 1947, the government began considering establishing a university in UP, with western UP being the initial preference. At this critical moment, Mahant Digvijaynath, along with Bhai Ji Hanuman Prasad Poddar and Sardar Majithia, appealed to the then CM to set up the first state university of independent India in Gorakhpur. One of the major hurdles in setting up the university was the requirement of assets or

funds worth Rs 50 lakh. Mahant Digvijaynath addressed this issue by donating the Maharana Pratap Degree College and the Maharana Pratap Women’s Degree College, both run under the MP Shiksha Parishad, for the university’s foundation. These two colleges were valued at Rs 42 lakh. The remaining Rs 8 lakh was arranged through donations from royal families of the nearby princely states. Pandit Surti Narayan Mani Tripathi, the then District Collector and ex-officio chairman of the university’s establishment committee, played a crucial role in acquiring land for the university. Dr Rao said that the role of MP Shiksha Parishad in the founding of Gorakhpur University is also evident in the composition of the university’s establishment committee. Out of the 18 members of the committee, 11 were from the Maharana Pratap Shiksha Parishad.



# Japan triumph in EAP Qualifier to book U19 Men's Cricket World Cup 2026 ticket



Sano, April 29 (UNI) : Japan became the 14th nation to seal their place at the ICC U19 Men's Cricket World Cup 2026, with a dominant 115-run victory over Fiji, capping a scintillating, unbeaten week at the East Asia-Pacific Qualifier here.

The home side began the week with impressive wins over PNG (by 106 runs and by 71 runs) and Fiji (6 wickets) and arrived at Monday's fixture knowing a second victory over the latter would see them advance to their second U19 Men's CWC.

Winning the toss and electing to bat first without their usual captain Nikhil Pol, the opening pair of Hugo Tani-Kelly (38 runs) and Nihar Parmar (36) made a solid start, putting on 78 runs before

Parmar fell, bowled by

Liga Manara. The dismissal of Tani-Kelly with the scores at 91 for two prompted a mini-collapse for Japan but critical contributions from Charlie Hara-Hinze (21) and Kazuma Kato-Stafford (25) helped steer them to a competitive 167 all out in 43 overs. Joeli Moala and Manara were the pick of the bowlers for Fiji, recording three for 33 and two for 29 respectively.

With the biggest chase of the competition on the cards, Fiji began with Maika Kamikamica and Peni Mawa aiming to see off the opening bowlers, but it only took until the end of the sixth over for their resistance to be broken, with both openers losing their wickets in successive balls to Kato-Stafford and Tani-Kelly. The wicket of Vakatawa Jone brought

Manav Narayan to the crease, and despite a rearguard innings of 20 from 35 balls, Fiji were undone by the talented Japanese bowling lineup, losing wickets at regular intervals with Hara-Hinze (four for 13) and Parmar (three for no runs and a run out) tearing through their middle and lower order.

Parmar picked up the final wicket with Fiji well short on the scorecards for Japan to seal a 115-run win and a World Cup place in front of jubilant home support, an ICC media release said.

Reacting to their qualification, Japan captain Pol, said: "We are so excited about qualifying for the World Cup. It's the biggest event on the U19 calendar and to follow in the footsteps of the team in 2020 makes us extremely

proud. "I can't wait to represent our country in Africa next year."

The final day of the event on Tuesday saw PNG get their first win, beating Fiji by seven wickets in a rain-affected match, and following the conclusion of the action, the Japanese duo of Hara-Hinze and Parmar were recognised as the standout performers across the week – Parmar taking home the Batter and Bowler of the Tournament awards (121 runs and 13 wickets from his four matches), while Hara-Hinze picked up the Player of the Tournament prize (92 runs and 12 wickets).

Japan had more reason to celebrate soon after, with no fewer than five players included in the Team of the Tournament. Captain Pol was named alongside Parmar, Hara-Hinze, Tani-

Kelly and Skyler Nakayama-Cook, with the remaining spots filled by Narayan, Moala and Manara of Fiji, plus Gaba Frank, Vagi Vani and Anthony David of PNG.

Sixteen teams will be competing at the ICC U19 Men's Cricket World Cup 2026 in Zimbabwe and Namibia. Ten teams automatically qualified for the event as the best-placed Full Member nations from the 2024 edition: Australia, Bangladesh, England, India, Ireland, New Zealand, Pakistan, South Africa, Sri Lanka and West Indies. Full Member hosts of the World Cup in 2026, Zimbabwe have also secured automatic qualification.

The remaining five spots are determined through regional qualification pathways, with only the winning team from each regional Qualifier advancing to the ICC U19 Men's Cricket World Cup 2026. Tanzania became the first team to qualify through this route last month with victory at the Africa Qualifier, while Afghanistan also booked their World Cup ticket after clinching the recent Asia Qualifier in Nepal. Victory in Sano means Japan are the 14th team to qualify, with Qualifiers in Europe and Americas still to follow in July and August where the final teams will be confirmed.

## Rising star of India Pratika Rawal breaks longstanding batting record

Colombo, April 29 (UNI) : India top-order batter Pratika Rawal added another accolade to her growing list of achievements, when she became the fastest player to reach 500 runs in Women's One Day Internationals.

In doing so, she has broken the record set by England legend Charlotte Edwards almost three decades back in 1997.

Rawal achieved the feat in just eight innings, and achieved the feat during her brilliant knock of 78 against South Africa in the ongoing tri-series in Sri Lanka. She overtook Charlotte's record by a single innings.

India posted 276/6

following a strong batting display in the first innings

This also makes Rawal the second-fastest player, across men's and women's cricket, to achieve the 500-run mark in ODI cricket.

South Africa's Janneman Malan has achieved this feat in seven innings in Men's cricket, an ICC report said.

In her nascent ODI career, Pratika Rawal has amassed five half-centuries and a century, taking her total to an impressive 572 runs. She has achieved this at a blistering strike rate of 92.71 and an outstanding average of 81.71.

Rawal has three Player of the Match awards and a

Player of the Series award to her name, not including the ongoing contest against South Africa, and looks well in contention to break the record for fastest to 1000 runs in Women's ODIs.

The current record is held by Australia's Lindsay Reeler, who achieved the feat in 23 innings. Reeler is followed by compatriots Meg Lanning and Nicole Bolton, who are jointly placed at the second place and achieved the landmark in 25 innings. Another Australia legend, Belinda Clark is tied with South Africa's Laura Wolvaardt in fourth place, having reached 1000 ODI runs in 27 innings.

## Kalinga Super Cup semi-finals : Last four begin summit climb

Bhubaneswar, April 29 (UNI) : After more than a week of gruelling action, the Kalinga Super Cup 2025 has only four remaining contenders.

The semi-finals will take place on Wednesday, with Mohun Bagan SG taking on FC Goa (16:30) and Mumbai City FC locking horns with Jamshedpur FC (20:00) at the Kalinga Stadium.

After a record-breaking league campaign, winning the ISL Shield and Cup, and already booking a place in next season's AFC Champions League Two, Mohun Bagan SG travelled to Bhubaneswar with a young squad for what coach Bastab Roy labelled as an "exposure trip".

The Mariners left Kerala Blasters FC stunned, beating them 2-1 in the quarter-finals, and are just two wins away from a domestic treble.

FC Goa, who finished second in the ISL, however, will be a tougher ask than the Blasters, according to Roy. The Gaurs were one of the only two sides to beat them during the regular season.

"FC Goa are, without a doubt, a better and a stronger team than Kerala Blasters. So my job is not easy. But my players are focussed and ready.

"It's an exposure trip for the young boys and some seniors as well. It's a semi-final and I've told my boys to enjoy the game," said Roy in the pre-match press conference. Mohun Bagan certainly did enjoy their outing against the Blasters on Saturday, with Salahudheen Adnan K, being the highlight performer. The 21-year-old bagged an assist and picked up the

Kalinga Player of the Match award. But Roy tried to tone down the buzz, stressing that it's important for the youngsters to keep their

focus on the next game and put on consistent performances.

He also stated that game-by-game is the way to go in knockout tournaments.

"We can't judge players with one match. Let's not hype the boys too much because they are very young. Let them play.

"We're not thinking about being champions right now. Winning the first match was good for us because we now get one more chance. Obviously, it's a semi-final and if we win, we will get a chance to play the final, and then we'll think of being the champions," Roy added.

FC Goa head coach Manolo Márquez spoke on similar lines. The Gaurs have reached the semi-finals after two victories, a breezy 3-0 defeat of Gokulam Kerala FC, followed by a nerve-racking 2-1 comeback win over Punjab FC on Saturday. Márquez now stands two wins away from his first silverware with FC Goa. "Everyone knows that you have to win four games to be the champion. Every game is very difficult. Winning a trophy is very important," the Spaniard said. FC Goa are billed as favourites for this clash, owing to their full strength, but Márquez emphasised that the number of foreign players is not an indication of a team's strength, citing examples from the Kalinga Super Cup so far.

"Mohun Bagan are here with half the squad of the main team, and the other half were champions of the Reliance Foundation Development League two weeks ago. I think that the game will be very difficult because they have nothing to lose. This is the reality. They have already won two trophies. They already have the slot for the Asian competition.

## Sciver-Brunt replaces Knight as England captain

London, April 29 (UNI) : England have appointed all-rounder Nat Sciver-Brunt as their new captain.

Sciver-Brunt, 32, replaces Heather Knight after nine years in the role and is just the fourth permanent women's captain since 2000.

Knight was sacked in March as a result of a review into the humiliating 16-0 Ashes defeat earlier in the year.

Head coach Jon Lewis was also removed from his position and has been replaced by legendary former captain Charlotte Edwards.

"I'm really proud to take on the role of captain and it's an honour to have been asked by Charlotte, someone I've always looked up to," said Sciver-Brunt. "Ever since I made my England debut back in 2013, all I have wanted to do is help the team in every way that I can. I will try my best to lead this team to success, while empowering them to be the best version of themselves.

"We have a really talented group, and we have a group that's united. It's a team I believe in and a team that can have a lot of success together."

Sciver-Brunt was the most likely candidate to take over, having been Knight's vice-captain, and is one of England's most experienced all-format cricketers, the BBC reported.

During the Ashes, she had stated her desire to fulfil the role when Knight's future remained uncertain,

and has previously led England in 11 T20s and once in one-day internationals, with nine of those being wins.

But Sciver-Brunt's appointment also felt inevitable considering England's lack of other leadership options, having failed to implement a proper succession plan despite the considerable length of Knight's tenure.

Spinners Charlie Dean, 24, and Sophie Ecclestone, 25, were other potential candidates but are lacking in captaincy experience.

England's home summer consists of white-ball series against West Indies and India, starting in May, while Sciver-Brunt's first major assignment will be the 50-over World Cup, which takes place in India in September. While Sciver-Brunt's record when stepping in as captain is positive, two of the three defeats have come in highly pressurised situations, again highlighting England's lack of structure without Knight. England failed to win a medal at the Commonwealth Games in 2022 when Knight missed the tournament with a hip injury, and the team's fielding imploded against West Indies during the T20 World Cup in 2024, where they went out at the group stage. But Sciver-Brunt could benefit from the opportunity to lead in her own style rather than simply stepping into Knight's shoes for a brief time, while the partnership with Edwards is likely to be a significant boost.

## Barcelona, Inter to fight through fatigue in Champions League semifinal

Madrid, April 29 (UNI) : FC Barcelona plays Inter Milan on Wednesday night in a Champions League semifinal first leg tie that promises to be a duel between two tired sides.

Barca goes into the game after a dramatic 3-2 win over bitter rival Real Madrid in Saturday's Copa del Rey final, with Jules Kounde scoring an extra-time winner.

The title, and how it was won, will be a huge boost to Barca's morale, but the fact that the players had to endure extra time in a match that didn't finish until 1 a.m. also presents challenges to coach Hansi Flick.

Key players such as Kounde, Lamine Yamal,

Raphinha, Frenkie de Jong and Inigo Martinez all played over 100 minutes on Saturday, with most playing all 120 minutes.

Meanwhile, injuries to Alejandro Balde and Robert Lewandowski rob Barca of two key players and the ability to rotate its starting 11.

Balde should be available for the return leg, but Lewandowski's hamstring injury is likely to keep the top scorer out of both matches.

That means Flick may have to continue with Ferran Torres in attack, or he could consider playing either Gavi or Ferran Lopez as a false nine alongside Raphinha and Yamal.

Gerard Martin will

continue at left-back, although Martinez could move across if Flick wants to freshen up his defense with Ronald Araujo alongside Pau Cubarsi in the back four.

De Jong and Pedri will start in midfield despite Saturday's exertions, with Eric Garcia available to provide cover when tiredness sets in.

Inter's players are also looking tired as they travel to Montjuic, as a late-season drop in form threatens to derail the Nerazzurri's campaign.

Since reaching the Champions League semis in Europe, Simone Inzaghi's side has lost three consecutive games and failed to score a goal.

## Food by candlelight and no showers at Madrid Open

Madrid, April 29 (UNI) : Mirra Andreeva had just stepped up to the baseline to serve for a place in the Madrid Open quarter-finals when the power went out.

A sweeping outage left millions in Spain, Portugal and parts of France without power, causing chaos across many regions on Monday. At the Spanish tennis tournament, the electronic line-calling system went down, with players and the chair umpire left to call the lines, while the scoreboards also went dark. On the main court, where Britain's Jacob Fearnley was about to serve to stay in the match against Bulgarian Grigor

Dimitrov, the 'spider cam' that hovers above court stopped right in the players' eyeline, preventing them from serving, the BBC reported. Russia's Andreeva served out victory but admitted afterwards it wasn't easy, saying: "It was 15-40 on my serve and I was like, Oh, Mirra, just please, please do everything in your power to just take this game and finish this match." Across Spain, traffic lights went out and trains stopped running, with Brazilian doubles player Fernando Romboli posting on Instagram that he was stuck in a lift, external at the tournament for 30 minutes. Fearnley

and Dimitrov had to leave court with the match poised at 6-4 5-4 in Dimitrov's favour, while Andreeva, Coco Gauff and Italian Matteo Arnaldi managed to complete their respective victories. "So far, the toughest thing has been not been able to shower after my match," American Gauff said on Monday.

"There's no running water so I just had to take baby wipes and wipe myself, spray some perfume and call it a day." It's just crazy how much we depend on electricity. It's really insane." Photographs on social media showed the players' restaurant lit by candles, with some heading

out to practice before the lack of natural light made it impossible to continue.

"Everyone is using the phones with flashlights," Andreeva said, "but it's also kind of fun because everyone is talking together." The atmosphere is a little bit more friendly."

Gauff agreed, saying: "Most of the time we're trying to prepare for our matches, everyone's zoned in and we all understand that." I was talking to Frances [Tiafoe], talking to Mirra, too, Diana [Shnaider], Maddy [Keys]. "This is the type of situation, it's light-hearted, nobody knows when they're going to go on."

the locals. Pithoragarh district is also very sensitive from the security point of view due to its border with Tibet (China) and Nepal.He requested the aviation minister to open 'House of Himalayas' stalls at Dehradun, Pithoragarh and Pantnagar airports so that local products can be promoted.

# J&K closes 48 tourist destinations following Pahalgam attack

Srinagar, April 29 (UNI) : Authorities in Jammu and Kashmir have shut down 48 resorts and tourist destinations across the Valley amid security concerns, officials said on Tuesday.  
The decision comes in the wake of a comprehensive security audit conducted across 87 tourist locations in all districts, following last week's deadly terror attack in Pahalgam that claimed the lives of 25 tourists and a local resident. The audit was aimed at identifying security vulnerabilities and bolstering safety measures at major tourist destinations.  
Among the prominent destinations now off-limits to tourists is Gurez, a valley on the Line of Control (LoC) in

Bandipora district that attracted thousands of tourists over the last decade.  
The other top destinations closed include Yousmarg and Doodhpathri in Budgam; Aharbal, Kounsarnag, and Verinag in south Kashmir; Kaman Post on LoC in Baramulla; and the picturesque Bangus Valley in Kupwara.  
In Srinagar city, the government has decided not to allow the tourists from visiting Jamia Masjid, the grand mosque located in the old city.  
The famous resorts like Pahalgam, Gulmarg and Sonamarg would remain open for tourists.  
Authorities emphasized that the

tourist spots which remain open have been provided with enhanced security arrangements to ensure safety of visitors.  
The Jammu and Kashmir Forest Department has also closed all its trekking routes for tourists. Over the past four years, both locals and non-local visitors had increasingly flocked to Kashmir's meadows and alpine trails, especially during the summer trekking season.  
While the Valley had witnessed a rise in tourist arrivals in recent years, the Pahalgam attack has dealt a severe blow to the tourism industry. Over the last six days, several tourists have left Kashmir while many others have cancelled their coming travel plans to Kashmir.
