Mumbai, April 8 (UNI) : The Bombay High Court on Tuesday initiated suo motu contempt proceedings against advocate Nilesh Ojha for his "scandalous defamatory' and remarks against a sitting HC judge during a press conference related to the Disha Salian death case.

The bench directed YouTube and a Marathi news channel to "forthwith' remove the video of the press conference and all related material.

Invest UP must set global standards PM Modi holds talks with visiting **Dubai Crown Prince Sheikh Hamdan** in investment promotion: Yogi

Lucknow, April 8 (UNI) : Chief Minister Yogi Adityanath on Tuesday directed that expert services be engaged to further enhance Uttar Pradesh's industrial ecosystem, emphasising the need for 'Invest UP' to evolve into a model investment promotion and facilitation agency.

While reviewing the work of Invest UP, the CM called for the inclusion of sector-specific specialists who can effectively engage with global industries and attract greater investment to the state.

He said that by embracing Prime Minister Narendra Modi's mantra of 'Reform, Perform, Transform', UP has, over the past eight years, emerged as the top choice for investors in India. He emphasised the need to further strengthen this positive industrial environment.

Yogi said that while an online single-window system has been established and is benefiting entrepreneurs, investors still often need to approach multiple departments for approvals. "In many cases, No Objection Certificates (NOCs) are issued at various levels depending on the investment category," he said.

He emphasised the need to streamline and strengthen the system, ensuring the single-window mechanism is implemented in its true spirit.

The CM emphasised the need to restructure the Nivesh Mitra portal using technology to prevent entrepreneurs' applications from being redirected to multiple departments. "All departments should be integrated into a unified system to ensure timely disposal of applications. If a department fails to act within the stipulated time frame, deemed approval should be granted," he said.He directed the implementation of the Single Window Act, enabling the Industrial Development Department to provide consolidated approvals for major investments. He said that every investor is important, and ensuring their convenience and security is the government's responsibility.

He emphasised the need to maximise the role of Udyami Mitras in this effort and make the Nivesh Sarathi portal more effective. He also directed the formation of a 'Chasing Cell' under Invest UP, comprising experts from various industrial sectors, to identify high-potential sectors, facilitate communication and ensure better coordination. Yogi said that investors from across the country and the world are eager to invest in UP. "To strengthen the state's global outreach, he emphasised the importance of establishing coordination with Indian embassies abroad," he said. He directed that the half-yearly meeting of the Invest UP Governing Body must be held regularly. In the review meeting, he directed that new policies be introduced for emerging sectors to ensure UP capitalises on the evolving global industrial landscape.

Centre files caveat in SC ahead of hearing on Waqf Act amendments

New Delhi, Apr 8 (UNI) The central government has filed a caveat before the Supreme Court in anticipation of legal challenges to the Waqf Amendment Act, 2025.

The caveat is a procedural move aimed at preventing the Court from passing any ex-parte orders allegedly bypassing proper consultation with state Waqf Boards and other stakeholders. The amendments in question reportedly include provisions that broaden the powers of the Central Waqf Council.

Curtail certain rights of individuals and organizations

The Court's had allowed the filing of petitions. As many as seven petitions challenging the Waqf Act Amendments Bill have been filed. More are coming up.

The initial response and the Centre's yet-to-be-filed which will be crucial in shaping the legal trajectory of the case, which may have far-reaching consequences for the administration of waqf properties across India.

The court was informed that Madras High

New Delhi, April 8 (UNI) : Growth in investments in Udyam-registered MSMEs slowed down to 23% in (UNI): The Supreme financial year 2023-24 (FY24) from 61% in financial year Court on Tuesday upheld 2021-22, as per a UGRO Capital-Dun & Bradstreet report released on Tuesday. Medium-sized firms have scaled back optimism on capital expenditure, while small businesses show slight improvement," it said. As per the report, credit growth has declined for micro and small businesses (15.5% in May 2024 to 10.1% in Nov 2024), remained stable for large businesses, and surged for medium-sized firms (12.6% in June 2024 to 20.0% in Nov 2024)."We see moderation in total loan disbursement in recent quarters, a trend reflecting more conservative lending practices across the industry. While this could be attributed to stricter risk assessments, it also presents an opportunity for NBFCs to play a more strategic role in bridging the credit gap. The increasing formalisation of MSMEs, as evidenced by lower cash percentages and improved debt-to-turnover ratios, especially among mature and larger businesses, is an encouraging sign," said ShachindraNath, Founder & Managing Director – UGRO Capital.

personal gain. A bench, comprising Justices Sudhanshu Dhulia and K Vinod Chandran, was hearing a special leave petition (SLP) challenging the quashing of the FIR filed in 2021 under Section 5(2)of the Jammu and Kashmir Prevention of Corruption

The appellant was represented by Advocate-on-Record Pashupathi Nath Razdan, while Advocate Nonu Khera appeared for the respondent.

The JKCHC had acquired land in 1989 for Rs 31,500 and developed several residential blocks, which were allotted to members on a "first come, first served" basis.

In 2021, an FIR (first information report) was registered, alleging that the landowners (through their power of attorney holders), in collusion with a Tehsildar and Brij Bhushan, managed to obtain a fard Intikhab (land ownership document), which facilitated the transfer of the land to JKCHC.

It was further alleged that this transaction conferred undue benefits to the corporation and its members.

Brij Bhushan, however, moved a petition under Section 482 of the CrPC, seeking quashing of the FIR, which was allowed by the High Court.

The Apex Court noted that the High Court had considered Section 29 of the J&K Agrarian Reforms Act, which provides protection for actions taken in good faith.

However, the Bench clarified, "We will not go into whether criminal proceedings would lie under the

> Prevention of Corruption Act and the Indian Penal Code as against the officers, since they are not before us."

> indemnity under Section 29 would only apply if the act was genuinely done in good faith, and that question must be independently determined if those officers are prosecuted.

US tariffs: India's tech hardware sector likely to gain over China, Vietnam

With China facing a 34 per cent US tariff and Vietnam 46 per cent, India's relatively lower tariff of 27 per cent may shift supply chain dynamics, helping the domestic tech hardware sector grow further, according to a new report.

India's electronics manufacturing, especially smartphones, are set to gain a competitive edge as the US imposes tariffs on electronics imports from key countries, says a CLSA report.

The shift in the global supply chain could favour India, particularly in the smartphone manufacturing segment, it added.

Smartphones account for \$51 billion worth of imports for the US, with China, Vietnam and India being key sources, according to the global broakrage.

Apple and Samsung already have robust manufacturing operations in India.

India's lower tariff, combined with its large domestic market and increasing backward integration supported by the production-linked incentive (PLI) scheme, enhances its cost competitiveness.

Dixon Technologies is likely to be a key beneficiary of this shift in the global supply chain dynamics.

While Apple and Samsung's assembly operations are either in-house or with companies not listed in India, Dixon's role in the supply chain is expected to grow, said CLSA.

SC slams 'moral policing' by courts Court had concluded

New Delhi, April 8 (UNI): In a significant ruling reinforcing the limits of judicial discretion, the Supreme Court on Tuesday set aside the Rs 10 lakh costs imposed by the Punjab and Harvana High Court on musician Vishal Dadlani and political commentator Tehseen Poonawalla over their 2016 tweets mocking Jain

Bhuyan, delivered the judgment while hearing an appeal filed by

Poonawalla challenging the 2019 High Court order. The High Court had

quashed the criminal proceedings against both individuals but went on to impose substantial costs on them, reasoning that such a penalty was needed to discourage similar acts in the future.

"It would be appropriate to impose the costs of Rs 10 lakh each... so that in future they may not mock at any head of a religious sect, just to gain publicity on social media," the High Court had said.

The top court strongly criticized this reasoning, remarking, "No notice is served. What kind of order is this? The court should not go on moral policing. This is not the function of the court at all."

According to other reports, the expected direct impact of US reciprocal tariffs would vary in nature for the sectors in India. The impact is expected to be largely neutral for electronics, textiles, agricultural products, chemicals, and automobiles and parts.

In electronics, higher reciprocal tariffs on China would mean a neutral impact for India's electronics exports, said the report by CareEdge Ratings.

Meanwhile, the recently-announced Rs 22,919 crore Electronics Component Manufacturing Scheme (ECMS), which has the potential to generate nearly 1 lakh direct jobs and several indirect jobs, focuses on the local production of sub-assemblies and bare components like inductors, resistors, PCBs and capacitors, etc.

The scheme envisages to attract investment of Rs 59,350 crore, result in production of Rs 4,56,500 crore and generate additional direct employment of 91,600 people and many indirect jobs as well during its tenure.

There has been five times increase in production over 10 years (17 per cent CAGR) to reach Rs 9.5 lakh crore in 2024, while 25 lakh jobs have been generated. There has also been six times increase in exports (43 per cent CAGR) to Rs 2.4 lakh crore in 2024. Electronics items are now among India's top three export items.

Hospitals Conducts Largest Study Using Artificial Intelligence



KIMS Hospital, Minister Road, has conducted Its largest-ever AI-driven study on pulmonary tuberculosis (TB) detection using chest

X-rays (CXRs). A total of 16,675 CXRs of adult patients were analyzed retrospectively using an advanced AI tool, qXR, without direct clinician intervention.

The study focused on two key objectives: evaluating the diagnostic accuracy of AI in TB detection and assessing its agreement with radiologists.

The findings indicate that AI technology is highly effective in identifying TB cases, with an impressive sensitivity rate of 88.7%. Sensitivity refers to the tool's ability to correctly detect TB-positive cases, demonstrating that AI can play a crucial role in early diagnosis. Additionally, the

study reported a high Negative Predictive Value (NPV) of 97%, confirming the AI's strong reliability in correctly ruling out non-TB cases.

The specificity of the AI tool stood at 69.1%, which, while moderate, remains within an acceptable range for screening purposes. These results align with the minimum criteria set by the World Health Organization (WHO) for TB screening.

One of the most significant aspects of the study was the agreement level between AI-driven assessments and expert radiologists' interpretations. The findings revealed substantial concurrence, highlighting AI's potential in enhancing accuracy and efficiency in clinical diagnosis. This is particularly significant given the global burden of TB and the challenges associated with its timely detection through traditional radiography.

Dr. Latha Sarma, Head of Department and Senior Consultant Pulmonologist KIMS Hospitals, at expressed optimism about the study's impact. "The ability of AI to assist in TB detection with such high accuracy is a gamechanger, especially in resource-limited settings where expert radiologists may not always be available."

Dr. Chaithanya Isamalla, Consultant Senior Radiologist at KIMS, emphasized the role of AI in augmenting radiological diagnostics.

"While AI does not replace human expertise, it serves as a highly reliable tool for preliminary screenings, allowing clinicians to focus on complex cases requiring deeper evaluation."

Christ the Redeemer

But you can climb the 220 stairs or get the elevator, if you want to get close enough to whisper in his ear. I was lucky enough to be in Rio when he got struck by lightning in February-naturally he survived intact-need I say more.





Copacabana Beach

A magnificent confluence of land and sea, the long, scalloped beach of Copacabana always has a flurry of activity stretching its length—footballers sing their team's anthem, cariocas (Rio's residents) and tourists line up for caipirinhas-a popular local cocktail-at kiosks, and beach vendors make their way through the mass of bronzed bodies. The rocky outcrop at its south end, called Arpoador, is popular with the city's surfing community and is one of the best spots in the city for watching the sunset. The beach is lined from one end to the other with tourist-class and luxury hotels. casinos, indoor and outdoor restaurants, bars and nightclubs. There are historic forts at both ends of the beach—Fort Copacabana, built in 1914 at the south end and Fort Duque de Caxias built in 1779 at the north end.



Recurring concussions force **Priyansh slams ton as PBKS post 219** Will Pucovski to retire

Melbourne, April 8 (UNI) : Australian batsman Will Pucovski on Tuesday announced his retirement from professional cricket, following a recommendation from a panel of medical experts.

The 27-year-old's decision brings an end to a career marked by repeated concussions, which ultimately curtailed his promising journey at the top level.

The right-hander suffered several head knocks throughout his career, with the most recent incident occurring in March 2024 during a Sheffield Shield match. Pucovski was forced to retire hurt after being struck on the helmet, ruling him out for the remainder of the Australian summer and prompting him to withdraw from a contract with Leicestershire ahead of the 2024 English season.Confirming his decision in an interview published on ICC website, Pucovski said, "I'm not going to be playing cricket again. It's been a really difficult year to put it as simply as possible.""I'd need a few hours, I think, to take you through the whole journey \dots but the simple message is I won't be playing cricket at any level again," he added.

Pucovski, who played a solitary Test for Australia against India at Sydney during the 2020-21 series, made scores of 62 and 10 in that appearance. Despite the brief stint at the international level, he earned wide praise for his technique and temperament.A gifted top-order batsman, Pucovski featured in 36 first-class matches, amassing 2,350 runs at an average of 45.19, including seven centuries. However, recurring head injuries severely disrupted his career, leading a medical panel last year to advise retirement in the interest of his long-term health.

Joining Iyer on the prestigious shortlist are New Zealand duo Jacob Duffy and Rachin Ravindra — both instrumental in guiding the Black Caps to the final of the marquee tournament.

Pacer Jacob Duffy lit up March with 13 wickets in New Zealand's 4-1 T20I series triumph over Pakistan, including career-best figures of 4/14. His dominance in the shortest format saw him rise to the No. 1 spot in the ICC Men's T20I bowling rankings. He ended the month with 15 wickets across six matches, making a compelling case for the award.

All-rounder Rachin Ravindra too had a standout month, contributing 151 runs in three ODIs at a brisk strike rate of 106.33. His knock of 108 against South Africa in the semifinal was the highest individual score of the Champions Trophy.


