Home Minister inaugurates police station building

Eluru, July 23 (UNI) Home Minister V Anitha, flanked by IGP GVG Ashok Kumar and MLA Balaraju, inaugurated the newly constructed police station building in Polavaram today.

Modi embarks on four-day visit to UK, Maldives to bolster bilateral ties

New Delhi, July 23 (UNI) : Prime Minister Narendra Modi today embarked on his four-day visit to the United Kingdom and the Maldives, expressing hope that the tour will bolster economic growth and deepen bilateral ties.

“Leaving for UK, a country with which our Comprehensive Strategic Partnership has achieved significant momentum in the last few years. I look forward to my talks with PM Keir Starmer and my meeting with His Majesty King Charles III,” Modi said in his departure comments on X.

He said that with the UK, “our collaboration spans a wide range of sectors, including trade, investment, technology, innovation, defence, education, research, sustainability, health, and people-to-people ties.”

Modi is scheduled to hold discussions with his British counterpart, Prime

Minister Rt Hon Sir Keir Starmer, with a focus on enhancing economic cooperation. “During my meeting with Prime Minister Starmer, we will have the opportunity to further enhance our economic partnership, aimed at fostering prosperity, growth, and job creation in both countries,” Modi stated.

He is also expected to have an audience with His Majesty King Charles III during the visit.

Following the engagements in London, Modi will proceed to Male at the invitation of Maldivian President Dr. Mohamed Muizzu, to participate in events commemorating the 60th anniversary of the Maldives’ Independence.

“Day after tomorrow, 25th July, I will be in the Maldives at the invitation of the President Dr. Mohamed Muizzu. I am honoured to be

taking part in the 60th Independence Day celebrations of the Maldives. This year we also mark 60 years of India-Maldives diplomatic relations. The talks with President Muizzu will certainly add momentum to bilateral ties across diverse sectors,” Modi wrote on X.

He added that he looks forward to his meetings with President Muizzu and other members of the Maldivian leadership to advance the shared vision of a Comprehensive Economic and Maritime Security Partnership. The visit, he said, would also serve to reinforce India’s commitment to peace, prosperity, and stability in the Indian Ocean Region.

“I am confident that the visit will yield tangible outcomes, benefiting our people and advancing our Neighbourhood First Policy,” said the PM.

With PM visit on anvil, Stalin says will restore grand lake built by emperor Rajendra

Chennai, July 23 (UNI) A pillar of victory erected by the great emperor Rajendra Chola to commemorate his successful military expedition of the Gangetic plains, lying in ruins in Ariyalur district, will be restored to its pristine glory and enhance irrigation, Chief Minister MK Stalin announced on Wednesday.

With Prime Minister Narendra Modi expected to participate in the 1000th birth anniversary of the monarch, whose rule extended up to the Gangetic plains in the north to present-day Indonesia in the far east, at Gangaikonda Cholapuram, lying 250 km south of Chennai, and release a commemorative coin on July 27, the ruling DMK can’t allow saffron appropriation of the valiant Tamil king.

The birth anniversary of Rajendra-I, son of emperor Raja Raja Chola, falls on the star Thiruvaaithirai in the Tamil month of Aadi and it is

celebrated at the Brihadeeswara temple in Gangaikonda Cholapuram, a replica of the Thanjavur Big temple, a marvel in granite. The nondescript town, close to Neyveli town, was once a bustling capital of the Chola dynasty for over 250 years.

Besides erecting the temple, which stands majestic even today, Rajendra constructed the lake, christening it ‘Chola Gangam’ (Ganges of the Cholas).The restoration of the lake, which originally stretched to 17 miles, has now shrunk to 17 km and remains dry for most parts of the year since the channels bringing water from river Kollidam, which branches off from Cauvery, now possess only traces of them.South Indian historian KA Nilakanta Sastri, citing the Tiruvallangadu copper plates and other inscriptions, says that emperor Rajendra erected the massive tank, as a “liquid

pillar of victory” in his capital with water from the Ganges. During his regnal years (1012-1044), he possessed a formidable navy and the Bay of Bengal remained the Chola’s captive zone.In a post on ‘X’, Stalin extolling the greatness of emperor Rajendra, who has the honorifics ‘Gangai Kondan’ (who won the Gangetic plains) and ‘Kadaram Kondan’ (annexing Indonesia), wrote “I am very happy to announce the restoration of Chola Gangam and its water resource development along with developing the place as a tourist attraction. It was the DMK government which declared Aadi Thiruvathirai, the birth anniversary of Rajendra, as a government function in 2021. Further, I had laid the foundation stone for a museum to display the pre-eminence of the Chola history and their expansive maritime trade. It is coming up exquisitely.”

Elections are stolen in India, this is a reality, alleges Rahul

New Delhi, July 23 (UNI) : Leader of Opposition in the Lok Sabha, Rahul Gandhi today reiterated his allegation that elections in India were being “stolen”, calling it a “reality”.

Talking to reporters during the INDIA protest against the Special Intensive Revision (SIR) of electoral rolls in Bihar, outside in the Parliament complex, Gandhi claimed that his party had found out how the BJP manipulated the voter lists in Karnataka during the Lok Sabha elections.Claiming that the Congress party has done some research in Karnataka, Gandhi said, “The party carried out deep and detailed study, choosing one constituency to find out how the BJP was stealing the elections”.He said that it took six months for the party and eventually everything came out in “black and white”.Gandhi again accused the BJP of

“stealing the elections in Maharashtra with the support of the Election Commission of India”.“Nearly one crore voters were added to the electoral rolls within a span of a few months in the state between the Lok Sabha and the Vidhan Sabha elections,” Gandhi alleged.Accusing the Election Commission of colluding with the BJP, he stated that when the Congress requested machine-readable, digital copies of the voter lists, the Commission declined.

He further alleged that when the party demanded video recordings, the rules were altered.Gandhi alleged that having realised that its “game plan of stealing the elections had been exposed”, the BJP had now taken a different route in Bihar by getting voters deleted from the electoral rolls in order to prepare a new voter list that suits its interests.

Annual pass facility for private vehicles at NH Toll plazas from Aug 15

Chennai, July 23 (UNI) : In a move that could be seen as a great boom to frequent travellers, the Union Road Transport and Highways Ministry will implement the Annual pass facility for private vehicles at NH Toll plazas across the country from August 15.

With the amendment to the National Highways Fee (Determination of Rates and Collection) Rules, 2008, issued by the Union Ministry of Road Transport and Highways vide Notification dated June 17, 2025, frequent travellers on National Highways will have a great boom from August 15, 2025 when the proposed Annual Pass facility for private Car/Van/Jeep will come into force.

With the payment of Rs.3,000 private Car/Van/Jeep can pass through the designated Fee Plazas on National Highways and National Expressways for one year or 200 trips (whichever is earlier), without per-trip user-free charges, an official release said.With the introduction of the new Annual Pass Policy, the regular/frequent travellers will be immensely benefitted, both saving in the user-free charges and ease of recharge of FASTag. For example, a person who travels from Chennai to Bangalore has to pass through six Fee Plazas and based on the prevailing user-fee rates, he/she has to pay total user-fee of Rs.445. If one undertakes a minimum of one ‘To’ and ‘Fro’ journey in a month, the expected annual expenditure towards user-fee would be Rs.10,680 involving 144 trips (crossing of Fee Plaza).With the Annual Pass, the saving would be a whopping Rs.7,680. Still he/she can undertake additional 56 trips (crossing of Fee Plaza) within the one-year period.

237 Railways projects worth Rs 1,90,333 crore sanctioned in less than 4 years: Vaishnaw

A total of 237 projects (40 new lines, 17 gauge conversion, and 180 doubling) of a total length of 9,703 kms -- costing about Rs 1,90,333 crore -- have been sanctioned across Indian Railways during the last three fiscals and the current financial year (FY26) to date, the Parliament was informed on Wednesday. Railways Minister Ashwini Vaishnaw told the Lok Sabha, in a written reply, that during the last three years (2022-23, 2023-24, 2024-25) and the current FY26, 892 surveys (267 new line, 11 gauge conversion, and 614 doubling) of total length 61,462 km have been sanctioned across Indian Railways.

PM pays tributes to Chandra Shekhar Azad and Lokmanya Bal Gangadhar Tilak

New Delhi, July 23 (UNI) : Prime Minister Narendra Modi today paid tributes to two iconic freedom fighters, Chandra Shekhar Azad and Lokmanya Bal Gangadhar Tilak, on their birth anniversaries, hailing their courage, conviction, and lasting impact on the nation's struggle for independence.

The Prime Minister said that the legacies of Chandra Shekhar Azad and Lokmanya Tilak continue to inspire generations in the country.

In a post on X, PM Modi wrote, “Tributes to Chandra Shekhar Azad on his birth anniversary. He epitomised unparalleled valour and grit. His role in India's quest for freedom is deeply valued and continues to inspire our youth to stand up for what is just, with courage and conviction.”

Paying tribute to Lokmanya Tilak, the Prime Minister said, “He was a pioneering leader who played a vital role in kindling the spirit of India's freedom movement with

unwavering conviction. He was also an outstanding thinker who believed in the power of knowledge and service to others.”

Born in 1856, Tilak was a scholar, mathematician, philosopher and one of the earliest advocates of Swaraj or self-rule. He fearlessly challenged British rule through his writings and launched two influential weeklies, Kesari and The Mahratta. As president of the Indian Home Rule League in 1914, Tilak mobilised nationalistic sentiments across the country.Chandra Shekhar Azad, born in 1906, became involved in the national movement as a teenager, participating in the Non-Cooperation Movement at just 15 years of age. He later became a key figure in the Hindustan Republican Association, which he reorganised after the arrest or death of many of its members. Known for his fierce opposition to British rule, Azad led several revolutionary actions, including the 1925 Kakori train robbery.

Bihar’s 98.01 pc electors covered under SIR: EC

New Delhi, July 23 (UNI) : Election Commission today announced that 98.01 per cent of voters in Bihar have been covered under the ongoing Special Intensive Revision (SIR) exercise.According to an official release issued here, the EC also said that so far as many as 20 lakh deceased voters have been reported, while 28 lakh of them have permanently migrated to other states.

While 7 lakh electors were found to be enrolled in more than one place, 1 lakh of them were marked

untraceable, it said.The poll panel said it has received and digitised 7.17 crore enumeration forms, accounting for 90.89 per cent of the state's voters.

However, 15 lakh forms were not returned.

The EC also said the lists of incorrectly included electors and those who have not returned their enumeration forms were shared on July 20 with 1.5 lakh Booth Level Agents (BLAs) nominated by district presidents of the 12 major political parties in the state, which is scheduled to

Parliament disrupted for third straight day amid Opposition ruckus

New Delhi, July 23 (UNI) : For the third consecutive day today, both Houses of Parliament were adjourned after Opposition members created a ruckus in support of their demands, including demanding withdrawal of the Special Intensive Revision (SIR) of the electoral rolls in Bihar.

As soon as the Lok Sabha resumed at 2 PM, presiding officer Krishna Prasad Tenneti began the proceedings, but the

Opposition members stormed into the well of the House shouting slogans.

Appealing to the protesting members, Tenneti asked them to allow the House to consider the important bill related to the reservation of seats for Scheduled Tribe members in the Goa Legislative Assembly.

He emphasised that since this is a matter concerning tribal communities, all members should cooperate. He also

pointed out that two days had already been wasted due to the ongoing disruptions.He told the protesting Opposition members, “You have come with placards — this is not appropriate. You don’t want to discuss the bill related to the tribes of Goa.”Despite repeated appeals from Tenneti, the commotion continued, prompting him to adjourn the House for the day.

Earlier, due to the Opposition's uproar in the Lok Sabha demanding the

withdrawal of the Special Intensive Revision (SIR) of the electoral rolls in Bihar, the Question Hour and Zero Hour could not be held.

Meanwhile, similar situation was witnessed in the Rajya Sabha.

On the third day of the Monsoon Session, the Opposition continued to create an uproar in the House over the SIR of the Bihar voter list.

Presiding Deputy Chairman Bhubaneswar Kalita, while resuming the

proceedings of the House at 2 PM after the second adjournment, asked the Minister of Ports, Shipping and Waterways, Sarbananda Sonowal, to present the "Carriage of Goods by Sea Bill, 2025" in the House for discussion and passage.

Meanwhile, members of the Opposition parties stood up and gathered near the Chair. They began raising slogans of “Withdraw SIR,” demanding a discussion on SIR of the voter list in

Bihar. Amid the uproar, Sonowal went ahead and introduced the bill.

Kalita asked AIADMK's M Thambidurai to initiate the discussion on the bill. As soon as Thambidurai stood up to speak, Opposition members intensified their sloganeering.The Chair appealed to the members to calm down and return to their seats, but when his appeals had no effect, he adjourned the House for the rest of the day.

Lathi-Charge on Jansuraj workers during assembly march in Patna

Patna, July 23 (UNI) : Police resorted to lathi-charge on workers of the Jansuraj Party marching towards the state assembly under the leadership of political strategist-turned-activist Prashant Kishor here today.

Police sources said here that the protest march, which began from Patna Airport, was trying to move towards the Assembly. However, police stopped the procession at Chitkohra Bridge with heavy barricading and security deployment. Later the police had to restore to mild lathicharge to disperse the mob.

The convoy of Prashant Kishor was blocked at Chitkohra by a massive security cordon following which he could not proceed towards the assembly.

The march was taken out demanding Rs 2 lakh employment assistance for poor families, as promised by the government, which has not been delivered to date,three dismil land to every landless Dalit family which remains unfulfilled and action against rampant corruption in the ongoing land survey process.While talking to the news persons, Kishor said that he had collected signatures from over one crore citizens across Bihar in support of these demands and intended to submit the petition during the ongoing monsoon session of the Bihar Assembly.

Kishor threatened to intensify the movement if the government refused to listen to their demands. He said that Jansuraj will return to the streets with greater force and public support if their demands continue to be ignored.

Meanwhile the protestors alleged that the police resorted to lathi charge on the peaceful march.

Party spokespersons condemned the lathi-charge, calling it a deliberate attempt to suppress public dissent. “Peaceful protest was our constitutional right. Instead of answering people's questions, the government was using batons,” a senior party leader said.

Ahmedabad crash: India working with UK on issue of wrong bodies

New Delhi, July 23 (UNI) Responding to a news report about an alleged mix up in the identification of bodies of two British nationals killed in the Air India flight 171 crash, India today said it is “working closely” with the UK to address the concerns.

Spokesperson of the Ministry of External Affairs, Randhir Jaiswal, responding the Daily Mail’s report, said that that the Indian authorities are working with their UK counterparts.

“We've seen the report and have been working closely with the UK since these concerns were raised. Following the tragic crash, victim identification was carried out by authorities according to established protocols and technical requirements.

All mortal remains were handled with utmost professionalism and dignity. We continue to work with UK authorities to address any related concerns,” the official said in a statement.

Notably, India’s

Nineteen more people on the ground were also killed.

Fifty-two of the killed were British nationals.

On Tuesday, the UK’s Daily Mail newspaper reported that the bodies of two British victims were wrongly identified before being repatriated to the UK.

The news report claimed that relatives of one victim abandoned funeral plans after getting to know that their coffin had the body of an unknown passenger, and not that of their family member.

Similarly in another case, remnants of more than one person killed in the crash were mistakenly kept in the same casket. They were to be separated before being sent, the report claimed.

Drone tech boost for fisheries underway: Govt

New Delhi, July 23 (UNI) : A prototype drone is being developed by ICAR-Central Inland Fisheries Research Institute (ICAR-CIFRI) for transportation of fish and shrimp from production centre to market with a capacity of 70 kg payload under Pradhan Mantri Matsya Sampada (PMMSY), the Government told Rajya Sabha today.

Fisheries Research Institutes under Indian Council of Agricultural Research (ICAR) have initiated research programmes on drones and expanding its uses to collect water samples for analysis from open-water bodies and difficult terrains; distribution of feed and medicines into culture systems; biomass estimation; health monitoring, etc, said Union Minister of State, Ministry of Fisheries, Animal Husbandry and Dairying, George Kurian, in a written reply in Rajya Sabha.

The Department of Fisheries has constituted a technical committee to formulate the Standard Operating Procedure (SoP) on application of drone technology in fisheries and aquaculture, said the Minister.

He further said that innovations and innovative projects/ activities, technology demonstration including startups, incubators and pilot projects is one of the activities under central sector scheme component of PMMSY which also cover extending financial support for promotion of drone technology in fisheries and aquaculture.

AAP slams BJP's ‘hollow claims’ on waterlogging in Delhi

New Delhi, July 23 (UNI) : In a role reversal for the BJP and the Aam Aadmi Party (AAP), the ruling saffron outfit is facing criticism on waterlogging in the national capital, with several leaders from the previous government, including former chief minister Atishi, questioning claims of the present dispensation.

The National Capital Region has been experiencing moderate to heavy rains for the past few days that has caused waterlogging in several areas, leading to massive traffic jams.

The AAP has questioned the Rekha Gupta-led government's planning.

"Chief Minister Rekha

Gupta ji, where is your proper planning? You made big claims in the media about tackling waterlogging, but today, entire Delhi is drowning, and you're relaxing in your grand palace. The public is now swimming on the roads and inviting all BJP leaders to join them for a swim," the AAP said in a statement.

The AAP's comments came as Delhi was lashed by rains that went on for hours today, resulting in waterlogging at many places in the national capital, and disrupting the normal life.Since roads were flooded, and residents posted videos of people swimming on them, the AAP reposted those videos on various social

media platforms, Former Delhi Chief Minister Atishi took a jibe at her successor, "Many congratulations to Chief Minister Rekha Gupta for starting so many swimming pools in Delhi.”

AAP leader Saurabh BhardwaJ, commenting on the flooded roads, said, “free water sports”.

Former AAP corporator Geeta Rawat, posted a video of herself in the middle of a submerged road, and asked where local "reel-making MLA" Ravinder Singh Negi was.

"This is the same NH 24 in Patparganj where you were rowing a boat two years ago. The boat is still rowing today. This means you have failed," she said in the caption.

BNS is a progressive and women friendly law: Govt tells RS

New Delhi, July 23 (UNI) The Government today said the Bharatiya Nyaya Sanhita, 2023 is a progressive and women-friendly law. For the first time, the legislation incorporates comprehensive provisions specifically aimed at protecting women and children from various crimes.

The new law introduces strict punishments, including life imprisonment and death sentences, for serious offences such as gang rape of minors, Minister of State for Home Affairs, Bandi Sanjay Kumar told Rajya Sabha today.

In a written reply, the Minister emphasized that the statute strengthens victim protection by ensuring sensitive and transparent investigation processes. Measures like

recording victim statements through audio-video means, mandating women magistrates to record statements where possible, and providing free medical treatment to victims underscore the government’s commitment to creating a safer and more supportive environment for women and children.

Giving details, he pointed out that recognizing women as adult members of the family eligible to receive legal summons reflects the law’s intent to empower women and ensure their active participation in legal processes.

“The new law imposes life imprisonment or death sentence for gang rape of a girl below the age of 18. Earlier, the punishment varied based on the victim’s age below 12 or 16 years, but now this distinction has

been removed, and gang rape of any woman under 18 is punishable by life imprisonment or death.

"The law also introduces a new offence of sexual intercourse obtained through false promises such as marriage, employment, promotion, or concealment of identity," he added.

Talking about some of the key provisions for women’s protection, the Minister said that Section 143 mandates strict punishments, including life imprisonment, for trafficking offences. Trafficking involving children attracts a minimum 10-year imprisonment, extendable to life, along with fines. The offence of ‘beggary’ as a form of trafficking exploitation is newly recognized and punishable under this section, he added.

ONGC to provide Rs.16 Cr cancer therapy unit to Kakinada GGH

Kakinada, July 23 (UNI) : As part of its CSR initiative, ONGC would supply Rs.16 Crore worth of cancer radiation therapy equipment to Kakinada government general hospital.

Rajya Sabha member Sana Sathish, who hails from Kakinada , has been able to convince the Union Minister for oil and natural gas Hardish Singh during his meeting with him along with Union minister of state for rural development and c o m m u n i c a t i o n s Pemmasani Chandrasekhar in New Delhi today to this effect. Along with Kakinada, the government hospitals of Guntur and Kadapa will also get similar equipments for cancer treatment.

The Camp office of Sana Sathish released the statement to this effect. At the initiative of Sana Sathish, it was agreed that these three radiation equipment costing Rs.16 Crores each would be supplied by the ONGC utilizing its corporate social responsibility(CSR) funds.`

The radiation equipment will diagnose the cancer in the initial stage and help in radiation therapy’ said Sana Sathish while thanking both the Ministers.

New sub-stations being set up to check low voltage problems: Minister

the Suryagarh and Kusum schemes at the field level and the work should be expedited.

The Minister issues orders to the officials to grant agricultural connections to all the farmers who applied.

Speaking to the media after the review meeting, Minister Gottipati Ravikumar said that special measures were taken to resolve the power fluctuations and provide quality power. Special measures were also being taken to check the low-voltage problems, he noted.

“Along with the construction of new substations in the required areas, additional transformers and necessary lines are also being installed,” the Minister highlighted and

issued instructions to the electricity authorities to be ready from now on for the upcoming Godavari Pushkaram to be held in Rajahmundry. He instructed the electricity engineers to complete all works by the beginning of Godavari pushkarams.

“The Naidu headed coalition government, since assuming office, has given 75,000 agriculture power connections across the state which reflects the sincerity of serving better to the farming community. Efforts are put in to recruit additional staff in the electricity department, if needed, to provide power supply without any interruptions,” Minister Ravikumar highlighted.

He vowed to resolve the complaints received from industries and business

organizations on the power supply. He pledged to resolve any flaws or grievances in the administration and in the electricity department, if they are brought to his notice.

Bill on campus discrimination triggers debate

In the buzzing corridors of Karnataka’s Vidhana Soudha, a storm is brewing, one not just of politics, but of memory, identity, and law. At the heart of it is the Karnataka Rohith Vemula (Prevention of Exclusion or Injustice) Bill, 2025, a proposed legislation that claims to fight caste discrimination in higher education, but critics say it might be weaponising tragedy and inviting chaos into classrooms.

The bill, as the name suggests, is wrapped in the memory of Rohith Vemula, the University of Hyderabad scholar whose 2016 suicide note became a chilling indictment of caste-based exclusion. “My birth is my fatal accident,” he had written—a line that seared itself into the nation’s conscience. Yet today, that memory is being reshaped, and some argue, repurposed.

For many, Vemula’s story symbolised the silent struggles of Dalit youth navigating elite academic spaces. For the Congress-led Karnataka government, it now serves as the emblem of a sweeping bill that seeks to criminalise any form of discrimination in colleges and universities—public or private. Offences under the bill are no slap on the wrist: up to three years in prison, hefty fines, institutional penalties, and even loss of government funding.

But here’s the rub. In 2024, Telangana Police quietly closed the case into Vemula’s death, finding no conclusive evidence of caste-based harassment. That hasn’t stopped his name from becoming the banner for what critics call a “legal overreach in the guise of justice.”

So, is this legislation a noble step toward equality—or a cynical rebranding of a complex tragedy?

On paper, the bill seems airtight: fight exclusion, punish casteism, protect the marginalised. But dig deeper, and a maze of complications emerge.

Any form of “direct or indirect” discrimination is now a cognisable and non-bailable offence. Translation: a student or staff member can be arrested without a warrant for an alleged insult, comment, or disagreement—no matter how ambiguous. No bail. No waiting. And it doesn’t stop there. Compensation of up to ₹1 lakh can be claimed before the trial even begins. Not by just the victim, but by parents, siblings, colleagues, or distant relatives. “Imagine a classroom argument being spun into a criminal case by someone who wasn’t even present,” said one senior professor Gangadhar Swamy from Bengaluru. “That’s not justice. That’s fear.” Legal minds are ringing alarm bells. The SC/ST (Prevention of Atrocities) Act, 1989 already exists to punish caste discrimination, and with far greater legal clarity. But this new bill overlaps it, adds more layers, and strips away safeguards.

The most dreaded clause? Personal criminal liability for heads of institutions. If a college fails to act—or is accused of failing to act—the principal or vice-chancellor can face jail time. “It turns administrators into potential convicts,” said expelled BJP MLA Basanagouda Patil Yatnal. “It’s asking us to police every word spoken on campus.”

“The bill has ulterior motives other than for the welfare or to protect the dignity of SC, ST, OBC, and minority students,” Yatnal said. “The act is a tool of the Congress government for caste-based political mobilisation aimed at appeasing the SC, ST, OBC, and its most trusted Muslim vote bank. The act creates a victimhood narrative and is devised with a malicious and mischievous intent of dividing the Hindus. The act is yet another tried and tested strategy of replicating the Divide and Rule of the British,” he stated. Private universities are equally worried. With a single allegation, their government grants could vanish. “No one wants to invest in an institution that could be shut down over a vague complaint,” said Yatnal.

The unintended consequences are already visible in similar attempts elsewhere. Maharashtra’s 2019 Social Boycott Act was praised for its intent but saw a surge of complaints, many later deemed frivolous. Faculty members withdrew from mentoring students of other castes. Group projects dissolved. Campus interactions turned cautious, even cold. In Karnataka, with its even broader provisions, the risks of self-censorship and reverse segregation are real. Instead of building bridges, the fear is this bill might build walls—where caste becomes not something we rise above, but something we constantly tiptoe around.

Even the United Nations has weighed in. Special rapporteur KP Ashwini has urged the Karnataka government to rethink the bill’s vague wording and far-reaching penalties. While applauding the goal of inclusivity, they warned that laws without clarity often hurt the very communities they aim to protect.

Supporters of the bill, however, remain steadfast. “The primary objective of the proposed legislation is to ensure that all students, regardless of caste, class, creed, gender, or nationality, are provided equal access to higher education, as well as to safeguard their dignity and right to fair treatment on campus,” Karnataka Minister HK Patil said.

But critics caution that justice enforced without fairness can become another form of injustice.

As the bill heads to the monsoon session of the Karnataka Assembly, it carries with it the weight of a nation’s conscience—and its contradictions. It dares to ask: can you legislate dignity? Can you criminalise exclusion without stifling expression?

Earlier voters elected govts, now govt choose voters: Tejashwi Yadav

(By IANS Interview) Political temperatures in Bihar are soaring as Leader of Opposition Tejashwi Yadav launched a scathing attack on the Election Commission and the NDA government.

In an exclusive interview with IANS on Wednesday from Patna, Yadav accused the ruling alliance of “manipulating” the ongoing voter verification drive (SIR – Special Intensive Revision) to “eliminate” genuine voters and “subvert” democracy.

He even hinted that the Opposition might consider boycotting the upcoming elections if the situation continues.

Interview excerpts: IANS: There was chaos in the Bihar Assembly today. What triggered it?

Tejashwi Yadav: A very serious issue was being discussed. Bihar is the cradle of democracy, and it’s here that attempts are being made to kill it. NDA members don’t want any debate on the SIR. We had even been granted permission to speak, but Chief Minister Nitish Kumar interrupted midway, so I sat down. When he spoke, it was clear he didn’t even know the discussion was about SIR. He started speaking off-topic. Later, when the Speaker gave us time, NDA ministers kept



interrupting us. They don’t want the truth about SIR to come out.

IANS: Do you believe the Bihar elections are being compromised?

Tejashwi Yadav: It certainly seems that way. The Election Commission hasn’t even held a press conference yet, despite the drive being underway. Earlier, voters chose the government; now, the government is choosing voters. We had no option but to go to court because our questions are being ignored. The EC is only trying to show inflated figures - saying 96 per cent or 98 per cent revision is done - just to respond in the Supreme Court. But the ground reality is very different. This drive is being carried out in a completely fraudulent manner. The Election Commission is acting on the BJP’s directions.

IANS: Are you

considering a boycott of the Bihar elections?

Tejashwi Yadav: That option is certainly on the table. We’ll discuss it within the alliance and also take public opinion. If the BJP wants to contest elections based on a fake list, then just give them an extension and let them run the government. What’s the point of holding elections if they’re rigged? If the entire process is dishonest, then there’s no meaning to democracy.

IANS: Rahul Gandhi has alleged election manipulation in other states too. Do you agree?

Tejashwi Yadav: Absolutely. In one case, 70 voters were registered under the address of a single BJP worker in Bihar. We have proof of such manipulations. Even the Supreme Court had slammed the authorities in the Chandigarh case. These things are

happening everywhere.

IANS: You are demanding a full discussion on SIR in the Monsoon Session. Why is this so important?

Tejashwi Yadav: We are elected representatives, and if our voters’ names are being removed, what purpose do we serve? If we can’t protect our own voters, then what’s the point of the Assembly? The first and foremost discussion must be on this issue.

IANS: The Congress hasn’t made any formal announcement yet on seat sharing or supporting you as the Chief Minister’s face. What’s the status?

Tejashwi Yadav: Everything has been decided internally. We will soon make a joint announcement through a press conference. In the next few days, everything will be clear.

IANS: The NDA keeps

raising the issue of “jungle raj” under your party’s past rule. How do you respond?

Tejashwi Yadav: They have no real issues to talk about, no development roadmap. These are tired leaders with no achievements, only interested in saving their chairs. That’s why they keep going back to “jungle raj.”

IANS: What’s your take on Nitish Kumar’s son Nishant possibly entering politics?

Tejashwi Yadav: If he joins, that’s fine, but it’s a decision for their party to make. Whether Nishant wants to join or Nitish Kumar wants to bring him in - or if someone is stopping him - that only they can say. But let’s be honest, this is Nitish Kumar’s last election, and JD-U is on the verge of collapse. Only time will tell who can revive it.

India’s nuclear power capacity to touch 22,380 MW by 2031-32: Jitendra Singh

New Delhi, July 23 (IANS) India’s installed nuclear power capacity is expected to reach 22,380 MW by the year 2031-32 from 8,780 MW at present, with the completion of the expansion plans that are currently being implemented, the Parliament was informed on Wednesday.

Presently, the installed nuclear power capacity in the country comprises 24 reactors with a total capacity of 8780 MW (excluding RAPS-1 (100 MW) under extended shutdown). In addition, a total capacity of 13,600 MW (including 500 MW PFBR being implemented by BHAVINI) is under different stages of implementation, Minister of State for Atomic Energy Dr Jitendra Singh told the Lok Sabha in a written reply. On the progressive completion of these expansion plans, the country’s installed nuclear power capacity is expected to reach 22,380 MW by the year 2031-32, he said.

India’s nuclear power plants generated 56,681 million units (MUs) of electricity in the financial year 2024-25, which constitutes about 3 per cent of the total electricity generated in the country, the minister said..

Japan’s PM Shigeru Ishiba may resign in End of August

Moscow, July 23 (UNI) : Japan’s embattled Prime Minister Shigeru Ishiba may announce his resignation by the end of August, Japanese newspaper The Mainichi reported today.

The reports came shortly after US President Donald Trump announced that he had reached a “massive Deal” with Japan, and days after Ishiba’s governing coalition lost its majority in the country’s upper house.

Meanwhile, the Yomiuri Shimbun newspaper reported that Ishiba plans to announce his resignation already by the end of July to take responsibility for the ruling coalition's defeat in the recent upper house elections.On Sunday, the Japanese ruling coalition of the Liberal Democratic Party and the Komeito party failed to secure the 50 seats they needed for parliamentary majority in the upper house. The ruling coalition now has 122 of 248 seats, compared to 141 seats before the election. The opposition, on the other hand, has significantly increased its presence in the upper house, now holding 126 seats.After the election, the prime minister said he had no plans to resign, reshape the government or expand the coalition.

Zelenskyy fears probe into his coterie : Reports

Moscow, July 23 (UNI) : Ukrainian President Volodymyr Zelenskyy's hasty signing of the law on restricting anti-corruption bodies may be due to the fact that the National Anti-Corruption Bureau of Ukraine (NABU) has launched an investigation against members of his inner circle, The Economist magazine reported, citing sources.

On Tuesday, the Ukrainian parliament passed a bill that limits the autonomy of the NABU and the Special Anti-Corruption Prosecutor's Office (SAP). Several lawmakers criticized the government for trying to terminate the anti-corruption watchdogs. Later, Zelenskyy signed the bill into law.

The law, aimed at undermining the most influential anti-corruption reforms in Ukraine, casts a shadow on the country's future course, the report said on Tuesday. According to the magazine, the European Union pressured Zelenskyy to pause, stating that the adoption of this law would have a negative impact on negotiations on Ukraine's accession to the EU.

Zelenskyy’s decision has shocked many in his team, the report added.

Ukrainian media reported on Monday that the Security Service of Ukraine (SBU) had conducted searches in the houses of NABU detectives. The NABU later confirmed the searches and stated that they were carried out without a court order.

Ambassadors of the G7 countries expressed serious concern regarding the SBU’s investigation into NABU on Monday, saying they would raise the issue with the Ukrainian government.

Afghan journalists in Iran and Pakistan face dire conditions, warns group

Kabul, July 23 (IANS) Describing their situation as "dire" and "disastrous", the Afghanistan Journalists Support Organisation on Wednesday said that Afghan journalists in Iran and Pakistan continue to face dire conditions, including threats, arrests and denial of basic services.Many of these journalists, Afghan news agency Khaama Press reported, had left Afghanistan as they faced threats, persecution and censorship under Taliban rule. However, they are now facing serious risks to their safety and dignity in the host nations, including forced deportation, arbitrary arrest and lack of basic services.Many Afghan journalists are in legal limbo in Pakistan due to the suspension of visa renewals, making them vulnerable to potential police detention and deportation. Others have said that they face similar difficulties in Iran, where access to essential services is either denied or limited.

The organisation called on international organisations to take urgent action. It requested United Nations, the European Union, Reporters Without Borders, and Western governments to expedite asylum processes and provide immediate support, the news agency reported.

The group's warning comes amid crackdowns on Afghan refugees in Pakistan and Iran, with many journalists also facing dire economic conditions and lack of protection.

They emphasised that global community's silence would only deteriorate the humanitarian crisis. The lives and freedoms of journalists continue to remain at risk without swift intervention.

Earlier in May, The Committee to Protect Journalists, alongside PEN International and 13 partner organisations, urged Pakistan's government to immediately halt the arbitrary mass deportation of Afghan journalists and other nationals at risk of Taliban persecution.

In the statement, the organisations expressed concern over Pakistan’s 'Illegal Foreigners Repatriation Plan' that was announced on October 3, 2023. Local and international bodies, including the Human Rights Commission of Pakistan, the United Nations High Commissioner for Refugees, and the International Organization for Migration, have criticized the Pakistan government's plan and urged the government to uphold its international obligations and continue offering protection to at-risk Afghans.In the joint statement, the organisations urged the international community to provide safe and legal pathways for Afghan journalists, writers, artists, human rights defenders, and other vulnerable individuals seeking refuge from Taliban persecution due to their peaceful expression.

Health advisor slammed for 'closeness' with Yunus, called 'product of nepotism'



Dhaka, July 23 (IANS): The Chief Coordinator of Bangladesh National Citizens Party (NCP), Hasnat Abdullah on Wednesday demanded the resignation of the interim government's health advisor Nurjahan Begum, branding her as a "product of nepotism and favouritism" backed by Chief Advisor Muhammad Yunus.

Addressing a public rally in Chandpur district, the NCP leader stated that the health advisor must resign by returning her salary and allowances.

"We have a health advisor, do you know her? She came in under the 'brotherhood quota' of Yunus. This health advisor is the biggest example of Yunus's nepotism. I have always said that there is no need for this health advisor. Have you seen any meaningful activity from her? The salary she draws is unjustified, and the government vehicle she uses is an insult to the taxpayers. She understands neither healthcare nor the medical system. Her only qualification is his connection to Grameen

Bank and her closeness to Yunus," Bangladesh's Bengali daily 'Jugantor' quoted Hasnat as saying.

"The unfortunate part is that she goes to Singapore for her own treatment. When we speak up about it, they tend to get angry. I once raised the issue, and since then she has stopped talking to us. She should deposit the salary and allowances given to this health advisor in the state treasury and resign immediately," he added.

"Planes are crashing, buildings are collapsing; this is not the Bangladesh we want," Hasnat further said.The remarks came after Monday's horrific plane crash in Dhaka that killed 32 people, mostly children, and injured more than 165.

The newly-formed party formed by student leaders who once collaborated with Yunus to overthrow the democratically-elected Awami League government led by former Prime Minister Sheikh Hasina is now at loggerheads and the much-flaunted unity, which was on full display during the ousting of Hasina, seems to have faded

gradually.

Following the crash of Bangladesh Air Force's Chinese-made F-7 BGI training aircraft on Monday, massive protests took place at the crash site and also outside the Secretariat building in the country's capital as the students demanded the immediate resignation of the Yunus-led interim government's Education Advisor and Education Secretary.The interim government's law and education advisors, along with Yunus's Press Secretary, who visited the institute for a site inspection after the tragic crash, also faced a strong protest from students who demanded their resignations, stating that the information provided by the government related to the crash was inaccurate.

The protestors demanded publication of a correct list of the names of the deceased and those injured, along with the compensation details for the families of the victims.

They also demanded an immediate discontinuation of the use of outdated and unsafe training aircrafts used by the Bangladesh Air Force

Trump announces ‘massive’ trade agreement with Japan

Washington, July 23 (UNI) US President Donald Trump has announced a long-awaited trade agreement with Japan, a framework between allies and major trading partners that appeared elusive just weeks ago.

“We just completed a massive Deal with Japan, perhaps the largest Deal ever made,” Trump said on Truth Social last night.

As part of the deal, US importers will pay 15 percent “reciprocal” tariffs on Japanese goods exported to the United States. Also, Japan will invest US\$550 billion dollars into the United States, the president said.

Trump noted that the US “will receive 90 percent of the profits”, without elaborating on how those investments would work or how profits would be calculated, reported CNN.

“This Deal will create Hundreds of Thousands of Jobs — There has never been anything like it. Perhaps most importantly, Japan will open their Country to Trade including Cars and Trucks, Rice and certain other Agricultural Products, and other things. Japan will pay Reciprocal Tariffs to the United States of 15 percent,” Trump posted.

The Japan agreement was the third such trade-related news Trump announced yesterday. This comes after months of negotiations with key trading partners like the European Union, South Korea, India and dozens of others at a standstill as Trump’s latest August one deadline for higher tariffs looms.

Torrential rainfall, flash floods in Pakistan kill 234 people

Islamabad, July 23 (IANS)As torrential rainfall continues to wreak havoc across Pakistan, at least 234 people have lost their lives, and 596 have been injured since the onset of monsoon in the South Asian nation, local media reported on Wednesday.

According to the latest figures released by the National Disaster Management Authority (NDMA), most of the 596 injuries reported nationwide involved children, women, and elderly persons, highlighting the disproportionate impact of

US to spend USD 253 million at UK’s RAF Lakenheath on facilities supporting nuclear operations

Moscow, July 23 (UNI) : The United States plans to spend USD 253 million on two major construction projects, including a hardened Primary Command Post and a Defender Operations Compound, at the RAF Lakenheath air base in the United Kingdom to support future nuclear missions, a Sputnik correspondent’s analysis of recently released US Air Force’s fiscal year 2026 budget report revealed.

The projects include a USD 104 million Primary Command Post and a \$149 million Defender Operations Compound. They are part of a broader effort to prepare the base for what is known as the Surety mission, which focuses on ensuring the safety, security, and control of nuclear assets. The upgrades are designed to modernize the base's ability to command operations and respond rapidly to potential threats involving specialized weapons.

The construction comes amid multiple media reports this week that US nuclear weapons, specifically B61-12 thermonuclear gravity bombs, have been transferred to a newly constructed secure storage facility at RAF Lakenheath, marking their return to UK soil for the first time since at least 2008. The bombs, reportedly flown from the US Air Force Nuclear Weapons Center in New Mexico, are modernized, low-yield tactical weapons with variable explosive power and precision guidance, compatible with

the F-35A Lightning II aircraft operated by the 48th Fighter Wing's 493rd and 495th Fighter Squadrons at the base.

Although neither the US Department of Defense nor the UK Ministry of Defense has confirmed the reports due to their policy of not commenting on nuclear weapon locations, this development suggests a significant shift in NATO’s nuclear posture in Europe amid heightened tensions with Russia and a renewed emphasis on deterrence.

The new Primary Command Post will replace a facility built in 1979 that no longer meets the demands of current and future missions. The upgraded center will consolidate key operational functions, including crisis response, emergency management, and secure communications. It is also being built to withstand high-altitude electromagnetic threats and meet modern standards for intelligence and communications infrastructure.

According to the budget documents, the existing command post lacks adequate space, modern equipment, and secure access. Without the upgrade, officials say the base would not be able to support an expanded nuclear role in Europe. Construction is expected to be completed by July 2031.

The second project, known as the Defender Operations Compound, is aimed at strengthening protections for potential nuclear assets at the base.

the relentless rain on the country's vulnerable groups.

The devastating impact of rainfall and flash floods has damaged 826 homes in the country. In addition, a rain-induced disaster claimed the lives of two men, two women, and eight children over the past 24 hours on Tuesday, while ten others were wounded.

Pakistan's Punjab province has been the worst affected with a devastating death toll of 135, which included 48 men, 24 women, and 63 children, while 470 sustained injuries.The high number of

child casualties reflected the severe impact of the recent downpours on young lives, the leading Pakistani newspaper, The Express Tribune, reported.

Additionally, Khyber-Pakhtunkhwa (K-P) province recorded 56 deaths, comprising 16 men, 10 women, and 30 children. Another 71 individuals have been injured in the province due to devastating monsoon rain.

Meanwhile, in the Swat region of the K-P province, five children lost their lives in separate rain-related incidents.

Polish PM unveils major cabinet reshuffle to streamline govt

Warsaw, July 23 (IANS) Polish Prime Minister Donald Tusk announced a sweeping government reshuffle on Wednesday, which includes the creation of two new ministries and a significant reduction in the size of the Council of Ministers. Under the reorganisation, a new Ministry of Finance and Economy will be established, to be headed by current Finance Minister Andrzej Domanski. A separate Ministry of Energy will also be formed, with Milosz Motyka, currently deputy minister of climate and environment, appointed as its

leader.Wojciech Balczun will take the helm of the Ministry of State Assets, while Stefan Krajewski, deputy minister of agriculture and rural development, will be promoted to lead the Ministry of Agriculture.Two existing ministries, the Ministry of Development and Technology, and the Ministry of Industry, will be dissolved as part of the restructuring.

Tusk said the reshuffle aims to improve efficiency and streamline the executive branch, Xinhua News Agency reported. "We will go from having one of the largest governments in Europe to one of the smallest in terms of structure," he said.

Hyderabad, July 23 (UNI) : The meeting of the Telangana State Council of Ministers will be held under the chairmanship of Chief Minister A Revanth Reddy on July 25.

According to an official statement issued here on today, the cabinet meeting will take place at 1600 hours in the Cabinet Meeting Hall, 6th Floor, Dr B R Ambedkar Telangana Secretariat.Key administrative and policy matters are expected to be discussed during the meeting.

Cyberabad police recover 827 stolen and lost phones worth Rs 2 cr

Hyderabad, July 23 (UNI) : In a major achievement, the Cyberabad Central Crime Station (CCS) has successfully recovered 827 stolen and lost mobile phones worth approximately Rs 2 crore under the 8th phase of its recovery operation.

The initiative was led by DCP Crimes A. Muthyam Reddy, with coordination across all five CCS zones.

The phones were recovered over the last 45 days using the Central Equipment Identity Register (CEIR) portal and were formally handed over to their rightful owners at a ceremony held at the Cyberabad Police Auditorium on Wednesday.

Zone-wise, the recoveries included-- Madhapur CCS – 180 phones, Balanagar CCS – 174 phones, Medchal CCS – 176 phones, Rajendranagar CCS – 153 phones and Shamshabad CCS – 144 phones

DCP Muthyam Reddy urged the public to promptly report lost or stolen phones at the nearest police station or via the CEIR portal, stressing the value these devices often hold both personally and in terms of data.Since the beginning of this initiative, Cyberabad Police have recovered and returned 6,233 mobile phones in eight phases. Citizens were also advised to stay alert against cyber frauds and report suspicious activities via the 1930 cybercrime helpline or cybercrime.gov.in.Beneficiaries expressed heartfelt gratitude, with many citing emotional and practical value attached to their recovered devices.

Govt completes pilot survey in 5 villages without maps: Minister

EOW police arrest one accused in major cheating case involving Rs 6 crore investment fraud

Hyderabad, July 23 (UNI) : The Economic Offences Wing (EOW), Cyberabad, has arrested one accused in a high-profile cheating case involving Rs 6 crore investment fraud under the guise of high returns here today.

The accused involved the collection of public deposits under false promises of high returns.

A case was registered following a complaint received from Talakokula Akhil, a 25-year-old private employee from Chandanagar, Hyderabad.

Based on credible intelligence, a police team

apprehended Nikhil Kumar Goel from his residence at Mothinagar, in the city, said A. Muthyam Reddy, Deputy Commissioner of Police, (Crimes) EOW, Cyberabad, in a release here.During the interrogation, the accused voluntarily confessed to his role in the fraudulent investment scheme and confessed to having collected around Rs 6 crore from around 50-60 clients.

The accused also revealed that the idea was initially proposed in 2017 by his associate Cyrus Hormusji and together, they executed an agreement titled “TURNKEY &

C O N S U L T A N C Y MANAGEMENT” in 2018 and began collecting funds.Nikhil Kumar, who previously worked at Wells Fargo, lured investors by misrepresenting Fibwave Analytics as a legally compliant investment firm.

The accused handed over his mobile phone used in the scam, which has been seized as evidence.Efforts to trace and apprehend Cyrus Hormusji, who is currently absconding, are ongoing. The case is being investigated by B.Somnarayan Singh, Asst. Commissioner of Police, Economic Offences Wing, Cyberabad.

Congress leaders involved in urea black marketing, alleges BJP Chief Ramchander Rao

(Standard Post Bureau) Hyderabad, July 23 : Telangana BJP President N Ramchander Rao today accused Congress leaders of engaging in black marketing of urea that was supplied by the central government for the benefit of farmers in the state.

Addressing party workers from the Makthal Assembly constituency of Narayanpet district at the BJP state headquarters here, Rao alleged that the Congress government in the state has been creating an artificial scarcity of urea despite receiving excess supplies from the Centre.

"Local body elections are approaching. It is the responsibility of our cadre to expose the misdeeds of the state Congress government, particularly its

failure in ensuring proper distribution of urea," he said.The BJP chief questioned the rationale behind the alleged shortage, pointing out that the Modi government had supplied over 12 lakh metric tonnes of urea to Telangana, even though the Revanth Reddy-led government had sought only 9.5 lakh metric tonnes.

"Why are farmers still lining up at fertiliser shops? Who is responsible for the black marketing? The state government owes an answer," he remarked.

Calling it "unfortunate," he said even regions like Makthal, known for cotton cultivation, are facing supply issues due to the negligence of the Congress government."Farmers are suffering because the state

administration has failed to deliver fertilisers to where they are needed," he said.

Rao urged party workers to stay vigilant and actively campaign from the ward level up to ZPTC level in the upcoming local body polls.

Hyderabad, July 23 (UNI) : Telangana has reached a new milestone in the preservation of its cultural and tribal heritage with the filing of its 27th Geographical Indication (GI) application.

Two traditional art forms from Nalgonda-Banjara Tribal Jewellery and Banjara Needle Craft - have been submitted for GI status by GI practitioner Subhajit Saha, marking a landmark step in recognising the craftsmanship of the Banjara (Lambada) community.Filed under application numbers 1597 and 1598 on behalf of The Devarakonda Banjara and Tribal Artisans Multipurpose Mutually Aided Cooperative Society Limited, and supported by the Commissionerate of Industries, Government of Telangana, the move underscores the growing institutional support for GI-based rural and tribal empowerment.With this, Telangana's GI tally has climbed to 27, with four more products in advanced stages of application. Nalgonda district now leads the state with four GI filings, emerging as the most active GI zone in Telangana.Previous GI entries from the state include Jagtial Sesame, Kollapur Benishan Mango, Warangal Rangasaipet Brassware, Mahadevpur Tussar Silk, and local produce like Nalgonda Nimma (lemon) and Nalgonda Dosakai (cucumber).The Nalgonda Banjara Tribal Jewellery, practised for over a century in villages like Kondabheemanapally and Devarakonda, is known for its striking use of silver, old coins, German silver, and distinctive ghoonguria bells that produce melodious chimes.

Meanwhile, the Nalgonda Banjara Needle Craft features over 20 types of intricate embroidery stitches, mirror work, coins, beads, cowrie shells, and geometric patterns rooted in local tradition.Subhajit Saha is also spearheading efforts to secure Authorised User (AU) registrations for other Telangana GI products like Hyderabad Lac Bangles and Cheriyal Paintings, enhancing the recognition and benefit-sharing framework for artisans. “Each stitch and shimmer tells a story — and now, those stories will be protected,” said Subhajit Saha, emphasising the state’s continued push to document and legally safeguard its cultural assets.

Hyderabad, July 23 (IANS) : CID has arrested two more accused, including the prime accused, in the inter-state human organ trafficking case. Pamulapati Pavan Kumar and Pradeep Kumar Gupta have been arrested in the case relating to inter-state human organ trafficking under the guise of organ donation and transplantaion.

Pavan Kumar, a native of Tadepalligudem in Andhra Pradesh, was apprehended at LB Nagar in Hyderabad, while Gupta, a resident of Haryana, was arrested at Chandigarh.

Both were produced before a magistrate in Hyderabad for judicial remand, Additional Director General of Police, CID, Charu Sinha, said.

With the arrest of the two accused, the number of accused arrested in the case so far has gone up to 19.According to the CID, Pavan Kumar is the prime accused in the case, and in connivance with other accused, Dr Rajashekar and Dr Avinash and other doctors, had arranged donors and recipients for illegal kidney transplantation surgeries done at Alakananda, Janani, and Aruna Hospitals in Hyderabad.

Pavan Kumar had set up brokers in Tamil Nadu who would trace, identify the innocent poor people for donating their kidneys. He also set up brokers, namely Pradeep Kumar in Bengaluru and Gupta in Haryana who would identify patients in need of kidneys and could afford to pay huge amount for their kidney transplantations.

In each kidney transplantation, he used to take Rs 10 to 15 lakh as commission and lead a lavish life by spending the money on purchasing luxury cars and visiting casinos in Sri Lanka.

Athletic Bilbao signs right back Areso from Osasuna for second time

Madrid, July 23 (UNI) Right back Jesus Areso completed a return to Athletic Bilbao when he joined the club from Osasuna for the second time in his career.

Areso joins for a fee close to his 12-million-euro (14 million US dollars) release clause and has signed a six-year contract until the end of June 2031, with Athletic holding off interest from Atletico Madrid.

The transfer marks the 26-year-old's second move from Osasuna to Athletic Bilbao, following his initial transfer in 2017, when Athletic paid 450,000 euros for his services.

He spent three seasons in the club's B-team making 55 appearances, but rejected offers of a new contract to return to Osasuna in 2021 and after overcoming a serious leg injury, he has been first choice for the Pamplona-based club in the last two seasons, making 76 appearances in La Liga.

A rapid and powerful attacking right back, Areso replaces Oscar de Marcos, who retired at the end of last season after a record 572 appearances for the club. Athletic is also thought to be close to a deal to re-sign Spain international Aymeric Laporte from Saudi Arabian side Al-Nassr as the club prepares to return to the Champions League next season after last season's fourth place finish in La Liga.

NCSSR conducts meeting on ethical standards in sports science research

New Delhi, July 23 (UNI) The National Centre for Sports Science and Research (NCSSR), today said that it convened the inaugural meeting of its Institutional Ethical Committee (IEC) on July 18, 2025 here at the SAI Head Office, Jawaharlal Nehru Stadium.

This landmark session marked a significant milestone in formalizing ethical practices for scientific research involving human participants in the field of sports and allied sciences.

Chaired by Prof. Jugal Kishore, Director Professor and Former Head of Community Medicine at Vardhman Mahavir Medical College & Safdarjung Hospital, the meeting brought together distinguished committee members from premier institutes and government bodies. Discussions focused on standardising ethical protocols for research approvals, safeguarding participant welfare, and ensuring scientific integrity across all NCSSR research initiatives.

"The establishment of the IEC represents our firm commitment to upholding the highest standards of ethics in sports science research. This committee will play a pivotal role in ensuring transparency, accountability, and participant protection in all scientific endeavours under NCSSR," said Vishnu Kant Tiwari, Secretary (SAI).

Serving as the Member Secretary, Brig (Dr.) Bibhu Kalyan Nayak, Director of NCSSR, emphasized the need for robust ethical oversight as the centre embarks on multiple interdisciplinary research projects. "Our vision is not just to advance sports science but to do so responsibly and ethically," he said. "The deliberations of this first meeting will serve as a foundation for all future work." During the session, the committee reviewed procedures for research project submission, evaluation, and monitoring, while also discussing legal and ethical considerations specific to studies involving athletes and human subjects. Key concerns included informed consent, data protection, and the long-term impact of research on athletes' health and performance.

"Ethical scrutiny is essential in research involving human subjects, especially in sports science where both physical and psychological factors are at play," noted Prof. Jugal Kishore. "Our role as an ethical committee is not to hinder research but to ensure it is conducted with dignity, care, and accountability." The IEC's mandate will be instrumental in ensuring all NCSSR projects comply with national and international ethical guidelines. The committee reaffirmed its collective responsibility to foster a culture of ethical excellence and scientific rigour.

The announcement came shortly after the club confirmed it had missed out on signing Jesus Areso from Osasuna, with Areso opting to join Athletic Bilbao for a similar fee.

The defender will have his medical tests in Madrid today, before joining with his new teammates in their summer training camp at Los Angeles de San Rafael to the north of Madrid. Pubill's arrival could pave the way for Argentine international Nahuel Molina to leave the club, as Atletico must reduce its non-European Union player quota after signing Thiago Almada. The club currently has four non-EU players, but only three are permitted.

Lausanne (Switzerland), July 23 (UNI): After Hockey New Zealand notified the International Hockey Federation (FIH) of their decision not to participate in the next FIH Hockey Pro League Men's season despite having won the FIH Hockey Nations Cup last month, FIH has, in accordance with the regulations, extended an invitation to the Nations Cup runners-up, namely Pakistan, to join the 2025-26 Pro League edition. The Pakistan Hockey Association has been given a deadline of August 12 to inform FIH of their decision to accept or deny the invitation.

The 2024-25 FIH Hockey Pro League crowned both Dutch teams, Women's and Men's, as champions. The upcoming season will be the seventh one of the "League of the Best".

237 Railways projects worth Rs 1,90,333 crore sanctioned in less than 4 years: Vaishnaw

New Delhi, July 23 (IANS) A total of 237 projects (40 new lines, 17 gauge conversion, and 180 doubling) of a total length of 9,703 kms -- costing about Rs 1,90,333 crore -- have been sanctioned across Indian Railways during the last three fiscals and the current financial year (FY26) to date, the Parliament was informed on Wednesday.

Railways Minister Ashwini Vaishnaw told the Lok Sabha, in a written reply, that during the last three years (2022-23, 2023-24, 2024-25) and the current FY26, 892 surveys (267 new line, 11 gauge conversion, and 614 doubling) of total length 61,462 km have been sanctioned across Indian Railways.

While from 2009-2014, the total tracks commissioned

were for 7,599 km (4.2 km per day), a total of 34,428 km tracks were sanctioned (8.57 km per day) from 2014-2025.

"As a result of comprehensive planning of Railway projects under PM Gati Shakti National Master Plan and better coordination among various stakeholders, the sanction of service, sanction of projects and the pace of laying/commissioning of new tracks have also increased," the minister said. The PM Gati Shakti Institutional mechanism is being extensively used for ground surveys, land records, alignment of route and has led to enhancement in the quality of preparation of the Detailed Project Report and reduction in project cost.

The Indian Railway launched the Amrit Bharat Station

scheme aimed at providing world-class amenities to passengers and improving efficiency in train operations at railway stations. So far, 1,337 stations have been taken up for redevelopment in the Amrit Bharat Station Scheme, according to the minister. To enhance passenger experience and provide a comfortable journey, the state-of-the-art Vande Bharat trains, Amrit Bharat Trains and Namoo Bharat Rapid Rail with modern features have been introduced on Indian Railways. "To improve safety in train operations, Kavach has been developed as a National Automatic Train Protection (ATP) system on Indian Railways. The work of implementation of Kavach has been taken up in mission mode on Indian Railways," said the minister.

Collective effort of Centre, RBI brings PSB NPAs down to 2.58 pc: Economist

New Delhi, July 23 (IANS) The significant reduction in gross non-performing assets (NPAs) of India's public sector banks (PSBs) is a result of combined efforts of the Reserve Bank of India (RBI) and the union government, a leading economist said on Wednesday.

Economist Pankaj Jaiswal told IANS that the improvement in NPAs had been made possible due to the joint initiative of the RBI and the Centre.

According to him, the two were complementary to one another and collaborated closely to achieve the same objective. Jaiswal noted that gross non-performing assets (NPAs) had decreased to 2.58 per cent in 2025, citing a statement by Minister of State for Finance Pankaj Chaudhary. He called this a significant accomplishment for the central government.

He discussed the role of the Insolvency and Bankruptcy Code (IBC) and said that 10 years ago, there was a widespread culture of evergreening, many industrial sector accounts were under stress, and NPAs were much higher.

Imphal, July 23 (Waari Singbul Network) : Thiyam, a towering figure in Indian theatre whose spellbinding visual aesthetic and philosophical depth transformed the stage into sacred ritual, passed away this morning at the age of 77. The legendary Manipuri playwright, director, and cultural thinker breathed his last at RIMS Hospital in Imphal after prolonged post-COVID and related health complications.

The solemn gathering, open to the public, was organised to offer the film community's final respects to Ratan Thiyam—not just a titan of theatre, but one of the finest artists Manipur has ever produced. "Though his medium was theatre, his influence transcended disciplines—deeply inspiring Manipuri cinema, visual storytelling, and the state's broader cultural imagination.

The glowing candles, lit in reverence, will stand as flickers of the enduring legacy he leaves behind," said MSFDS Secretary Sunzu Bachaspatimayum. A true son of Manipur and one of the world's finest theatre directors, Thiyam leaves behind a body of work that reshaped the contours of Indian performance. His passing marks the end of an era—but his vision, steeped in ancient Indian wisdom and tuned to the cries of a fractured modernity, will continue to illuminate stages across the world. Born on January 20, 1948 in Nabadwip, West Bengal, and raised in Imphal, Ratan Thiyam's life was rooted in Manipur's cultural soil but reached far beyond its borders.

A graduate of the National School of Drama (1974), Thiyam returned to Imphal to establish the Chorus Repertory Theatre in 1976—planting a seed that grew into a global institution. Under his direction, the Chorus stage became an altar where dance, martial arts, poetry, and ritual fused into unforgettable dramatic experiences. With landmark productions such as Chakravayuha, Uttar Priyadarshi, Urubhangam, Antigone, and When We Dead Awaken, Thiyam forged a new idiom of "theatre of roots"—a movement that reclaimed traditional Indian forms and made them vessels for contemporary critique. His theatre was austere yet spectacular, meditative yet urgent, drawing from Vaishnavism, Meitei culture, and classical texts to address social injustice, war, identity, and spiritual longing. His legacy was not only artistic but deeply political. Thiyam returned his Padma Shri in 2001 to protest threats to Manipur's territorial integrity, and in recent years, stood against the Government of India's silence over the ethnic conflict that has scarred the state. For Thiyam, Manipur was not merely home—it was an ideal of co-existence, a cultural ark where many voices must sing in harmony. Accolades trailed him throughout his life: the Sangeet Natak Akademi Award, the Fringe Firsts Award at Edinburgh, the Kalidas Samman, the Rockefeller Award, and most recently, a Lifetime Achievement Award conferred by the Government of Manipur in 2024.
