PM welcomes Trump's as peace efforts in Gaza make decisive progress

New Delhi, Oct 4 (UNI) : Prime Minister Narendra Modi today welcomed the leadership of US President Donald Trump as peace efforts in Gaza make decisive progress and said the indications of the release of hostages represent a significant step forward in the ongoing humanitarian and diplomatic efforts.

The Prime Minister reaffirmed that India remains steadfast in its commitment to supporting all initiatives that contribute to a durable and just peace in the region. “We welcome President Trump’s leadership as peace efforts in Gaza make decisive progress. Indications of the release of hostages mark a significant step forward. India will continue to strongly support all efforts towards a durable and just peace,” The Prime Minister posted on X.

The Prime Minister's tweet came Hamas said it had accepted some elements of President Trump's peace plan and was willing to release the hostages and hand over power to other Palestinians. President Trump also asked Israel to stop bombing Gaza.

Telangana youth shot dead in Dallas, US

Hyderabad, Oct 4 (UNI) : A 28-year-old Telangana youth was reportedly shot dead by robbers in Dallas, US, on Friday.

The man, Pole Chandrasekhar, a resident of LB Nagar, had gone to Dallas for higher studies after completing his Bachelor of Dental Surgery (BDS) course in Hyderabad. He was also working at a petrol station in Dallas.

Sharing on ‘X’ today, former Minister and BRS MLA T. Harish Rao, who visited his family, said, “It is tragic that Chandra Shekhar Pole, a Dalit student from LB Nagar who completed BDS and went to America (Dallas) for higher studies, died in a shooting carried out by miscreants early yesterday morning.”

He added: “The pain that the parents are going through, knowing that their son, who they believed would reach great heights, is no more, is heart-wrenching to witness.” “My deepest condolences to their family members,” Rao said.

16 injured, six hospitalised after boiling starch spills at Visakhapatnam

Visakhapatnam, Oct 4 (UNI) : Sixteen people, including six children, suffered burn injuries after boiling starch spilled over them at Jalaripeta here today.

Police said that a community meal (annadana prasadam lunch) had been organised for devotees on the occasion of the conclusion of the Dussehra festival.

The incident occurred at the Durga Devi mandapam when rice was being cooked in a giant vessel. The boiling starch spilled onto the people standing around the vessel. The injured persons were immediately shifted to the KG Hospital. Six of the injured were admitted to the hospital and are currently undergoing treatment. The remaining 10 people were treated for their injuries and later discharged.

MLA Vamshi Krishna and NTR Vaidya Seva Trust Chairman Sitamraju Sudhakar visited the injured at the hospital.

E-crop kharif can be registered till October-end in AP: Director, Dilli Rao

Vijayawada, Oct 4 (UNI) Andhra Pradesh State Agriculture department Director Dilli Rao has announced that farmers who have not registered their e-crop kharif 2025 can do so till October-end.

In a statement here today, Director of Agriculture Dilli Rao stated that due to certain field-level challenges during the current kharif 2025 season, the E-Crop Digital Survey has not progressed as expected.

Out of 290 lakh land parcels, only 88 lakh (36%) have been registered so far.

At the Rythu Seva Kendras (RSKs), agriculture assistants are registering farmer-wise details of all crops, agriculture, horticulture, sericulture, social forestry, as well as fallow lands.

As per Centre's directives, 100% of land parcels must be registered under E-Crop Digital Survey from the kharif 2025 season onwards.

Rationalisation and transfers of village secretariat, the Rythu Seva Kendra staff, at the start of the season, with many new staff are facing difficulties in survey number identification. As part of the extended action plan, all cultivated fields and uncultivated fallow lands must be registered in E-Crop by October-end 2025.

The Director stressed that the E-Crop Digital Survey data will act as the single base platform for all farmer welfare and development schemes. Therefore, collectors have been specially requested to deploy additional staff wherever required, ensure inter-departmental coordination, strengthen supervision, and complete registrations within the extended deadline.

Our Govt. fulfilled all assurances, committed to welfare of poor : CM

Vijayawada, Oct 4 :Chief Minister N Chandrababu Naidu today reaffirmed his commitment to implementing all welfare schemes as assured and announced launching of an App especially for auto rickshaw drivers.

Lunching the ‘Auto Driverla Sevalo’ scheme the Chief Minister credited Rs 15,000 each into the account of 2,90,669 eligible auto rickshaw drivers across the State.

Addressing a public meeting, the Chief Minister said the Government had spent Rs 436 crore to implement the Auto Driverla Sevalo scheme for the welfare of auto rickshaw drivers. He promised to launch an App especially for



auto drivers. The APP will help auto rickshaw drivers so that they do not have to wait at auto stands for customers.

The Chief Minister also

assured setting up an Auto Drivers Welfare Board and promised to extend all support to Auto rickshaw, maxi cab and cab drivers. He made it clear that plans are

being formulated to replace auto rickshaws with e-auto rickshaws in a phased manner in the coming days. The Chief Minister appealed to the Auto rickshaw drivers to speak positively about his government.

Mr. Naidu highlighted that the Government made over 23,000 kilometers of roads pothole free after coming to power. He said the Government is implementing a universal health insurance scheme and providing free medical treatment to the eligible poor. Deputy Chief Minister K Pawan Kalyan, IT Minister Nara Lokesh and BJP State president PNS Madhav also spoke.

Earlier, Chief Minister N Chandrababu Naidu, Deputy Chief Minister K Pawan Kalyan and IT Minister N Lokesh travelled in auto rickshaws from Undavalli camp office to Payakapuram to reach the venue.

Naidu, Pawan, Lokesh have deceived auto rickshaw drivers: Ex-Minister, Nani

Vijayawada, Oct 4 (UNI) Former Minister and YSRCP Krishna District President Pemi Venkataramaiah (Nani) slammed Chief Minister Chandrababu Naidu, Deputy Chief Minister K Pawan Kalyan and IT Minister Nara Lokesh, declaring that what they celebrated as “Drivers’ Service Day” is in fact “Drivers’ Betrayal Day.”

The former Minister ridiculed that the TDP and JSP leaders staged a khaki-shirt drama, while ignoring their pre-poll promises. “Naidu pledged free RTC bus travel for every Aadhaar-linked woman, yet after one year in power it was implemented only with severe restrictions, reduced buses, curtailed long routes, and limited coverage. Women were dissatisfied, and auto drivers lost livelihoods. Their protests forced today’s gimmick,” he charged.

Stating that Mr. Naidu boasted that Rs 436 crore was given to 2,90,669 drivers, the former Minister said: “Lokesh himself said there were 13 lakh drivers two years ago. Today there should be at least 15 lakh. Why is help restricted to 2.90 lakh? Where is the Drivers’ Welfare Board, insurance, education loans, 5% interest subsidy on loans, or the Rs 15,000 annual support promised to badge-holding auto, taxi, lorry, and tipper drivers? Why deny aid if challans are pending or if autos are in family members’ names? This is deception, not service.”

By contrast, he recalled that the then Chief Minister during the previous regime, Y S Jagan Mohan Reddy introduced Vahana Mitra after hearing auto drivers’ plight during his padyatra in Machilipatnam. He promised Rs 10,000 annually and kept his word for five consecutive years: 2,36,344

beneficiaries in Year 1; 2,74,476 in Year 2; 2,56,646 in Year 3; 2,61,516 in Year 4; and 2,75,931 in Year 5. “Support was unconditional, even for family-registered autos or drivers with challans. We implemented every word of our 2019 manifesto,” the YSRCP senior leader noted.

The Ex-Minister reminded that Lokesh once accused YSRCP of giving only to 10% of drivers, promising welfare boards, accident and health insurance, subsidised e-autos, and facilities like charging points and toilets at stands.

Ridiculing Naidu’s promise of launching an App and setting up a control room, Venkatramiah said: “This is not a festival, it is betrayal. Just as he betrayed NTR, today he betrayed drivers.” He challenged Naidu, Pawan, and Lokesh to ride in an auto rickshaw across Krishna district roads.

Pralhad Joshi Reviews Railway Projects with SWR General Manager at Rail Soudha

Mumbai, Oct 4 : Mr Pralhad Joshi, Minister of Consumer Affairs, Food and Public Distribution and New & Renewable Energy of India, chaired a review meeting of ongoing and proposed railway projects with Shri Mukul Saran Mathur, General Manager, South Western Railway at Rail Soudha, Hubballi, today.

The meeting was attended by Shri Mahesh Tenginakai, Hon'ble MLA Hubballi Central; Smt. Jyothi Patil, Hon'ble Mayor Hubballi-Dharwad; Shri Rudresh Gali, Commissioner Hubballi-Dharwad; Shri Vijay Kumar, Assistant Commissioner; Smt. Bela Meena, DRM Hubballi; officials of KIADB from State Government; and Principal Heads of Departments (PHoDs) and officers of SWR.

During the review, the Hon'ble Minister assessed the progress of key projects in Karnataka including the Hubballi-Ankola new line, Tumkur-Chitradurga new line, Dharwad-Belgaum new line, Bagalkot-Kudachi line, Gadag-Wadi line, and the ongoing works on Road Over Bridges (ROBs) and Road Under Bridges (RUBs).

He was also apprised of the Gadag-Yalvigi new line DPR, which is to be submitted to the Railway Board by December 2025.



The Minister further reviewed the redevelopment of Hubballi station at an estimated cost of Rs 397 crore, along with details of the DPR for the Hubballi-Ankola new line project estimated at Rs 17,000 crore.

Minister took stock of SWR's achievements in new-line construction, doubling, and progress of ROB/RUB works during 2025. Shri Joshi emphasized the need for speedy

execution of railway developmental works and assured full support from the Central Government in resolving any bottlenecks. Additionally, the Minister examined progress under the Amrit Bharat Station Scheme (ABSS) at Alnavar (Rs 17.2 crore), Badami (Rs 15.1 crore), Koppal (Rs 21.14 crore), and Bantwal (Rs 26.18 crore).

The Hon'ble Minister

reiterated the Government's commitment to fulfill proposals that benefit the public and directed that works be completed within stipulated timelines.

General Manager Shri Mukul Saran Mathur assured that the Minister's guidance will be acted upon in earnest and reaffirmed SWR's commitment to ensuring timely completion of developmental projects for the benefit of Karnataka and the region.

En route, Trains will have stoppages at Londa, Alnavar, Dharwad, SSS Hubballi, SMM Haveri, Harihar, Davangere, Birur, Arsikere, Tumakuru and Chikbanavar.

The train will run with a composition of 22 coaches, consisting of 20 Sleeper Class Coaches, 02 Second Class Cum Luggage & Brake Van & Disabled Friendly Compartment.

PM hails ‘Swasth Nari, Sashakt Parivar’ for transforming women’s health

New Delhi, Oct 4 (UNI) : Prime Minister Narendra Modi today praised the tireless efforts of those working at the grassroots level to make the nationwide ‘Swasth Nari, Sashakt Parivar Abhiyan’ (Healthy Woman, Empowered Family Campaign) — focused on the health of women and children — a success, calling it an excellent example of public participation. The Prime Minister emphasized that such collective initiatives are key to improving lives and building a healthy and empowered society.

Responding to a social media post by union Health and Family Welfare Minister Jagat Prakash Nadda, Modi appreciated the efforts of those involved in the campaign and said it is a classic example of public participation aimed at bettering lives.

In his social media post, he said, “Commendable efforts! Congratulations to all those who worked tirelessly at the grassroots level to make this campaign so impactful and beneficial for our women power. This is a remarkable example of public participation towards improving lives.”

Nadda, in his post, stated that the Prime Minister had launched the two-week-long ‘Swasth Nari, Sashakt Parivar Abhiyan’ on September 17, which concluded on October 2. During this period, around 18 lakh health camps were organised, examining 6.5 crore women.

He noted that this extraordinary achievement reflects the nation’s collective resolve to emphasise women’s health for strong families and prosperous communities.

He added, “Let us continue this momentum by encouraging every woman to prioritise her health, get regular health check-ups, and move towards a healthy and empowered future.”

Under this initiative, jointly led by the Ministry of Health and Family Welfare and the Ministry of Women and Child Development, millions of health camps were organised across the country at Ayushman Arogya Kendras, Community Health Centres (CHCs), district hospitals, and other government health facilities.

The Health Ministry had said yesterday more than 1,780 million citizens were screened for hypertension and 1.72 crore for diabetes during the campaign. More than 37 lakh women were screened for breast cancer, and over 19 lakh for cervical cancer. Oral cancer screening covered more than 69 lakh people.

More than 62.60 lakh antenatal check-ups were also conducted, while more than 1.43 crore children received life-saving vaccines. Besides, more than 1.51 crore were screened for anaemia, over 85 lakh for tuberculosis and 10.23 lakh for Sickle Cell Disease, the Ministry said.

Pune, Oct 4 (UNI) : The message of compassion rang across Pune as students of the Sadhu Vaswani group of institutions stepped out on October 3 and 4.

Uddhav's man Anil Parab hits back at Shinde Sena's Ramdas Kadam

Mumbai, Oct 4 (UNI) : Uddhav Thackeray-led Shiv Sena leader Anil Parab today hit back against Eknath Shinde-headed Shiv Sena leader Ramdas Kadam's recent sensational allegations here about late Shiv Sena founder Balasaheb Thackeray's last moments.

Kadam alleged yesterday that Uddhav Thackeray had kept the corpse of his father and Shiv Sena founder Bal Thackeray at his Bandra East 'Matoshree' residence, for two days after he passed away and his fingerprints were taken.

"Ramdas Kadam behaved despicably at the Dussehra gathering by raising questions about the death of our god, Balasaheb Thackeray. So I will respond. In 1993, Ramdas Kadam's wife, Jyoti Kadam, set herself on fire. Did she burn herself or not? To know whether she burnt herself or if she was burnt by somebody else, a narco test must be conducted on Ramdas Kadam. His son Yogesh Kadam is the Minister of State for Home Affairs. An inquiry should be conducted into his father Ramdas Kadam's business dealings," Anil Parab said.

"I know what Balasaheb Thackeray's will is. I know the details in the will because I was responsible for getting it done. Moreover, I know whose signatures are on it, whose fingerprints are on it. Even if you take the fingerprints of a dead person, it is of no

use. I am telling you this clearly. Ramdas Kadam's knowledge is crude. These allegations have been made to poison the minds of the people against Uddhav Thackeray," Anil Parab said. "When Balasaheb Thackeray passed away, I was given the responsibility to organise everything. I was there at (Balasaheb Thackeray's) Bandra East residence) Matoshree for 24 hours. I was a witness to everything that happened at that time. Now, after 15 years, why did Ramdas Kadam make noise? After Balasaheb Thackeray's death, Ramdas Kadam became a minister, because it was Uddhav Thackeray who made him a minister in 2014," Parab said.

He asked why Kadam did not complain against Uddhav Thackeray at that time and kept his mouth shut for the last several years. "If Uddhav Thackeray was so bad, then why did Ramdas Kadam accept the ministerial post? In 2019, his son Yogesh Kadam became an MLA. So Uddhav Thackeray was good as long as Ramdas Kadam was getting everything from him," he said. Parab said if Kadam had some self-respect, he should have left the party then. "I am still looking for the bench (outside Matoshree) on which Ramdas Kadam slept in 2012. At that time, a team of doctors was there for 24 hours in the room where Balasaheb Thackeray was.

Maharashtra FDA launches statewide festive food safety drive

Mumbai, Oct 4 (UNI) : In a proactive move to safeguard public health during the festive season, the Food and Drug Administration (FDA) of Maharashtra has launched an extensive inspection campaign targeting food adulteration across the state. The campaign, conducted under the initiative ‘Festival of Maharashtra, Commitment to Food Safety’, has already covered 1,594 sweet shops, with 2,369 food samples collected for laboratory testing, according to FDA Minister Narhari Zirwal.

Minister Zirwal stated that the campaign covers a wide range of food products including milk, khoya (condensed milk), ghee, edible oils, sweets, dry fruits, and chocolates.

Of the 554 sample reports received so far, 513 were certified safe, 26 were found substandard, 4 had labeling defects, and 11 samples were deemed unsafe for consumption.

Reports on the remaining 1,815 samples are still pending. According to a statement issued here to bolster enforcement, the FDA has completed the recruitment of over 200 Assistant Commissioners (Food) and Food Safety Officers, posts that had been pending since 2022.

Additionally, a proposal for 750 new posts has been submitted to the Finance Department to enhance regulatory oversight.

Laboratory infrastructure has been significantly upgraded to ensure timely testing.

MBA graduate arrested in Chhatrapati Sambhajinagar narcotics raid, LSD worth Rs 1 lakh recovered

Ch. Sambhajinagar, Oct 4 (UNI) : The spread of narcotic substances from major cities like Mumbai and Pune has now reached Chhatrapati Sambhajinagar, where police arrested an MBA graduate allegedly involved in drug trafficking in the Begumpura area.

The accused, identified as Khadri Maroof Ahmed Shahid Ahmed, was found in possession of LSD, one of the most potent and expensive synthetic drugs.

According to Deputy Commissioner of Police (Crime) Ratnakar Nawale, police recovered ten small pieces of blotting paper imprinted with various pictures, each containing LSD, weighing a total of 0.09 grams and valued at approximately Rs 1 lakh.

He stated that LSD (Lysergic acid diethylamide) is among the most powerful hallucinogenic drugs and is increasingly being consumed by urban youth.

Acting on a tip-off received by the Anti-Narcotics Squad, police laid a trap on the night of October 2 near the Bibi Ka Maqbara area, where a suspect was expected to deliver drugs. The team apprehended the man near the ticket counter and, upon interrogation, identified him as Khadri Maroof Ahmed.

A subsequent search led to the recovery of additional LSD slips from his possession. Preliminary investigation revealed that the accused holds an MBA

degree and had previously worked in Dubai. After returning to India, he settled in Pune, where he reportedly came into contact with members of an international drug syndicate during a party.

He is suspected to have begun trafficking LSD and other narcotics thereafter.

Police seized ten LSD slips and a mobile phone from the accused and registered a case under relevant sections of the Narcotic Drugs and Psychotropic Substances (NDPS) Act. The accused was produced before the First Class Judicial Magistrate, V S Deshmukh, who remanded him to police custody until October 8.

Spurious liquor racket busted in Annamayya district; 10 arrested

Man kills mother after she refuses to give him money for alochol

In a fit of rage, he took an iron rod and hit her on the head. Yelamma, who suffed injuries, died while beig shifted to hospital, the police added.

The police are yet to apprehend the accused.

Manchal police have registered a case and taken up investigation.

Aqua farmers are buoyant as the shrimp exports to Russia

Nellore, Oct 4 (UNI) Aqua farmers in PS Nellore district in the coastal Andhra Pradesh are buoyant as the shrimp exports to Russia from the district has increased 40 per cent, giving a major relief after the tariff hike by the US government.

Nellore district has earned fame for shrimp cultivation in over one lakh acres. It exports the produce to various countries, especially the US. However, the tariff hike on the aqua products imports from India by US President Donald Trump has put the aquaculture in doldrums and the aqua industries stand at crossroads.

However, the farmers under the guidance of their unions are focusing on finding new markets for their shrimp exports and they found the Russian as a suitable alternative to the US market.

Chandrasekhar Reddy, a shrimp exporter, said they have got huge orders from Russia for prawns and other aqua products. During the last two months, aqua exports to Russia from Nellore district have increased to 40 per cent from a mere 10 per cent. The huge orders from Russia for prawns have raised hopes of aqua farmers of the district. The Nellore aqua industry is receiving orders from Europe giving a fillip to aqua exports.

Aqua farmer Surendra said they used to raise shrimp in about one lakh acres in Nellore district. However it has reduced to 50,000 acres now after US President Donald Trump's decision to hike tariffs on Indian aqua products. The aqua farmers used to raise scampi and tiger varieties of prawns three decades ago. The farmers have been raising the Vannamei variety shrimp since 2009 which has high demand in various countries.

Surendra said the aquaculture has faced hurdles in various forms in the last five years, including rising input costs and weak returns. Many aqua farmers, unable to face the volatile situation have leased out their fish ponds. However, since aqua products exports have started increasing, the farmers hope for a rapid recovery. An industries department official said that there are eight shrimp processing units in PS Nellore district and over 600 employees work in each unit. Aqua product exporter S Narasimha Rao said they had started exporting shrimp to Russia, and if they receive orders from Europe too, the aquaculture sector in Nellore district would thrive again.

BJP panel to decide candidate for upcoming Jubilee Hills by-election

Hyderabad, Oct 4 (UNI) : With the notification for the Jubilee Hills by-election expected anytime following publication of the final electoral roll of the constituency on Sept 30, BJP state chief N Ramchander Rao appointed a three-man committee to decide the candidate for the upcoming by-election.

The committee members are: former MLA M Dharma Rao, former MP A. Pothaganti Rmulu and the party's senior leader Advocate Komala Anjaneyulu, said B Umashanker, state office secretary in a release on Saturday.

The committee will collect opinions from leaders to decide the candidate for the upcoming by-election of Jubilee hills Assembly constituency.

The main opposition Bharat Rashtra Samithi (BRS) had already announced Maganti Sunitha as its candidate. The by-poll was necessitated by the death of her husband, Maganti Gopinath, who was the sitting MLA. The ruling Congress is yet to announce its candidate.

TGSRTC decides to hike city bus fares in Hyd from Oct 6

Hyerabad, Oct 4 (UNI): The Telangana State Road Transport Corporation (TGSRTC) today announced to increase city bus fare ranging between Rs 5 and Rs 10 on city

services, effective from October 6 to cover the infrastructure costs of electric buses here. The corporation will collect the additional charge on all buses

operating within Hyderabad and Secunderabad. On city ordinary, metro express, e-ordinary and e-express buses, the company will levy an extra

Rs. 5 for the first three stages and Rs. 10 from the fourth stage onward.

On metro deluxe and e-metro AC services, it will charge an additional Rs. 5 for the first stage and Rs. 10 from the second stage onward.

The state government, which decided to introduce a pollution-free public transport system in Hyderabad, directed the Corporation to use environmentally friendly electric buses to reduce air pollution that makes city residents ill and to curb traffic problems, the Corporation said in a release here.

It has decided introduce 2,800 electric buses by replacing diesel buses within the ORR area of Hyderabad by 2027. This decision is a promising sign for steering the city's public transport system toward a clean and green

direction. If 2,800 new electric buses are put into full operation, private vehicle purchases will decrease and public transport ridership will increase.

As a result, emissions from vehicles will fall. Urban residents will suffer less from respiratory and heart problems, and people's life expectancy will improve.

Following state government orders, the TGSRTC management, which already taken steps to procure 2,800 new electric buses, drawn up a plan to gradually introduce the electric buses into service over the next two years. Infrastructure suitable for electric buses is being put in place, the corporation said that out of 25 depots in Greater Hyderabad, 6 depots operate 265 electric buses, and another 275 electric buses will be made available this year.

For Gaza, a chance to return from destruction to reconstruction

Hamas’s cautious acceptance of United States President Donald Trump’s proposal for a solution may have cracked open a diplomatic door long sealed by warfare and mistrust. This was perhaps the window that the countries mediating a ceasefire in Gaza were waiting for.Negotiators from Egypt, Qatar, Turkey, and the United States can now be expected to shuttle between Hamas officials (mainly perhaps) in Doha and Jerusalem to iron out a ceasefire implementation.Under Trump’s 20-point blueprint, an immediate ceasefire would accompany the release of living hostages, followed by the return of remains of those deceased, in exchange for hundreds of Palestinians held by Israel in detention facilities outside Gaza.

While Hamas has accepted elements such as the release of hostages and the handover of Gaza’s administration, it has reportedly rejected disarmament demands and any permanent surrender of arms.

According to information available, an official statement -- released through the group’s Telegram channel -- has confirmed readiness to release all Israeli hostages, and bodies of those deceased. It has also abided by handing over the administration of the Gaza Strip to a technocratic Palestinian body supported by Arab and Islamic states. However, the group is said to have refused to lay down its weapons or disarm unconditionally, or allow foreign forces to oversee Gaza, or remove Hamas fighters from Palestinian territory.

These caveats underscore Hamas’s insistence on maintaining its role as a political and military actor in Gaza. Thus, negotiators will also need to grapple with the question of Gaza’s governance.

Trump’s plan envisages a technocratic, apolitical Palestinian committee to run the Strip under an international oversight board chaired by the US. Hamas, say reports, insists on a purely Palestinian administration endorsed by national consensus and backed by Arab and Islamic states.But Israel’s Prime Minister Benjamin Netanyahu has repeatedly and unequivocally ruled out the establishment of a Palestinian state west of the Jordan River, which he reiterated in his recent address at the United Nations General Assembly (UNGA) in New York.Both he and Trump have condemned nations granting recognition to a Palestinian state, saying that the recognition of Palestine as a state without going down strongly on the Hamas organisation serves as a reward for it. Even as the leaders were delivering their respective statements at the UNGA, 156 of the 193 UN member-countries had officially recognised the state of Palestine. Meanwhile, legislative elections are scheduled to be held in Israel by October 2026, where Netanyahu’s governing coalition includes far-right parties that stand rigidly against any concessions toward a “two-state solution”.

In fact, some of his cabinet members have demanded the full annexation of the West Bank, making any move toward a sovereign Palestinian state politically untenable for Netanyahu. Disagreements over such and other issues remain the primary objective in the path to a comprehensive peace.

Yet, when the ground reality in Gaza remains grim, this moment of conditional optimism offers a fleeting chance to return from destruction to reconstruction.

Pain is a signal that the brain processes, and if the brain is engaged in other activities, the pain is no longer perceived. This is a simple, accessible method for everyone. I thank Dr. Bhaskar Rao, the CMD of KIMS Hospitals, Dr. Abhinay, the CEO, and others for their support in introducing this technology. If this technology becomes widespread, even rural areas will be able to easily manage pain during treatments. For example, patients undergoing chemotherapy often have

TRAI releases Recommendations on “Formulating a Digital Radio Broadcast Policy for private Radio broadcasters”

The Telecom Regulatory Authority of India (TRAI) has today released its Recommendations on “Formulating a Digital Radio Broadcast Policy for private Radio broadcasters” along with terms and conditions and reserve price for commencement of digital radio broadcasting service in four ‘A+’ category cities viz., Delhi, Mumbai, Kolkata and Chennai; and nine ‘A’ category cities viz., Hyderabad, Bengaluru, Ahmedabad, Surat, Pune, Jaipur, Lucknow, Kanpur and Nagpur.

2. Ministry of Information and Broadcasting (MIB) vide its reference dated 23rd April 2024 had sought recommendations of TRAI under section 11 (1)(a)(i) of the TRAI Act, 1997 on formulating a digital radio broadcast policy for private Radio broadcasters.

3. In this regard, a consultation paper was issued on 30th September 2024 seeking stakeholders’ comments on various issues relating to formulation of digital radio broadcast policy for private radio broadcasters. 43 comments and 13 counter-comments were received on the consultation paper, which are available on TRAI’s website. Subsequently, an Open House Discussion was held on 8th January 2025.

4. After considering all comments/counter-comments received and further analysis of the issues, the Authority has finalized its recommendations. The

salient features of the recommendations are as below:

a) The digital radio services should be commenced in Simulcast mode by new broadcasters. The existing analog FM Radio broadcasters should also be permitted to migrate to simulcast mode on voluntary basis.

b) The proposed simulcast mode will enable them to broadcast one analog, three digital and one data channel on the assigned spot frequency.

c) A single digital radio technology standard should be adopted in India for introduction of digital radio broadcasting in VHF Band II.

d) The Government should select a suitable Digital Radio Technology for deployment in India either by holding consultations with main stakeholders, that is, the radio broadcasters and the radio receiver manufacturers; or by incorporating selection of technology in the spectrum auction process; or any other method considered suitable by the government.

e) The government should prepare the frequency planning in single technology scenario for each of the four cities of category ‘A+’ and nine cities of category ‘A’ and place in public domain.

f) The frequency for new channels should be assigned by way of auction in accordance with Section 4(4) of the Telecommunication Act, 2023.

g) Immediately after the successful assignment of frequency through auction for digital radio broadcasting, an offer should be made to the existing FM Radio broadcasters to migrate to simulcast mode on voluntary basis.

h) A time limit of 6 months from the date of conclusion of auction process should be given to the existing broadcasters to exercise the option to migrate to simulcast mode.

i) For migration to simulcast mode, existing FM radio broadcasters will be required to pay an amount equal to the difference of auction determined price for digital radio broadcasting in a city and the proportionate amount of Non-refundable One Time Entry Fee (NOTEF) for the remaining period of the existing permission.

j) Radio broadcasters should commence simulcast operations within two years of conclusion of auction process or acceptance of option for migration.

k) The sunset date for the analog broadcasting should be decided after evaluating the progress of digital radio broadcasting at a later date.

l) Government should introduce a new authorisation for ‘Radio Broadcasting Infrastructure Provider’ for provision of active and passive digital infrastructure which can be leased to radio broadcasters. However, this will not be a pre-requisite for introduction of digital radio services.

m) The Government should issue an advisory regarding availability of

digital radio receivers in mobile phones and car infotainment systems, similar to the advisory issued by the Ministry of Electronics and Information Technology (MeitY) for availability of FM Radio receivers in mobile phones.

n) The private terrestrial radio broadcasters should be allowed to stream their live terrestrial channels concurrently, without user control.

o) To oversee and monitor the development and proliferation of digital radio receivers and market dynamics, the Ministry of Information and Broadcasting (MIB) should constitute a high-level steering committee comprising of senior representatives from the MIB, Ministry of Electronics and Information Technology (MeitY), radio broadcasters, device manufacturers, and the technology provider.

p) Eligibility conditions (including the minimum net worth criteria) for digital radio broadcasting service authorisation should be same as as provided in TRAI’s recommendations on ‘Framework for Service Authorisations for provision of Broadcasting Services under the Telecommunications Act, 2023’ issued on 21st February 2025.

q) Period of authorisation for digital radio broadcasting should be 15 years.

r) Definition of Gross Revenue as mentioned in the Policy Guidelines for Phase-III of private FM radio, notified by MIB on 25.07.2011 has been retained.

s) Revenue from streaming of a radio channel should be included in the definition of GR, if streaming is being provided by the radio broadcaster.

t) The Authorisation fee should be levied on Adjusted GR on similar lines as in Telecommunication authorisations.

u) Applicable Gross Revenue (ApGR) should be equal to the total Gross Revenue (GR) of the licensee as reduced by the revenue items not directly related to radio broadcasting services.

v) Adjusted Gross Revenue (AGR) shall be arrived at after deducting any GST paid

w) Annual/ Authorisation Fee shall be: (i) 4% of AGR for cities of category ‘A+’, ‘A’, ‘B’, ‘C’, and ‘D’.

(ii) For cities of ‘Others’ category (in border and hilly areas of NE, J&K, Ladakh & Island Territory) and ‘E’ Category – 2% of AGR for initial period of 3 years, thereafter same as above.

x) An Authorised entity should not be allowed to own more than 40% of the total spot frequencies in a city subject to a minimum of three different operators in the city. y) Two new spot frequencies for digital radio broadcasting in each city out of total spot frequencies identified by MIB in category A+ and A cities should be auctioned at this stage. Auction of remaining frequencies in these cities to be considered after reviewing outcome of this round and the progress of

development and proliferation of receiver device ecosystem. The definition of spot frequency for digital radio has been provided.

z) Choice of genres on multiple radio channels of an entity in a city should be left to the market forces.

aa) The Central Government should notify separate Programme Code and Advertisement Code for Terrestrial Radio Services.

bb) In case of non-operationalisation of services within a period of 24 months, frequency assignment should be withdrawn, and the entity should be debarred from allotment of another spot frequency in the same city for a period of five years from the date of such withdrawal.

cc) Prasar Bharati should share its land and tower infrastructure (LTI) as well as common transmission infrastructure (CTI) with private broadcasters at concessional rental rates while taking full recovery of operational expenses.

dd) The condition for mandatory co-location of transmission infrastructure should be removed, and the authorised entities of Terrestrial Radio Service should be allowed to share infrastructure, on voluntary basis with the entities of broadcasting services, telecom services, infrastructure providers etc. as per technical and commercial feasibility.

ee) Reserve prices for auction of spectrum required for simulcast by new radio broadcasters in 13 cities of category ‘A+’ and ‘A’ should be as follows:

Two killed in shooting in Nice

Nice, Oct 4 (UNI/SPUTNIK) Two persons were killed and five others were wounded in a shooting in Nice that was linked to drug trafficking, local authorities said.The shooting occurred in the Les Moulins neighborhood in Nice last night.

"A shooting took place this evening in Nice in the Moulins district. Two died, 2 were seriously injured and 3 others more lightly. Law enforcement and firefighters are on site and have secured the perimeter. Laurent Hottiaux, Prefect of the Alpes-Maritimes, is on site and strongly condemns this despicable act," the Alpes-Maritimes department said in a statement on X.

The statement added that reinforcements will be mobilized today to ensure the return of security to the Les Moulins district and "will remain as long as necessary."

Mayor of Nice Christian Paul Gilbert Estrosi said, as quoted by BFMTV yesterday, that the shooting occurred when "an incursion against a backdrop of drug gangs led to automatic weapon fire."

An investigation is underway.

UN chief appoints special representative for children and armed conflict

United Nations, Oct. 4 (UNI) : UN Secretary-General Antonio Guterres on Friday appointed Vanessa Frazier of Malta as his special representative for children and armed conflict.Frazier succeeds Virginia Gamba of Argentina, to whom the secretary-general is "grateful for her dedicated service and commitment to the United Nations," according to a press release.

Frazier holds a doctorate honoris causa in humane letters from Luther College in the U.S. state of Iowa and a master's degree in diplomatic studies with major in international law from the University of Malta. She is fluent in Maltese, English and Italian.

The mandate was created by the UN General Assembly in December 1996 to strengthen the protection of children affected by armed conflict, raise awareness, promote the collection of information about the plight of children affected by war and foster international cooperation to improve their protection.

China issues orange alert for Typhoon Matmo

Beijing, Oct. 4 (UNI) : China's national observatory on Saturday issued an orange alert, the second-highest in its four-tier system, for Typhoon Matmo, the 21st typhoon of the year, as it strengthens and heads toward the country's southern coast.

The typhoon, observed at 18 degrees north latitude and 117.7 degrees east longitude at 5 a.m. on Saturday, is moving northwestward at a speed of 25-30 km per hour, according to the National Meteorological Center (NMC).It is anticipated to make landfall along coastal areas ranging from Dianbai in Guangdong Province to Wanning in Hainan Province, both located in south China, during the daytime on Sunday, the NMC said.

From Saturday morning to Sunday morning, the typhoon is expected to bring strong winds and heavy rain to China's southern coastal regions.

The national observatory has urged local authorities to activate emergency response measures for the typhoon and stay alert for mountain torrents and geological disasters triggered by heavy rainfall.

China has a four-tier, color-coded weather warning system for typhoons, with red representing the most severe warning, followed by orange, yellow and blue.

Meloni calls for Gaza ceasefire, immediate release of hostages

Rome, Oct 4 (UNI/SPUTNIK) : Italian Prime Minister Georgia Meloni, commenting on the response of Palestinian Hamas to US President Donald Trump's plan, stated that the priority in resolving the Gaza conflict should be a ceasefire followed by the release of hostages.

"I am following developments in Gaza very closely and reiterate my full support for President Trump's efforts to bring peace to the Middle East. The priority for everyone must now be to reach a ceasefire that will lead to the immediate release of all hostages. Italy remains ready to do its part," Meloni wrote on X.

French President Emmanuel Macron said on X that the commitment made by Hamas will contribute to peace in Gaza."The release of all hostages and a ceasefire in Gaza are within reach! Hamas' commitment must be followed up without delay. We now have the opportunity to make decisive progress towards peace. France will play its full part in line with its efforts at the United Nations, alongside the United States, Israelis and Palestinians, and all of its international partners," Macron said, thanking Trump for his peace efforts.

Hamas said earlier on Friday that it had agreed to hand over governance of the Gaza Strip to a Palestinian committee based on a nationwide consensus. Hamas also expressed its readiness to release all living Israeli hostages and hand over the bodies of the dead in accordance with Trump's plan, adding that the movement will participate in discussions on the future of the Gaza Strip within the framework of a pan-Palestinian structure.In response to Hamas' statement, Trump said on Truth Social that he believed Hamas was ready for a lasting peace. Trump called on Israel to immediately stop the bombing of Gaza, since it was too dangerous at the moment to get the hostages out.On Monday, Trump unveiled a 20-point plan to resolve the Gaza conflict. The proposal calls, among other things, for an immediate ceasefire and the release of hostages within 72 hours. The plan also stipulates that Hamas and other factions must renounce their involvement in governing Gaza, both directly and indirectly

US Special Envoy Steve Witkoff arrives in Egypt for ceasefire negotiation in Gaza

Cairo, Oct 4 (UNI) : US Special Envoy to the Middle East Steve Witkoff arrived in Egypt on Saturday for negotiations aimed at securing a ceasefire in Gaza. Hamas representatives are expected to reach Cairo later tonight, with talks scheduled to start Sunday, according to Saudi outlet Al Arabiya.

Officials believe that there exists a short window to strike a deal, hence thus leading to immense rush to the negotiating table by all members party to the deliberations.

"We are heading into a dramatic week," a senior Israeli official told N12.

The discussions will revolve around the key demands of the 20-point-initiative proposed US President Donald Trump.

This includes the total-release of all hostages by the terror group, living and deceased, under 72 hours,

its total disarmament, and the cessation of hostilities by both sides, marked by a gradual IDF retreat.

Trump had issued a stark ultimatum to the outfit, giving it Sunday evening as deadline for either accepting the deal, or otherwise reap the whirlwind.

While Hamas has not formally accepted the plan, an anonymous official of the group said that Egypt will host intra-Palestinian talks on "unity and the future governance of Gaza," including how the war-torn Strip will be administered once fighting ends.

"We are ready to begin negotiations immediately to finalize all issues," the official added.

As per N12, Israel understands that the timetable for the hostages' release could be stretched out depending on the situation on the ground in Gaza, with security officials

in Tel Aviv already making a list of the Palestinian prisoners who could be released in parallel to the hostages freed by Hamas, in a bid to hasten the process.

Both sides are also preparing withdrawal maps, with the Israeli side notably ready to make several compromises on its original demands.

The Israeli delegation is reportedly trying to speed up talks on the hostages, and wants to table discussions on an IDF withdrawal from Gaza, the meaning of the full ceasefire, and the names of the prisoners set to be released.

This follows the comments delivered by American-Palestinian mediator Bishara Bahbah, who had hailed Trump's Gaza peace plan as the means to potentially end the whole war and return the hostages.

Backchannel US-Palestinian mediator hails Trump's Gaza peace plan

Washington, Oct 4 (UNI) : American-Palestinian mediator Bishara Bahbah described Hamas's response to US President Donald Trump's Gaza peace proposal as a "pivotal moment" that could mark both the end of the war and the release of all hostages, reports Jerusalem Post.

Speaking to Walla in an interview released Saturday, the 68-year-old, who has also served as the unofficial envoy to US special envoy Steve Witkoff, said he was "cautiously optimistic" that negotiations were moving toward a breakthrough.

"I truly believe that good things are happening now," he said. "I can see before my eyes the end of the war and the release of

all the hostages."Despite holding no official position in the US administration, Bahabab is a predominant backchannel figure in Washington's mediation efforts, acting as a conduit for facilitating talks, drawing both criticism and praise.He opined to Al Arabiya on Friday that mediators were already discussing disputed points of the US plan with Hamas.

He suggested Trump's rapid public response — calling on Israel to halt strikes so hostages could be freed — showed he had not consulted Prime Minister Benjamin Netanyahu beforehand.

"This is a very special day, unprecedented in many ways," Bahbah said.

"Everybody was unified in wanting this war to end and seeing peace in the

Middle East, and we are very close to achieving that."Trump, in his own statement, urged Israel to stop bombing Gaza "immediately" to facilitate the release of hostages, a rare direct appeal to Jerusalem in the middle of its military campaign.

One senior Israeli official told N12 News that Netanyahu appeared "visibly surprised" by Trump's tone, which was noted to be rather aggressive and hostile. Netanyahu- who convened his security cabinet late Friday had notably excluded some of the extreme far-right ministers, such as Security Minister Itamar Ben-Gvir and Finance Minister Bezalel Smotrich — and told advisors he considered Hamas's response to the plan a rejection.

Takaichi elected Japan's ruling party leader

Tokyo, Oct. 4 (UNI) : Japan's former Economic Security Minister Sanae Takaichi was elected leader of the ruling Liberal Democratic Party (LDP) on Saturday after a runoff against Agriculture Minister Shinjiro Koizumi.

The winner of the party poll to succeed incumbent Shigeru Ishiba, who announced his resignation last month, is almost certain to become the country's next prime minister because the LDP remains the largest party in parliament.

LDP parliamentarians cast 295 votes in the first round of voting, while another 295 votes were allotted to rank-and-file members. Takaichi, who took the lead with 183 votes in the first round, entered the runoff with Koizumi who won 164 votes.

In the runoff voting, the LDP lawmakers cast the same number of votes, but the rank-and-file members' votes were reduced to one for each of the LDP's 47 prefectural chapters. Takaichi secured 185 votes in the round to defeat Koizumi, who received 156 votes.

Qatar welcomes Hamas' agreement to Trump plan

Doha, Oct. 4 (UNI) : Qatar on Saturday welcomed Hamas' acceptance of U.S. President Donald Trump's peace plan for Gaza and the group's willingness to release all hostages as part of the exchange outlined in the proposal."We also affirm our support for the statements made by the President calling for an immediate ceasefire to facilitate the safe and swift release of hostages, and to achieve rapid results that would put an end to the bloodshed of Palestinians in the Gaza Strip," Qatari Foreign Ministry spokesperson Majed bin Mohammed Al Ansari wrote on X.Al Ansari added that Qatar has begun working with Egypt, in coordination with the United States, to continue discussions on the plan and ensure a path toward ending the conflict.The U.S.-proposed 20-point plan combines a ceasefire-for-hostages deal, phased Israeli withdrawal, and international oversight on Gaza's post-war reconstruction and governance.Trump on Friday demanded that Israel immediately stop bombing Gaza, hours after Hamas said it had agreed in principle to release the hostages.

Qatar, along with Egypt, has played a central role as mediator throughout the conflict, previously helping broker humanitarian pauses and prisoner exchanges between Israel and Hamas.

Trump urges Israel to stop bombing Gaza after Hamas agrees to release hostages

Washington, Oct. 4 (UNI) : U.S. President Donald Trump on Friday demanded that Israel immediately stop bombing Gaza, hours after Hamas said it had agreed in principle to release hostages.

Earlier in the day, Trump set a deadline for Hamas to accept his "20-point plan" to end the Gaza conflict by 6 p.m. EDT (2200 GMT) on Sunday and rebuild the enclave, warning that otherwise "all hell" would break out against the group.

Hamas later announced it had submitted its response to regional and international mediators, saying it agreed in principle to release all Israeli hostages, both living and dead, under the exchange framework outlined in the plan. The group said it was ready to begin immediate negotiations through mediators on implementation details.

In a statement, Hamas also said it would transfer Gaza's administration to a Palestinian body of independent technocrats and backed by Arab and Islamic countries.

The group said it valued Arab, Islamic, international and U.S. efforts to end the conflict, allow humanitarian aid, prevent Palestinian displacement and reject any reoccupation of Gaza. Other issues raised in the U.S. proposal concerning Gaza's future and broader Palestinian rights would be addressed within a collective Palestinian framework, in line with relevant international laws and resolutions, it said.

The U.S.-proposed plan combines a ceasefire-for-hostages deal, phased Israeli withdrawal, and international oversight on Gaza's reconstruction and governance after the end of the conflict.

Under the ceasefire terms, Israel would halt military actions and pull back to the agreed lines.

Hamas, within 72 hours of Israel's public acceptance, must release all remaining hostages, living or deceased.

In return, Israel pledges to free select prisoners and detainees, while disarmed Hamas members pledging peaceful coexistence could receive amnesty or a safe exit.

South China provinces upgrade typhoon emergency responses

Guangzhou, Oct. 4 (UNI) : The southern Chinese provinces of Guangdong and Hainan on Saturday upgraded their emergency typhoon responses as Typhoon Matmo, the 21st named storm of the 2025 Pacific typhoon season, approaches.

The Guangdong flood control headquarters upgraded its emergency typhoon response to Level II, the second-highest level, from Level IV at 9 a.m., as heavy rains and strong winds are expected in the next 48 hours.At 9 a.m., Typhoon Matmo was located about 670 kilometers southeast of Xuwen County in Guangdong Province, packing winds of up to 33 meters per second at its center, according to the National Meteorological Center.Matmo, which has strengthened to typhoon level, was moving northwestward at a speed of roughly 25 kilometers per hour while still increasing in intensity.

Matmo is expected to make landfall as a typhoon or severe typhoon on Sunday morning along the coast -- in an area ranging from Dianbai in Guangdong to Wanning in Hainan.

Fishing boats in affected sea locations off Guangdong have been ordered to return to ports for shelter, while affected coastal cities have been urged to implement prevention measures in bracing for potential waterlogging, flash floods and landslides.

Local authorities in Guangdong have been instructed to enhance forecasts, issue timely warnings, implement emergency response measures, and relocate residents living in vulnerable areas.

Meanwhile, in Hainan, the provincial committee for disaster prevention, mitigation and relief upgraded their emergency typhoon response for vessels and marine operations in affected sea areas to Level III from a Level-IV emergency response at 8:30 a.m. on Saturday.Haikou, the provincial capital of Hainan, plans to suspend classes (including tutoring institutions), work activities, public transportation, and park and business operations from Saturday afternoon to Sunday, according to the Haikou committee for disaster prevention, mitigation and relief.

Death toll in Philippine earthquake rises to 70, with 559 injuries

Manila, Oct 4 (UNI) : The death toll in Tuesday's magnitude 6.9 earthquake in Cebu province in central Philippines has climbed to 70, according to the latest official figure released by the Philippines' highest body for disaster risk reduction and management on Saturday.The National Disaster Risk Reduction

and Management Council (NDRRMC) reported that 32 of the fatalities were recorded in Bogo City, the quake's epicenter, 15 in San Remigio town, 14 in Medellin town, six in Tabogon town, and one each in the municipalities of Sogod, Tabuelan, and Borbon.The NDRRMC further reported that 559 people have been injured in the 5-

kilometer-deep, offshore quake that struck at 9:59 p.m. local time while villagers were asleep and preparing to go to bed.

More than 120,000 families, or approximately 457,000 people, were affected by the tremor, which damaged over 18,000 houses and more than 500 infrastructures, including

roads, bridges, and the city's hospital.The Philippine Institute of Volcanology and Seismology continues to record aftershocks, with more than 5,000 as of the time of writing, prompting people to stay in open spaces in makeshift tents due to their reluctance to return home because of the

aftershocks.All residents have now been accounted for.The Philippine government has announced the termination of search, rescue, and retrieval operations, focusing on relief efforts, early recovery, and rehabilitation activities.

Nearly four days since the quake struck, survivors

continue to depend on the dole out for food and water as they face daily struggles to live. The victims appeal for food packs, first aid kits, hygiene supplies, tents, sleeping bags, and generator sets amid power outages.The Philippines sits along the Pacific "Ring of Fire," a region prone to earthquakes and volcanic activity.

Babulal Marandi criticizes Hemant Soren govt for inaction in Dhanbad cough syrup case

Ranchi, Oct 4 (UNI) : Jharkhand BJP president and former Chief Minister Babulal Marandi has strongly criticized Chief Minister Hemant Soren, accusing his government of inaction in the Dhanbad cough syrup case and claiming that such negligence is putting the future of the state’s youth at risk.

Marandi said that despite the CID taking over the case of the banned cough syrup consignment seized from Barwadda in Dhanbad last year, not a single arrest has been made even after 14 months.

He questioned the government’s silence, pointing out that everyone knows the seized Phensedyl syrup is used as an intoxicant, yet no action has followed.

“This is not only an administrative failure but also amounts to handing over our children and youth

to a deadly addiction,” Marandi said.

Accusing the Chief Minister of prioritizing financial interests over the well-being of young people, Marandi said, “Hemant Soren is putting the future of our youth at stake in the blind race for money.”

He also took to his social media account on ‘X’, asserting that the BJP had repeatedly warned the Chief Minister about the deep roots of corruption in his administration and highlighted the questionable functioning of the CID.

Marandi recalled that the cough syrup consignment was seized in Dhanbad following a tip-off from Gujarat Police, yet the illegal sale of the banned substance continues unchecked.

He wrote, “Chief Minister, are we so greedy that we will not even spare our children? The hunger

for money has locked your tongue while our youth are being pushed into drugs.”

Further criticizing the state government, Marandi pointed out that Chief Minister Hemant Soren also holds charge of the Home Department, but agencies like the CID and ACB have failed to submit timely chargesheets and conduct impartial investigations.

He alleged that the CID has consistently been found shielding paper leak accused, protecting drug traders, and facilitating land scams, leading even the courts to doubt its credibility.

Calling for decisive action, Marandi demanded a public inquiry into the extortion and corruption activities allegedly carried out by CID officials over the past year.“The people of Jharkhand are watching everything. The time has come for concrete action, not empty words,” Marandi said.

Bukhari alleges BJP-PDP political understanding; PDP hits back

Srinagar, Oct 4 (UNI) Jammu and Kashmir Apni Party president and former minister Altaf Bukhari today claimed that the BJP and PDP have a political understanding, saying the two parties “always play a fixed match.”

“PDP is a unit of BJP and they (PDP) walk on their (BJP) strength. ...Some parties openly say that they have a relationship with someone (BJP) and some parties don't say that,” Bukhari told reporters in Srinagar.

Bukhari, who was a minister in the PDP-BJP government, praised Chief Minister Omar Abdullah for demonstrating some “political honesty” by not joining hands with the BJP.

“Omar had taken votes on the promise of not aligning with the BJP, and now that he has repeated that stand, it shows political honesty,” he said.

Reflecting on past

political decisions, Bukhari said that in 2014, the PDP had promised to keep the BJP away but later joined hands with them.

“Mehbooba became Chief Minister with BJP support. By the grace of Allah, I told them to keep the BJP out. I was the only person. Allah has given us the courage to speak the truth. And this is the truth. It was the wrong decision of PDP, and you will see that PDP will suffer for a long time,” Bukhari said. “Omar learnt a lesson from that, and his latest statement reflects that.”

The PDP, however, hit back at Bukhari, accusing him of seeking a “backdoor route” to the Rajya Sabha through the National Conference.“After being rejected by the people and left politically orphaned, Altaf Bukhari is targeting PDP only to seek a backdoor route to Rajya Sabha through NC.

Assam CM inaugurates 5th Assam Police Commando battalion in Biswanath

Guwahati, Oct 4 (UNI) : In a major boost to the manpower and connectivity of Assam Police, Chief Minister Himanta Biswa Sarma today inaugurated the headquarters of the 5th Assam Police Commando Battalion at Pabhoi in Biswanath district.

Spread over 218 bighas, the battalion is equipped with modern facilities for an elite commando force.

It may be noted that on July 18, 2022, during a Cabinet meeting, the Government of Assam decided to set up five Assam Police Commando Battalions in Biswanath, Hailakandi, Karbi Anglong, Sivasagar, and Tinsukia. Subsequently, on December 10 the same year, the Chief Minister laid the foundation stone of the battalion at Pabhoi in Biswanath. Within a span of three years, its infrastructure has been completed, and the Chief Minister today dedicated it to the service of the people.

The battalion has modern facilities, including residential accommodation for 400 commando personnel, advanced security with boundary fencing, nine watchtowers, underground bunkers with magazine vaults, barracks for 256 commandos, and 144 residential quarters for officers and staff. It also has extensive training and operational infrastructure such as a parade ground, drill shed, obstacle course, shooting range and classrooms with computer facilities. With these features, the Pabhoi Commando Battalion is expected to emerge as a centre of excellence for commando training and operations.

Speaking on the occasion, Sarma said that ever since the present state government assumed office, decisive steps taken by Assam Police have led to a remarkable reduction in the crime rate across the state. Referring to the development that has taken

place in Biswanath over the past few years, he said the district has been one of the most inspired recipients of the government’s vision for progress.

He further highlighted that a medical college is being established in the district, a stadium has been constructed, and new buildings for the District Commissioner’s office and the Circuit House have been completed. The inauguration of the Pabhoi Commando Battalion marks another milestone.

Although Biswanath is a newly created district, it has managed to surpass many others in terms of development, the Chief Minister remarked, adding that the progress achieved there is commendable.

Sarma pointed out that until 2016, there were very few paved roads in Biswanath.

However, now all roads in the district have been blacktopped. Roads inside tea garden lines have also been constructed.

Speeding car kills three women during morning walk, driver fled the scene in Ghaziabad

Ghaziabad, Oct 4 (UNI) : A speeding car ran over three women who were out for a morning walk in the Rakesh Marg area under the Sihani Gate police jurisdiction today.

The collision was so intense that the women were thrown several feet into the air. Two women died on the spot, while the third succumbed to her injuries at the hospital. Another man sustained injuries in the incident.

The accident occurred reportedly due to the driver dozing off behind the wheel. Eyewitnesses estimate the car’s speed to be around 100 km/h. The impact was so severe that the bonnet of the car was nearly torn off after it rammed into the road divider. The crash caused a massive traffic jam and drew a large crowd to the scene.

Police teams from Dial 112 and Sihani Gate police station quickly arrived at the location. Authorities have identified the car as a white Toyota Glanza registered in Ghaziabad. The driver, identified as Manjul, a resident of Nehru Nagar, is currently on the run.

He was reportedly returning from Bulandshahr at the time of the accident. Initial investigations suggest that he fell asleep while driving, leading to the fatal crash. Police confirmed that he also sustained injuries.

The deceased women have been identified as Kamlesh (55), wife of Dayanand; Meenu Prajapati (56), wife of Bhakt Singh; and Savitri (60), wife of Dariyab, all residents of New Kotgaon. They were walking near a cut on Rakesh Marg when the speeding car hit them from behind. Another local resident, Vipin Sharma from Shyam Bihar Colony, was also injured.

Left Front stages protest rally in Kolkata against Israeli actions in Gaza

Kolkata, Oct 4 (UNI) : Kolkata witnessed a massive rally on Saturday as the Left Front and its affiliated organisations marched from Rabindra Sadan to Lenin’s Statue at Esplanade, raising their voice against the recent Israeli attack on a humanitarian aid flotilla bound for Gaza.

The protesters also demanded the immediate release of internationally renowned activists, including environmentalist Greta Thunberg, who have reportedly been detained for standing in solidarity with the Palestinian cause. The rally, called by Left parties, was marked by a sea of banners, posters and placards condemning Israel’s actions. The demonstrators carried slogans demanding an immediate end to what they described as “genocide in Gaza” and condemned the United States for providing continuous support to what they termed “war crimes” by Israel. Senior Left leaders, including Left Front chairman Biman Bose, CPI(M) central committee member Suján Chakraborty, and Students’ Federation of India (SFI) general secretary Srijan Bhattacharya, were present at the forefront of the rally.

They walked shoulder to shoulder with a large number of activists, students, workers, and common citizens who had gathered in solidarity with the people of Palestine.

Speakers at the rally strongly criticised the Israeli government for launching repeated assaults on civilian populations in Gaza, as well as the attack on the flotilla carrying humanitarian aid. “The attack is not only an assault on the people of Gaza but also on international humanitarian principles,” Suján Chakraborty said. He further alleged that such actions were possible only because of unconditional backing from the United States, which continues to shield Israel on international platforms.

The rally reiterated the student community’s solidarity with the Palestinian people and demanded the immediate release of Greta Thunberg and other activists who had stood up against what they called “ecological destruction and human rights violations in the name of war.”

The rally saw hundreds of participants chanting slogans such as “Stop genocide in Gaza,” “Free the detained activists,” and “Down with US-backed Israeli war crimes.” The protest concluded at Lenin’s statue in Esplanade, where participants took a pledge to continue mobilising public opinion in support of Palestine.

The leaders announced that similar rallies and meetings would be held across districts in West Bengal in the coming days to sustain the momentum.

BJP govt in UP acting undemocratic, anti-constitutional: Akhilesh Yadav

This is condemnable and shameful," he said. The SP

president said," the BJP government's behavior is completely undemocratic and an abuse of power. Following the incident that occurred after Friday prayers on September 26, numerous houses and shops were bulldozed, with innocent people being arrested.

By preventing the opposition from accurately assessing the situation there and meeting the families of the victims, it has been demonstrated that the BJP government is taking all these actions to conceal its misdeeds."He further said the BJP government must understand that it will achieve nothing by repressing the people of Bareilly. "

Speaking exclusively to UNI, Shriram said "most of the private schools have tennis courts, and they have coaching camps, but more tournaments are required as that they can actually showcase their talent and become more competitive."

He explained what inspired him to come forward to support tennis "my son use to play Tennis at the national level, once he and his mother went out of Delhi for a tournament, the matches were scheduled to start at 9 am but they finally started vey late at 4 pm, the organization was not good no arrangements were made for water or food, there was no place to sit no proper schedule being followed. We wanted that

tournament should be organized in a proper way otherwise the player's focus is not on the game and on other things like these basic facilities."

Shriram expressed satisfaction that as many as 800 players are participating in the tournament this year and appeared confident that the numbers will rise further in the future.

He said that his biggest satisfaction over the 30 years has been the ability to provide the players with good facilities

"We are very happy that this tournament has been able to achieve 30 years of consistent growth and management.

What we are trying to provide is a quality atmosphere where the players don't have to worry about where do they get water, food, if their racket strings cuts then they should not have to worry about where they have to get it repaired from? where do they stay, where do they eat, we are taking care of everything, this year we had 800 participants, this shows the commitment of the players and the parents.

Yogeshwar confident that India will excel in high weight categories in the future

New Delhi, Oct 4 (UNI) : 2012 London Olympics bronze medalist wrestler Yogeshwar Dutt is confident that the Indian grapplers, now doing well in the lower weight categories, would put up a strong showing in the higher weight sections as well in the near future.

Speaking to UNI on the sidelines of the 30th Fenesta Open National Tennis Championship at the DLTA Complex, Dutt said, "Earlier, we were not doing well even in low-weight categories. Now we are winning medals in those categories regularly, but in heavyweight categories, some of our grapplers have been performing well".

To buttress his point, he referred to Deepak Punia winning a silver medal at the World Championships

in the 86 kg category. "We have started to do well in the Greco-Roman category at the Asian level, and our women wrestlers are doing well. At present, we are strong in the 57, 65 and 74 kg weight categories," he said.

The Khel Ratna Awardee expressed satisfaction that wrestling has been growing in the country and has been a source of medals in big competitions like the Olympics

"Wrestling has fetched India medals consecutively in five Olympics from 2008 to 2024. Overall, sports is growing very well in India as Prime Minister Narendra Modi is keen on hosting the Olympics in India in 2036, and making India a superpower in sports.

"Government initiatives

like the Target Olympics Podium scheme and the various Khelo India games, giving a platform to players, have also supported them financially, which is very important as most of the players are from financially weak backgrounds," said Dut who was the chief guest in the function.

The Padma Sri awardee highlighted the role of village fairs and Dangals in the promotion of wrestling in the country

"Wrestling is a village sport, played in mud. The village fairs and Dangals have a big role in promoting wrestling. All famous wrestlers have fought in these dangals and fairs, when I started out, I fought bouts even for Rs 2. Even now, wrestlers fight for a very small amount of money in these events, they are

our heritage," said Dutt.

He spoke about the way he was inspired by India's exploits in tennis to do well in the Olympics. "It was Leander Paes's medal in 1996 (Atlanta Olympics) that inspired me to strive to be an Olympian; before that, I was not even aware of the Olympics. Besides this, I have been very close to Rohit (Indian Davis Cupper Rohit Rajpal)."

He warned wrestlers to steer clear of steroids and be perseverant if they wish to win medals for the country. "Make hard work your addiction and learn to be patient.

I played four Olympics and finally won a medal at the 2012 edition. So train for hours and never give up on your dreams," he added.

Bezzecchi blasts to pole with jumbled up grid in Indonesia

Jakarta, Oct 04 (UNI) : One of the most shaken-up grids of the year is headed by polesitter Marco Bezzecchi (Aprilia Racing) as the 72's form of recent rounds continues with domination at Mandalika. He heads up an exciting front row, including rookie Fermin Aldeguer (BK8 Gresini Racing MotoGP) and Raul Fernandez (Trackhouse MotoGP Team), whilst Marc Marquez (Ducati Lenovo Team) suffered his worst qualifying of 2025 in P9.

With both Marquez and teammate Francesco Bagnaia (Ducati Lenovo Team) contesting Q1, it was always going to be a battle for graduation. Marquez led Fabio Di Giannantonio (Pertamina Enduro VR46 Racing Team) in the provisional graduation spots after the first run, with Pecco P7, the Japanese GP winner with work to do. Lapping together, 'Diggia' and teammate Franco Morbidelli (Pertamina Enduro VR46 Racing Team) managed to improve their times with the #21 briefly into Q2 before Di Giannantonio snatched P1, demoting the #93 to P2 but at the chequered flag, he was safe. Di Giannantonio and Marquez moved into Q2, Morbidelli missing out by 0.048s. Bagnaia was only sixth, leaving him 16th on the grid. With Q2 underway, all eyes turned to the pole battle and the pre-session favourite Marco Bezzecchi, who was fastest on Friday and in FP2 on Saturday. He delivered the goods and by

the end of the first run was the rider to beat, but there was still time for it all to change. Further down the order, Fabio Quartararo (Monster Energy Yamaha MotoGP) suffered a fast crash at Turn 15 but was straight back on his feet and onto his second bike.

Going into the final run, Marc Marquez needed a lap and was down in P10 with less than three minutes remaining. Pedro Acosta (Red Bull KTM Factory Racing) and Fernandez were on the provisional front row, but Bezzecchi was in a different league up ahead, smashing the all-time lap record and becoming the first rider into the 1'28s at Mandalika. Just behind, Alex Rins (Monster Energy Yamaha MotoGP) had put in a cracking lap to go third, whilst elsewhere, Alex Marquez (BK8 Gresini Racing MotoGP) fell at Turn 13. Nobody could catch Bezzecchi, who stormed to pole position, a second in three GP's and with a margin of 0.398s. In second place, a first front row in MotoGP for Aldeguer, following Bezzecchi home just like on Friday afternoon. Fernandez recovered his front row starting position from Rins, a first front row for him since he was third at the Sachsenring in 2024. Rins crashed on his final flying lap but with a best qualifying since COTA in 2023, he may have a say at the front. Acosta and Luca Marini (Honda HRC Castrol) round out the second row of the grid with all five manufacturers across the front two rows.

This initiative has the potential to benefit countless citizens. I humbly request you to spread the word about this campaign in your communities and nearby areas.” Sitharaman said.

“With concerted efforts, from all—the Finance Ministry, regulators, state governments, and banks in villages—if the entire chain is activated, everyone will be able to reclaim their money. This is not only our assurance, but also our duty.” Sitharaman added.

She said “I am very grateful to Prime Minister Narendra

Modi who once advised me to go among the people and call upon them to claim what is rightfully theirs. Acting on his advice, I am glad to share that Gujarat has taken the lead in launching this campaign.”Moreover, Secretary DFS, M Nagaraju said, “As of August 2025, more than Rs 75,000 crore of unclaimed deposits have been transferred to the RBI’s Depositor Education and Awareness Fund. Unclaimed insurance proceeds stand at over Rs 13,800 crore, unclaimed balances in mutual funds to about Rs 3,000 crore and unpaid dividends worth more than Rs 9,000 crore.”

Unclaimed financial assets, including insurance policy claims, bank deposits, dividends, shares, and mutual fund proceeds, often remain unclaimed due to a lack of awareness or outdated account details.
