### **Mumbai corporation** polls: State EC approves ward boundaries

Mumbai, Oct 6 (UNI) Marking a major step toward conducting the much-delayed Bombay Municipal Corporation election, the Maharashtra State Election Commission (SEC) gave its final approval to the revised ward boundaries for the upcoming civic polls.

The final ward structure was officially published in the Maharashtra government gazette and uploaded on the BMC's official website this morning.

In a post shared on X, the BMC announced, "The State Election Commission has approved the ward formation for the Brihanmumbai Municipal Corporation (BMC) general elections 2025. The finalized ward structure was published in the government gazette and on the BMC's official website on October 6, 2025."

The approval of ward boundaries paves the way for the much-anticipated civic elections, which have been pending for nearly three years. The polls for the BMC, India's richest municipal body, are likely to be conducted in mid-January 2026, with the Supreme Court's extended deadline for completing local body elections in entering several houses and Maharashtra set to end on January 31.

The process follows months of public consultation and scrutiny. The SEC had earlier released a draft delimitation notification on August 22, detailing the proposed geographical boundaries for all municipal wards.

Citizens were invited to submit their feedback, and a total of 492 suggestions and objections were received by the September 4 deadline. Hearings on these objections were held between September 11 and 13, after which the localities were completely final ward map was approved.

The BMC's election department has appointed 6,500 Booth Level Officers (BLOs) to oversee the voter lists and polling arrangements. Additionally, recruitment for more than 4,000 supporting staff for election management is currently in progress.

According to civic officials, nearly 70,000 personnel, including staff from the state government, will be deployed for various election-related duties on polling day.


### Heavy rains lash Marathwada, Parbhani worst hit by flooding

Ch. Sambhajinagar, Oct 6 (UNI) Heavy rains lashed several districts of the Marathwada region early this morning, causing severe disruption, particularly in Parbhani district, which was the worst affected.

The downpour occurred between 4 am and 7 am, with the India Meteorological Department (IMD) having earlier predicted heavy rainfall for the region.

After Parbhani, heavy showers were also reported from parts of Dharashiv and Beed districts. In Parbhani, torrential rain led to waterlogging in low-lying areas, with rainwater affecting hundreds of families. From about 4 am to 5 am, Parbhani city and its surrounding experienced an intense spell of rain that caused hardships for residents.

Many low-lying inundated, with substantial water ingress into homes in neighbouring settlements. Roads and major intersections in central parts of the city, including the Four-Way Square area, were submerged under knee-deep water, paralysing morning traffic.

# Three scientists including two from US and one from Japan awarded 2025 **Nobel Prize in Physiology or Medicine**

New Delhi, Oct 6 (UNI) The Nobel Committee has decided to award the 2025 Nobel Prize in Physiology or Medicine to three scientists including two from the United States and one from Japan for discovering how the immune system is kept in check, the Nobel Committee announced

Mary E. Brunkow of the Institute for Systems Biology, Seattle, Fred Ramsdell of the Sonoma Biotherapeutics, San Francisco and Shimon Sakaguchi of Osaka University, Osaka, Japan, were awarded the Nobel Prize for their "discoveries concerning peripheral immune tolerance. They discovered how the immune system is kept in check," the Nobel Committee said in a statement.

The body's powerful immune system must be regulated, or it may attack our own organs, it said.

Every day the immune system protects from thousands of different microbes trying to invade human bodies. These all have different appearances and many have developed similarities with human cells as a form of camouflage. So how does the immune system determine what it should attack and what it should defend?

The laureates identified the immune system's security guards, regulatory T cells, which prevent immune cells from attacking our own body.

"Their discoveries have been decisive for our understanding of how the immune system functions and why we do not all develop serious autoimmune diseases," says Olle Kämpe, chair of the Nobel Committee.

Shimon Sakaguchi was swimming against the tide in 1995 when he made the first key discovery. At the time, many researchers were convinced that immune tolerance only developed due to potentially harmful immune cells being eliminated in the thymus through a process called central tolerance. Sakaguchi showed that the immune system is more complex and discovered a previously unknown class of immune cells, which protect the body from autoimmune diseases.

Mary Brunkow and Fred Ramsdell made the other key discovery in 2001, when they presented the explanation for why a specific mouse strain was particularly vulnerable to autoimmune diseases.

They had discovered that the mice have a mutation in a gene that they named Foxp3. They also showed that mutations in the human equivalent of this gene cause a serious autoimmune disease, IPEX.

Two years after this, Shimon Sakaguchi was able to link these discoveries. He proved that the Foxp3 gene governs the development of the cells he identified in 1995. These cells, now known as regulatory T cells, monitor other immune cells and ensure that our immune system

The five largest importers accounted for 85 percent of that total, buying 979 million euros worth of Russian oil and gas. # Uddhav Sena and Raj Thackeray's MNS to fight municipal polls together says Sanjay Raut

Mumbai, Oct 6 (UNI) Uddhav Thackeray led Shiv Sena MP and chief party spokesperson Sanjay Raut said here today that Uddhav and Raj Thackeray have reached an understanding to fight the municipal elections together.

"Raj Thackeray and Uddhav Thackeray have reached an understanding about Maharashtra Navnirman Sena (MNS) and Shiv Sena fighting together in the municipal elections of Mumbai, Thane, Kalyan Dombivali, Pune, and Nashik. Besides these, there are many such municipal corporations where Shiv Sena is present, but MNS is present in many areas. In some places the (Sharad Pawar-led) NCP is strong, while in other places the Congress is strong. All these factors are being taken into account," Sanjay Raut told media persons.

Replying to whether the Congress-led Maha Vikas Aghadi (MVA) would open its doors to include Raj Thackeray, Sanjay Raut said, "There is a Maha Vikas Aghadi (MVA) in Maharashtra, and (Uddhav-led) Shiv Sena constituents. Therefore, we are considering if a new party (MNS) can be accommodated in the MVA. Let's keep a different calculation in mind for local selfgovernment bodies. Also, I am not the only one who has the right to tell Raj Thackeray that the doors of the Maha Vikas Aghadi (MVA) are open. There are three parties in the MVA. Leaders of other

When asked who would keep the mayor's post after municipal elections, Sanjay Raut said, "You can be

certain that the mayor of Mumbai will be a Marathi and he will be of genuine saffron blood and of Marathi lineage. It will not be anybody from the BJP or those who carry the shoes of those in Delhi.'

"The mayor will be

somebody who goes to Hutatma Chowk and prostrates himself before our 105 martyrs who laid down their lives during the Samyukta Maharashtra movement agitation and raises his voice for Maharashtra. Such blood and lineage exist only in Shiv Sena and MNS. These are the two parties that were created for Marathispeaking people and to fight for the Marathi identity," Sanjay Raut said."The mayor will be ours. I am speaking with emphasis on the word 'ours'. The Thackerays will decide who will be the mayor. Ours is not just a political alliance, but an alliance of body, mind, wealth, heart, and soul," Sanjay Raut said

### Maratha quota: **Jarange targets** Pawar; says **OBC leaders** betrayed own community

Mumbai, Oct 6 (UNI): Maratha reservation activist Manoj Jarange Patil has launched a sharp attack on Sharad Pawar, chief of the Nationalist Congress Party (Sharadchandra Pawar faction), alleging that Pawar had in 1994 diverted the Maratha community's rightful 16% reservation to the Other Backward Classes (OBC), depriving Marathas of their due rights.

This marks the first time Jarange has openly accused Pawar. "We will now secure our reservation with our own efforts. But the fact is we should have received it back in 1994. Sharad Pawar gave our rightful share to the OBCs. Yet the OBC community has not acknowledged his favour," Jarange said. He also accused OBC leaders of harming their own community's interests.

Jarange claimed that Minister Chhagan Bhujbal and Congress Legislature Party leader Vijay Wadettiwar held a secret meeting to plan leadership for the OBC reservation protection movement. According to Jarange, Bhujbal told Wadettiwar, "I'm trapped in this government because of Deputy CM Ajit Pawar; you should lead the movement instead."

However, Wadettiwar denied that any such meeting took place. The ongoing exchange between Bhujbal and Jarange over reservation continues to intensify.

Bhujbal recently remarked that Jarange has been unnecessarily elevated as the Maratha community's leader, asserting that he is not truly the representative of the entire Maratha community.

### Shiv Sena (Shinde) leader Rajan Teli levels allegation against Fisheries Minister

Sindhudurg, Oct 6 (UNI) Shiv Sena (Shinde faction) leader and former MLA Rajan Teli has alleged that Maharashtra Fisheries Minister Nitesh Rane is the mastermind behind the multi-crore loan scam in the Sindhudurg District Bank.

In the same case, the bank's manager Vishwanath Dorlekar lodged a complaint with the Bank Security and Fraud Department against Rajan Teli and seven others.

It is alleged that to avoid action in this matter, Teli switched allegiance from the Thackeray faction to the Shinde faction. Teli claimed that Rane, who is a director of the bank, exerts pressure on the chairman and CEO to sanction illegal

Complaints reportedly been submitted to the local police, Cooperative Registrar and NABARD, but no action has been taken so far.

He further alleged that under Rane's influence, a firm named Rockstar was granted Rs 6.5 crore initially and later Rs 10 crore in loans despite being ineligible. Similarly, a personal assistant earning just Rs 20,000 per month was sanctioned a loan of Rs seven crore.

Teli claimed that such illegal disbursement of crores of rupees has taken place under pressure and that false accusations were made against him for raising objections.

### **Organised Crime act** slapped on Latur Gang involved in assault, extortion

Latur, Oct 6 (UNI) The Latur Rural Police have invoked the Maharashtra Control of Organised Crime Act (MOCCA) against notorious criminal Shakti alias Yogesh Ashok Gurne and his gang, who are accused in multiple serious offences, an official confirmed today.

The group, comprising Shakti Gurne, Ismail Sheikh, Kishore Maske, Akash Sakat, and others, had allegedly assaulted Avinash Boyne with iron rods and chairs at Devgiri Bar on Ausa Road over nonpayment of extortion, following which a case was registered at the Latur Rural Police Station.

During the investigation, the police recovered an iron rod used in the assault. The gang already has 11 serious criminal cases registered against it, including charges of robbery, extortion, forcible theft, and assault with deadly weapons. Based on the investigation, police have filed an 860-page charge sheet against the accused under Sections 3(1)(ii), 3(2), and 3(4) of the MOCCA Act before the Special MOCCA Court in Latur. The action was initiated under the guidance of Superintendent of Police Amol Tambe and Additional Superintendent of Police Mangesh Chavan, and led by Sub-Divisional Officer Sahebrao Narwade and Police Inspector Arvind Pawar.

# WHO issues new guidelines to tackle deaths from excessive bleeding after childbirth

The World Health Organization (WHO) has issued new guidelines to prevent, diagnose, and treat postpartum haemorrhage (PPH), which causes excessive bleeding after childbirth, to millions of women across the globe.

The maternal health guidelines, copublished with the International Federation of Gynecology and Obstetrics (FIGO) and the International Confederation of Midwives, highlight the urgent need for earlier detection and faster intervention to prevent death among new mothers.

PPH is one of the leading causes of maternal mortality globally, causing nearly 45.000 deaths due to excessive bleeding after childbirth.

Even when not fatal, it can lead to lifelong physical and mental health impacts, from major organ damage to hysterectomies, anxiety, and trauma.

"Postpartum haemorrhage is the most dangerous childbirth complication since it can escalate with such alarming speed. While it is not always predictable, deaths are preventable with the right care," said Dr Jeremy Farrar, Assistant Director-General for Health Promotion and Disease Prevention and Care.

"These guidelines are designed to maximise impact where the burden is highest and resources are most limited -helping ensure more women survive childbirth and can return home safely to their families," Farrar added.

The guidelines, launched at the 2025 FIGO World Congress in Cape Town, South Africa, also introduced new objective diagnostic criteria for detecting PPH.

While PPH has typically been diagnosed as a blood loss of 500 mL or more, the guidelines advise clinicians to act when the blood loss reaches 300 mL, and in case of any abnormal vital signs.

To diagnose PPH early, doctors and midwives are advised to monitor women closely after birth and use calibrated drapes -- simple devices that collect and accurately quantify lost blood -- so that they can act immediately when criteria are met.

The guidelines recommend the immediate deployment of the MOTIVE bundle of actions once PPH has been diagnosed. This includes: Massage of the uterus; Oxytocic drugs to stimulate contractions; Tranexamic acid (TXA) to reduce bleeding; Intravenous fluids; Vaginal and genital tract examination; and Escalation of care if bleeding persists.

In rare cases where bleeding continues, the guidelines recommend effective interventions such as surgery or blood transfusion to safely stabilise a woman's condition until further treatment becomes available, the WHO said. The guidelines also emphasise the importance of good antenatal and postnatal care to mitigate critical risk factors such as anaemia, which is highly prevalent in lower-middle-income lowand countries. Anaemia increases the likelihood of PPH and worsens outcomes if it occurs. Recommendations for anaemic mothers include daily oral iron and folate during pregnancy and intravenous iron transfusions when rapid correction is needed, including after PPH, or if oral therapy fails.

# Delhi govt will urge SC to allow use of green firecrackers on Diwali: CM

New Delhi, Oct 6 (UNI) Delhi Chief Minister Rekha Gupta today said the government, respecting the sentiments of the residents of the national capital, will request the Supreme Court to grant permission for the use of certified green crackers during the upcoming Diwali festivities.

Gupta, while replying to a question while speaking to reporters at the secretariat on Monday, said that the government believes that there must be a balance between environment protection and public sentiments.

Gupta said that she feels that the public should get the permission, be it in the form of green crackers, so that they can celebrate the festival with enthusiasm, and accordingly the government will express in writing its intention, that it is responsible for the pollution control, and will abide by its responsibility.

She said that the objective of this initiative is to further strengthen the government's commitment towards controlling pollution, while also respecting the traditions and sentiments of the people.

CM said that it will also ensure that all green firecrackers are manufactured only by authorized institutions, and certified and tested by competent and concerned departments.

She reiterated that the Delhi government is fully committed to environmental protection and pollution control, adding that the apex court will be assured that the government will fully comply with its directions and standards.Gupta said that the government's aim is to ensure that the festivities are full of happiness, while the environment also stays safe and clean.

The CM has said that Diwali is the most significant festival in the country's culture, deeply rooted in the emotions of the people.

She added that based on past experience, a complete ban on firecrackers has not yielded the desired results, and despite restrictions, violations have continued, which led to the use of highly polluting firecrackers and worsened Delhi's air quality. Therefore, the government wishes to allow the use of green firecrackers in the city.

She also reaffirmed that the Delhi government remains unwavering in its commitment to environmental protection and will assure full cooperation with the central government and the SC to implement any directions issued in this regard.

Gupta also mentioned that allowing green crackers would also help the city's economy, with regard to the small traders, while art and culture will also flourish

Presently, due to the pollution issue there has been a ban on firecrackers since a while, and it is said that if effective anti-pollution measures had been taken during the past, such a situation could have been avoided. During the past, due to lack of a proper system for identification, certification, and distribution of green firecrackers in the national capital, the complete ban on the use continued.

# **SC** issues notice to Centre on plea challenging **Constitutional validity of STT**

New Delhi, Oct 6 (UNI) The Supreme Court today issued notice to the Central government on a writ petition challenging the constitutional validity of the Securities Transaction Tax (STT), which is levied on the buying and selling of stocks and other securities on Indian stock exchanges under the Finance Act, 2004.

A Bench comprising Justice J.B. Pardiwala and Justice K.V. Viswanathan issued the notice, returnable in four weeks.

"The principal argument canvassed before us is that the Securities Transaction Tax is the only tax levied in the country on the mere act of carrying out a profession and is sought to be levied irrespective of whether a profit is derived or not.

This, according to the petitioner, renders the levy almost punitive or deterrent in nature.

Otherwise, all other taxes in India are levied on profits at the year-end, but the STT is imposed even if the stock market trader operates at a loss.

Issue notice, returnable in four weeks," the Court recorded.

The writ petition, filed by stock market trader Aseem Juneja, seeks a declaration that STT is unconstitutional as it violates Articles 14, 19(1)(g), and 21 of the Constitution.

In the alternative, Juneja has sought a direction to allow adjustment of STT paid during a financial year against short-term or long-term capital gains tax liability, similar to how Tax Deducted at Source (TDS) is adjusted for salaried individuals.

The petitioner has argued that STT amounts to double taxation, since traders pay capital gains tax on profits while also being charged STT on every transaction.

He pointed out that while short-term or longterm capital gains taxes are levied on profits, STT currently 0.1 percent on both buy and sell sides for delivery trades, is imposed regardless of whether profit or loss is made.

Juneja further contended that STT is unique because it applies even when a trader incurs losses, making it punitive in nature.

"STT is applicable to

the rupee value of shares bought or sold, not on actual profits. There is no other tax in India where a professional is taxed despite making a loss. Such a levy on transactions rather than profits is arbitrary and violates Articles 14, 21, and 19(1)(g)," the plea states.

Drawing an analogy, the petitioner compared STT to taxing a doctor on every consultation fee received even if the practice ultimately incurs

The petition notes that while STT was introduced in 2004 to curb tax evasion and function like TDS, it lacks any mechanism for adjustment or refund against final tax liability, effectively forcing traders to pay both STT and capital gains tax.

The plea also highlights that major global financial markets such as the United States, Germany, Singapore, and Japan do not impose such

The petitioner has urged the Supreme Court to either strike down the STT as unconstitutional or direct that it be adjusted against capital gains tax liability.

### 4: Cow Face Pose for your upper back-

Take both your hands and clasp your hands behind your back. If you are unable to clasp, don't try too hard, comfortably stretch your fingers towards one another.

Release with an exhalation. Now shake your arms for about 30 seconds and repeat.

5: Cat Asana for the lower back-

While exhaling, bend your back in a backward direction creating a sharp curve in your spine.

Now bend in a forward direction with the point between the shoulder blades and inhale. Do it for 5 breathing cycles to relieve your body of long hours at the desk.

### 6: Konasana for toned arms-

Stand straight with legs wide apart. Now bend forward from your waist. Try and touch the ground with the tips of your fingers, if possible place both your hands on the ground while standing. Your upper body should be in a straight line. Look ahead by about 3 inches. Perform konasana for 10 to 30 seconds and breathe normally throughout the asana.

### 7: Bhastrika for your abdomen-

Sit in a comfortable position with your back straight. Close your eyes and start exhaling and inhaling via nose by focusing on the abdominal muscles. As soon as you release your abdominal muscles you'll realize that your diaphragm contracts before you start to inhale. Hear the sound of your breath and perform this asana 5 times at a stretch. Give it a pause. Breathe normally. And start again. Complete one to two rounds on a daily basis and increase the number of your breaths by 5, each week.

### 8: Leg Extension Asana-

Sit in a comfortable position with one leg bent and placed on a chair or desk in front of you. Place both your hands on your feet. Keeping your spine straight, inhale and extend your leg



outward while holding it with your hands. Stay in this position for 3 to 5 breaths. Exhale as you come back to the normal position, while moving your hands and placing them on your waist. Stay in this position for 3 to 5 breaths. Relax. Perform 5 to 10 rounds like this. Read more Personal

# **Babulal Marandi criticizes Hemant Soren govt for inaction** in Dhanbad cough syrup case

Ranchi, Oct 6 (UNI): to a deadly addiction," Jharkhand BJP president and former Chief Minister Babulal Marandi has strongly criticized Chief Minister Hemant Soren, accusing his government of inaction in the Dhanbad cough syrup case and claiming that such negligence is putting the future of the state's youth at risk.

Marandi said that despite the CID taking over the case of the banned cough syrup consignment seized from Barwadda in Dhanbad last year, not a single arrest has been made even after 14 months.

Marandi said. Accusing the Chief

Minister of prioritizing financial interests over the well-being of young people, Marandi said, "Hemant Soren is putting the future of our youth at stake in the blind race for money."

He also took to his social media account on 'X', asserting that the BJP had repeatedly warned the Chief Minister about the deep roots of corruption in his administration and highlighted questionable functioning of the CID.

Marandi recalled that cough the syrup consignment was seized in Dhanbad following a tip-off from Gujarat Police, yet the illegal sale of the banned continues substance unchecked.

He wrote, "Chief Minister, are we so greedy that we will not even spare our children? The hunger for money has locked your tongue while our youth are being pushed into drugs."

Further criticizing the state government, Marandi pointed out that Chief Minister Hemant Soren also holds charge of the Home Department, but agencies like the CID and ACB have failed to submit timely chargesheets and conduct impartial investigations.

He alleged that the CID has consistently been found shielding paper leak accused, protecting drug traders, and facilitating land scams, leading even the courts to doubt its credibility.

Calling for decisive action, Marandi demanded a public inquiry into the extortion and corruption activities allegedly carried out by CID officials over the past year."The people of Jharkhand are watching everything. The time has come for concrete action, not empty words," Marandi said.

### **Speeding car** kills three women during morning walk, driver fled the scene in **Ghaziabad**

Ghaziabad, Oct 6 (UNI) : A speeding car ran over three women who were out for a morning walk in the Rakesh Marg area under the Sihani Gate police jurisdiction today.

The collision was so intense that the women were thrown several feet into the air. Two women died on the spot, while the third succumbed to her injuries at the hospital. Another man sustained injuries in the incident.

The accident occurred reportedly due to the driver dozing off behind the wheel. Eyewitnesses estimate the car's speed to be around 100 km/h. The impact was so severe that the bonnet of the car was nearly torn off after it rammed into the road divider. The crash caused a massive traffic jam and drew a large crowd to the scene.

Police teams from Dial 112 and Sihani Gate police station quickly arrived at the location. Authorities have identified the car as a white Toyota Glanza registered in Ghaziabad. The driver, identified as Manjul, a resident of Nehru Nagar, is currently on the run.

He was reportedly from returning Bulandshahr at the time of the accident. Initial investigations suggest that he fell asleep while driving, leading to the fatal crash. Police confirmed that he also sustained injuries.

The deceased women have been identified as Kamlesh (55), wife of Dayanand; Meenu Prajapati (56), wife of Bhakt Singh; and Savitri (60), wife of Dariyab, all residents of New Kotgaon. They were walking near a cut on Rakesh Marg when the speeding car hit them from behind. Another local resident, Vipin Sharma from Shyam Bihar Colony, was also injured.

### **Left Front stages protest** rally in Kolkata against Israeli actions in Gaza

Kolkata, Oct 6 (UNI): Kolkata witnessed a massive rally on Saturday as the Left Front and its affiliated organisations marched from Rabindra Sadan to Lenin's Statue at Esplanade, raising their voice against the recent Israeli attack on a humanitarian aid flotilla bound for Gaza.

The protesters also demanded the immediate release of internationally renowned activists, including environmentalist Greta Thunberg, who have reportedly been detained for standing in solidarity with the Palestinian cause. The rally, called by Left parties, was marked by a sea of banners, posters and placards condemning Israel's actions. The demonstrators carried slogans demanding an immediate end to what they described as "genocide in Gaza" and condemned the United States for providing continuous support to what they termed "war crimes" by Israel.Senior Left leaders, including Left Front chairman Biman Bose, CPI(M) central committee member Sujan Chakraborty, and Students' Federation of India (SFI) general secretary Srijan Bhattacharya, were present at the forefront of the rally.

They walked shoulder to shoulder with a large number of activists, students, workers, and common citizens who had gathered in solidarity with the people of Palestine.

Speakers at the rally strongly criticised the Israeli government for launching repeated assaults on civilian populations in Gaza, as well as the attack on the flotilla carrying humanitarian aid."The attack is not only an assault on the people of Gaza but also on international humanitarian principles," Sujan Chakraborty said.He further alleged that such actions were possible only because of unconditional backing from the United States, which continues to shield Israel on international platforms.

The rally reiterated the student community's solidarity with the Palestinian people and demanded the immediate release of Greta Thunberg and other activists who had stood up against what they called "ecological destruction and human rights violations in the name of war."

The rally saw hundreds of participants chanting slogans such as "Stop genocide in Gaza," "Free the detained activists," and "Down with US-backed Israeli war crimes."The protest concluded at Lenin's statue in Esplanade, where participants took a pledge to continue mobilising public opinion in support of Palestine.

The leaders announced that similar rallies and meetings would be held across districts in West Bengal in the coming days to sustain the momentum.

# India will work with any government that emerges through the people's mandate in Bangladesh: FS Misri

India said today that it will work with any government that emerges through the mandate of the people of Bangladesh, in the elections slated for February 2026. Foreign Secretary

Vikram Misri, interacting with a group of journalists from the Diplomatic Correspondents Association, Bangladesh (DCAB), also said that regarding former PM Sheikh Hasina's extradition, that there is a judicial and legal process involved which involves consultations between the two governments and New Delhi is looking into the issue.

"We will work with any government that emerges through the mandate of the people of Bangladesh, and there is no doubt that a certain mandate will be expressed through the election," he said.

Regarding the ban on the Awami League, the party of former PM Sheikh Hasina, he said: "When it comes to some of the conditions that shape that mandate, India will not get into that; That is something the people of Bangladesh should be more invested in that decision and in those circumstances."

He said the people and

New Delhi, Oct 6 (UNI) civil society in Bangladesh will have to make their own assessment of how these elections are viewed both domestically internationally, if the AL is kept out of participating in the elections.

"We will work with the government that is sworn in and enters into office following the elections," FS Misri said, pointing out that even after the events of July-August last year when Hasina was forced to quit and flee to India, New Delhi has continued to work with the authorities in Dhaka.

He also reiterated that India firmly supports "free, fair, inclusive, and participatory elections" in Bangladesh at the earliest possible time.

On Hasina's presence in India and Dhaka's request for her extradition to face charges, the FS said: "On the impact of her presence on the bilateral relationship, all I will say is this is a judicial and legal process, and it requires engagement consultations between the two governments. We are examining this issue and we look forward to working together with the Bangladesh authorities on these issues. Beyond that I don't think it will be constructive to say anything at this point."

On several members of the interim government, including the Chief Advisor, accusing India of sheltering Hasina and towing a pro-Hasina line, the FS said: "There musn't be an attempt to shift blame because we overwhelmed by a problem or an issue, and we are not immediately able to find a solution. And the answer to that is to double down and try and find solutions, and it is not that there are no solutions. And in fact, there are solutions on the table, and what it will take is to shed the models and templates of the past and look to the future of our relationship."

He also termed the bilateral relationship as mutually beneficial, and said they are working to expand it. "And we have made very good progress over several years. It would be a pity to let the gains be frittered away over what I feel are transient issues at the present moment. There may be some different approaches that may be taken in the present moment, and I hope that we can look beyond these.

"What I mean is that we should set a future-oriented relationship rather than look at it from the lens of the past," the FS said.
