#### Patancheru registers season's lowest minimum temperature at 9 deg cel

Hyderabad, Nov 14 (UNI); The season's lowest minimum temperature of 9 degrees celsius was recorded at Patancheru in Sangareddy district on the intervening night of Thursday and Friday, the Meteorological Centre said.

In its daily weather report, the Met office cautioned that cold wave conditions are likely to prevail at isolated pockets in Adilabad, Komaram Bheem Asifabad, Nirmal, Sangareddy and Medak districts over the next 24 hours.Minimum temperatures expected to remain 3 to 4 degrees Celsius below normal at isolated locations across Telangana for the next two to three days.Dry weather is likely to continue across the state for the next week, the report added.

#### Adibatla town planning officer, assistant caught taking bribe

Hyderabad, Nov 14 (UNI): The Anti-Corruption Bureau (ACB) on Thursday caught the Town Planning Officer of Adibatla Municipality and his outsourcing Assistant while they allegedly were accepting a bribe of Rs 75,000 for issuing a building permission.

According to the ACB statement on Friday, Bandela Varaprasad (A0-1), Town Planning Officer Adibatla Municipality Ibrahimpatnam mandal of Rangareddy district, was trapped at his office after he demanded and accepted the bribe through his assistant, Vadala Vamshi Krishna (A0-2). The bribe was reportedly sought for processing and issuing permission for a G 4 building construction. It said that the amount of 75,000 was recovered from Vamshi Krishna's possession.

#### Delhi: Slight improvement in AQI, but still 'very poor'

New Delhi, Nov 14 (UNI) With a minor improvement, Delhi's average Air Quality Index (AQI) on Friday was recorded in the 'very poor' zone, stepping down from the 'severe' category.

However, according to the Central Pollution Control Board's daily bulletin, national capital's air quality index value was 387, which is 17 points lesser as compared to Thursday's 404, but still is 'very poor.'

Going according to the Indian Institute Tropical Meteorology's (IITM) air quality and weather bulletin for Delhi, there seems to be lesser scope of much improvement for now, as it has forecast that the air quality is likely to be in the 'Very Poor category from

These locations were strategically chosen to represent diverse socio-economic contexts like metro, semi-rural, and coastal which can be replicated across the country.

The project's first 12-month budget stands at Rs 12 crore (USD 1.4 million), with a five-year outlay of Rs 60 crore (USD 7 million), funded through EBG Group CSR allocations, partner contributions, and publicmicrodonations via the Children of Life digital platform.

Notably, 80 percent of all expenditure is earmarked for direct programme delivery, with less than 10 percent for administration and less than 10 percent for audits and

## Social Banking: A mission adrift

The Regional Rural Banks (RRBs) are fast losing not only their 'regional and rural' character but, unfortunately, their inherent social banking nature, the very purpose of their establishment fifty years ago. Started with five RRBS, one each in West Bengal, Rajasthan and Haryana and two in UP, on a pilot basis, on 2 October 1975, they are now spread to 700 districts in 26 States and three union territories, Puducherry, Jammu and Kashmir, and Ladakh; only two states, Goa and Sikkim, and five union territories do not have an RRB, yet.

The reform measures introduced in the RRB sector in different phases starting from the early 1990s were definitely not with the intent to strengthen their original goals, which they had admirably delivered in certain respects, but with new tasks, pure commercial as opposed to social benefit. The new approach of the government, guided by the goals of the overall neoliberal economic policies, has facilitated the changes, regardless of the fact that the rural credit doesn't fit into the market forces doctrine in view of its critical importance in developing the farm sector, farmers' welfare, and rural employment.

Moreover, the RRBs' experiment was far superior to all the earlier measures put in place since the early years of independence for strengthening rural institutional credit.

A cursory review of the earlier steps for strengthening rural institutional credit reveals the importance of RRBs, particularly the current need to revive their establishment goals. Even the British government, for whom their own colonial interest was supreme, had to focus its attention on the government's lending to the farm sector, as evidenced by passing of the consolidated law, the Land Improvement Loans Act in 1883.

To facilitate the setting up of rural credit societies, the government enacted the first-ever cooperative Act in the country in 1904; it subsequently brought subject of the cooperatives under the states' legislative competence in 1919, following the Montague-Chelmsford Reforms.

Later, the independent Indian government considered supporting agriculture as its top priority and found credit to be an important input for farm development, and thus, an issue of national importance; the first Prime Minister Jawaharlal Nehru said, it is apt recall here, "anything can wait, but not agriculture!". The RBI undertook the first rural credit survey in 1951-52 to take stock of the agricultural credit scenario in the country.

The survey highlighted the deplorable state of the then-existing rural credit scenario. It found that the cooperative system, the only institutional arrangement at that time, was neither effective nor adequate to deal with the problem of rural credit.

Worse was the informal segment comprising traditional money lenders who fleeced the farmers with usurious interest rates and the exploitative conditions attached to their lending, leading to borrowing farmers ending up in eternal bondage or losing what little assets they had to their creditors. The major among several steps following recommendations of the committee on direction on Rural Credit Survey (Gorawala committee 1955) was the conversion of the Imperial Bank into the State Bank of India, with the main goal of taking banking to rural areas.

The SBI initially set up 400 branches within the next five years, meeting its mandate. Several other steps, including the strengthening of cooperatives, were also initiated.

A National Credit Council (NCC) was set up in 1967 to assess credit demand and supply. The prioritization of areas for credit deployment and the coordination of credit allocation with national priorities were its other tasks. Later, in 1968, social control on banks for channelizing credit towards the areas of national importance was experimented with. As social control without government ownership was not found to be effective, fourteen major commercial banks were nationalized in 1969, and another six in 1980. Although banks made good progress after nationalization, their reach, particularly to the poor, continued to be nowhere near the expectations.


The Banking Commission (under R.G.Saraiya) in its report in 1972 recommended, among other things, increasing banking coverage in rural areas and for an appropriate institutional arrangement suitable to rural requirements to bridge the wide gap between rural credit need and supply, particularly in relation to the small and marginal farmers.

Despite all these concerted efforts, including outright nationalization of banks, it was found that credit was not reaching the needy in the quantity required and in the method convenient to them.

Therefore, the government in 1975 appointed a working group under the chairmanship of M Narasimham, then Additional Secretary in the Finance Ministry, to study the problem and recommend the establishment of a suitable lending institution for the poor in rural areas. Based on the recommendations of this working group, the government established the Regional

Rural Banks in 1975 through an ordinance, without even waiting for parliament to make a law; the presidential ordinance was later converted into the Regional Rural Banks Act, 1976. The preamble of the Act clearly set out the goals of the new institution.

## Bridging the Himalayas: India, Bhutan, and the China Factor

(By Jayanta Roy Chowdhury)

When Prime Minister Narendra Modi flew to Thimpu earlier on Tuesday for talks with Bhutan's monarch King Jigme Khesar Namgyel Wangchuck, the agenda went far beyond bilateral friendship.

India's proposal to link the Himalayan kingdom to its rail network through routes in West Bengal and Assam may appear as an infrastructure project, but its strategic implications reach deep into the heart of the eastern Himalayas, where India, Bhutan, and China intersect in a complex and fragile triangle.

India has long seen strengthening connectivity with Bhutan as both a reaffirmation of trust and a subtle counterweight to Beijing's expanding presence along the disputed Bhutan—China border.

Nestled in the high

neighbour in the North.

The latest India—
Bhutan engagement comes amid a notable thaw in India—China ties.
In August 2025, just weeks before Modi's scheduled visit to Beijing for the Shanghai Cooperation Organisation (SCO) Summit, New Delhi hosted the 24th round of Special Representative (SR) talks with China.

Both sides agreed to create an expert group under the Working Mechanism for Consultation and Coordination (WMCC) to explore an "early harvest" solution for border delimitation.

delimitation. While the discussions primarily focused on stabilising the long and disputed boundary, they also have implications for Bhutan, the only neighbouring state with which China has neither diplomatic relations nor a settled border. As India cautiously reopens channels with Beijing, Bhutan finds itself facing renewed Chinese pressure and a rare opportunity to finally conclude its own protracted boundary dispute.

Bhutan Between Two

Giants Bhutan shares deep civilisational and strategic ties with India, but it has managed to maintain a careful neutrality with China. Since 1984, it has held 25 rounds of border talks with Beijing over three disputed sectors the North, West, and East. Yet, progress has been agonisingly slow and with no clear results in sight. The most sensitive zone is Bhutan's Western sector, abutting India's Sikkim state and the Chumbi Valley, a dagger-shaped wedge of Tibetan territory, that points menacingly toward India's narrow Siliguri Corridor, the "Chicken's Neck'

connecting mainland India to its northeast.

At the core of this

contest lies the Doklam Plateau, where India, Bhutan, and China meet. In 2017, India's intervention stopped the Chinese construction of a road toward the Jampheri Ridge, sparking a 73day military standoff. The plateau's strategic significance is immense: if China were to occupy the ridge, it would gain direct observation and artillery advantage over India's vital corridor. Bhutan and India both recognise Batang La as the trijunction point, while China insists it begins at Gipmochi, several kilometers south, a seemingly minor difference with enormous geopolitical consequences.

Bhutan's

vulnerability to Chinese

pressure is rooted in

history. For centuries, the kingdom shared a symbiotic, if uneasy, relationship with Tibet, which extracted tributes and enjoyed influence based on the spiritual leadership of the Dalai Lama over the Himalayan Buddhist world. However, when China formally annexed Tibet in 1951, it inherited its ambiguous frontier with Bhutan and began asserting historical claims based on old Tibetan grazing routes and monastic records. During the 1950s and 1960s, Beijing oscillated between threats and inducements. It issued maps showing swathes of Bhutanese land as Chinese territory even as it offered trade concessions and friendship.

The annexation of Tibet also deepened India's strategic anxieties. New Delhi, which guided Bhutan's foreign policy at the time, moved swiftly to strengthen ties with Thimphu, an alignment that has endured ever since. For Beijing, however, Bhutan remains an unfinished business, the only neighbour, apart from India, with which it has no demarcated boundary with it. To make matters worse, it is the only neighbour that has not yet allowed China to send a permanent minister. In Chinese eyes, settling the Bhutan border is essential to consolidating control over Tibet, reducing Indian influence in the Himalayas, and expanding its strategic reach toward the Siliguri corridor. Over the decades,

China has perfected a slow-motion strategy of encroachment, which analysts term "gray zone warfare", in Bhutan. Through the 1980s and 1990s, Chinese herders and patrols gradually pushed southward, setting up camps, outposts, and eventually roads. Recently, satellite imagery has revealed entire Chinese-built villages inside territory

internationally recognised as Bhutanese, some in the Menchuma Valley in the north, others near Doklam in the west. A 2024 report counted 19 such settlements housing around 7,000 residents, an unmistakable effort to establish "facts on the ground." In 2020, Beijing even expanded its claims to include Sakteng, in eastern Bhutan, a move that caught Thimphu by surprise and underscored the scale of Chinese ambitions.

India's Stakes For New Delhi, the stakes in Bhutan's border dispute with China are far greater than a few square miles of snow-covered wilderness. Control over Bhutan's south-western sector, particularly the Doklam Plateau, could determine whether India retains secure access to its northeastern states or lives with a permanent vulnerability at its narrowest strategic hinge, the Siliguri Corridor.

India cannot prevent this by military posturing alone. It needs a layered, patient strategy that combines deterrence, development, and diplomacy to ensure that Bhutan's sovereignty and India's security are not eroded ridge by ridge or, for that matter, valley by valley. The most effective defence against coercion is interdependence. By accelerating rail and road links from West Bengal and Assam to Bhutan, particularly the Kokrajhar-Gelephu and Banarhat-Samtse corridors, New Delhi can both anchor Bhutan's economy more firmly in the Indian market and extend logistical reach across the eastern Himalayas. Fast-tracking these projects under special funding windows would signal commitment at a time when China's own infrastructure is increasing by leaps and bounds southward through Tibet.

Similarly, expanding hydropower cooperation, concessional financing, and cross-border electricity trade can bind Bhutan's long-term growth to India's grid, offering Thimphu prosperity without dependency on Beijing's inducements. Economic connectivity, in this context, becomes strategic connectivity.

India's defence

relationship with Bhutan is rooted in quiet trust, not an overt alliance. To preserve that balance, New Delhi's focus should be on capacity-building, enabling Bhutan to monitor and manage its own frontier effectively. This includes expanding training for the Royal Bhutan Army, facilitating logistics and mountain mobility, and deepening cooperation on border roads and all-weather access routes.

Equally vital is the transfer of surveillance technology.

The goal is not militarisation but awareness, ensuring that every new Chinese road, herder's camp, or "model village" is visible, recorded, and diplomatically actionable.

## India, Canada reaffirm strength of bilateral economic partnership

New Delhi, Nov 14 (UNI): India and Canada have reaffirmed the strength and resilience of economic bilateral partnership and emphasized the importance of continued engagement with private sector to unlock new opportunities for trade and investment.

Commerce and Industry Minister Piyush Goyal and his Canadian counterpart Maninder Sidhu, at the 7th edition of the Ministerial Dialogue on Trade and Investment (MDTI) here, reaffirmed the strength and continuity of economic partnership between the countries and reiterated commitment to bilateral deepening

sustained dialogue, mutual maintaining an open, respect and forwardlooking initiatives.

The Ministers noted robust growth in bilateral trade in goods and services which reached USD 23.66 billion in 2024, with merchandise trade valued at nearly USD 8.98 billion, a substantial 10 percent increase over the previous

They welcomed the steady expansion of twoway investment flows, including notable Canadian institutional investment in India and the growing presence of Indian firms in Canada, which together support tens of thousands of jobs in both economies.

The Ministers also reaffirmed commitment to

transparent and predictable investment environment and exploring avenues for deeper collaboration across priority and emerging sectors. residence of Dr Umar Nabi. the main accused in the Red Fort terror car bombing, in South Kashmir's Pulwama district during the intervening night of Thursday and Friday.Officials said the structure was demolished using a controlled explosion.Locals said that the area had been sealed by security forces and that residents were asked to vacate the house before the demolition.Investigators have revealed that Dr Umar drove the explosive-laden i20 car that exploded near Red Fort, claiming 13 lives and injuring several others, on November 10 evening.

Although J&K Police has not issued an official statement on demolition, top officials said that such actions are aimed at discouraging local youth from joining militant ranks.According to them, the measure is intended to send a strong message that involvement in terror activities carries grave repercussions, not only for the individuals concerned but also for their families.

The demolition of the triggered house condemnation mainstream leaders.J&K Chief Minister Omar Abdullah questioned the effectiveness of such measures in curbing militancy."If terrorism could be stopped by these actions, it would have ended long ago," Omar told measures had been taken even after incidents like the Pahalgam attack.

**House of Red Fort blast** 

"I fear such actions only fuel more anger. But these decisions are not in our (elected government) hands. Those taking these decisions should reflect on whether they have succeeded in stopping terrorism through these methods."Drawing on his experience as Chief Minister of J&K state, Omar said militancy incidents had consistently declined during his six-year tenure without the need to "blow up anyone's home." Former Chief Minister

and PDP Chief Mehbooba Mufti said the government must act strictly against perpetrators but should not punish innocent families."We are not against action being taken against those involved. But targeting their friends, relatives, parents, siblings — the way detentions are happening, especially in the Valley, has created fear and terror," she told reporters in Budgam. Mehbooba recalled union Home Minister Amit Shah's assurance that the law

would take its course. 'We also want strict action, but within the law," she said. "Blowing up someone's home where elderly parents live, who have nothing to do with the incident, arresting friends and relatives — this is against the law. This said.Srinagar Member Parliament Aga Ruhullah condemned the demolition, saying the measure won't deliver "punishment" it only inflicts "collective suffering.""Making an entire family homeless during the harsh winter of Kashmir without evidence/ court order or any law linking them to the incident is an act of cruelty. It doesn't bring justice to the innocent lives that we lost in the terror attack, and it doesn't achieve the ends of justice," the office of the MP said on X."Hold the actual perpetrators accountable through lawful investigation. Mass detentions, coercive

interrogations, and illegal demolitions will not bring peace, they will drag Kashmir back by decades," he said. This is not first time that the house of an accused in a terror attack has been demolished.

After the Pahalgam terror attack on tourists in April, at least ten houses of the militants were blown up.

In December 2022, the police and district administration demolished the Pulwama residence of a Pakistan-based Jaish militant who had been declared a designated terrorist earlier that year. At time, officials maintained that the action was based on land-related illegalities.Soon after, a portion of the house belonging to Hizbul Mujahideen commander was also razed in Pahalgam.

#### Over 3,000 Boeing workers vowed to end their strike

Moscow. Nov 14 (UNI/ SPUTNIK): More than 3,000 Boeing workers voted to ratify a new contract with the company, ending a strike that lasted more than three months, the International Association of Machinists and Aerospace Workers (IAM) said.

"Approximately 3,200 members of IAM union (International Association of Machinists and Aerospace Workers) District 837 at Boeing in the St. Louis area have voted to ratify a new contract with Boeing, ending the strike that began on Aug. 4, 2025," the organization said in a statement on Thursday.

Union members will begin returning to work on November 16, the statement added.

The media reported previously that the striking employees are involved in the assembly and maintenance of high-tech military systems, including F-15 and F/A-18 fighter jets, as well as advanced missile and defense technologies.

#### Md Yunus discusses illegal immigration, Rohingya crisis with UK minister

Dhaka, Nov 14 (UNI) Bangladesh Chief Advisor (CA) Md Yunus, during his meeting with British Minister for International Development Baroness Jenny Chapman on Nov 13, discussed a whole array of bilateral topics such as migration, trade, tackling illegal migration, boosting trade, the Rohingya crisis, and enhancing cooperation in the aviation and

Expressing particular concern about the abuse of the UK asylum system by migrants from countries, with Bangladesh being one of its biggest exploiters, Chapman stressed the importance of safe and legal migration, instead of abusing political mechanisms, reports Business Standard BD.

Concurring with her assessment, the CA emphasised his govt's commitment to promoting safe migration and encouraging Bangladeshis to seek overseas employment through legal channels.

Discussing the Rohingya crisis and the need for continued humanitarian support for more than a million refugees living in camps in Bangladesh, Yunus said: "The young people in the camps are growing up without hope -- angry and frustrated. We must ensure they receive education."

He further noted that Bangladesh is purchasing a British research vessel to conduct maritime studies in the Bay of Bengal.

The British minister called for stronger aviation ties between the two nations, adding that the head of Airbus International is expected to visit Bangladesh soon. Also present at the meeting were National Security Adviser Dr Khalilur Rahman, SDG Coordinator Lamiya Morshed, and British High Commissioner to Bangladesh Sarah Cooke.

#### **COP30 Presidency launches Belém Action Plan for Health** and Climate Adaptation

Belem (Brazil), Nov 14 (UNI): The COP30 presidency has officially launched the Belém Action Plan for Health and Climate Adaptation following discussions during the World Health Organisation's recent General Assembly.

The initiative comprises over 80 members, including numerous countries and organisations, backed by investments and support from philanthropic bodies and civil society.

The report highlights a significant gap in global health finance regarding adaptation; as climate change impacts escalate, health systems find themselves at the forefront of the crisis.

With the Indian representatives endorsing the Belém Health Action Plan, they emphasised that this marks a crucial step toward prioritising health within the framework of climate action.

"The air pollution crisis we face, with millions exposed to toxic air daily, underscores the urgency of this commitment. This issue is not just a singular event; it's part of a growing trend of dangerous air quality extending across the Indo-Gangetic plain and beyond," they stressed during a recent press conference.

As noted in India's 2023 national communication to the UNFCCC, to adapt to climate change under a business-as-usual scenario, the nation will need 643 billion USD by 2030, as shared by Dr. Vishwas Chitale, a Fellow at the Council for Energy, Environment & Water and Research Fellow at United Nations.

He indicated that India has already made notable strides, having invested 146 billion USD in 2021-2022, accounting for 5.6% of the GDP, a significant increase from 3.7% in 2015-2016.

Dr. Chitale also highlighted the recently launched Climate and Health Funders Coalition, which has pledged an initial 300 million USD for coordinated efforts to address both the root causes of climate change and its health repercussions — focusing on delivering solutions where they are urgently needed.

Jeni Miller, Executive Director of the Global Climate and Health Alliance, remarked, "The establishment of the Climate and Health Funders Coalition, with an annual commitment of 300 million USD in philanthropic contributions, sends an important and encouraging message."

She underscored the necessity of adaptation finance to bolster health systems, emphasising that such funds must be just, equitable, transparent, and accessible to enhance health resilience, particularly in vulnerable nations.

## US approves \$330m aircraft parts sale to Taiwan, drawing anger from Beijing

Washington/Taipei/ Beijing, Nov 14 (UNI): The US has approved a \$330 million sale of fighter jet and transport aircraft parts to Taiwan — the first such package since President Donald Trump took office in January, drawing Beijing's ire.

Taiwan's presidential office welcomed the announcement, describing it as further evidence of sustained US support.

"The deepening of the Taiwan-US security partnership is an important cornerstone of peace and stability in the Indo-Pacific region," presidential office spokesperson Karen Kuo said.

The move comes at a particularly sensitive time amid heightened regional tensions, as China has been amping up its military presence in the island country's maritime zone

through its constant maintain sufficient selfincursions, while the US has been maintaining its role as Taiwan's main weapons supplier, and military supporter under the Taiwan Relations Act, reports Taipei Times.

Announcing the presidential greenlight, the Pentagon said the proposed sale would Taiwan's enhance defensive readiness by supporting the upkeep of its F-16 fighter jets, C-130 transport aircraft and other platforms, which "will improve the recipient's capability to meet current and future threats by maintaining the operational readiness of the recipient's fleet." Although Washington formally recognises Beijing's political position, it maintains unofficial ties with Taipei and is legally

defence capabilities.

Taiwan's Ministry of National Defence also thanked Washington, saying the package expected to take effect within one month - would boost the air force's fighter readiness, reinforce air defences, and strengthen the island's ability to counter China's expanding "grey-zone" pressure.

The ministry noted that the deal aligns with US commitments under the Taiwan Relations Act and the Six Assurances.

Beijing, in line with its predictable state rhetoric, expressed strong condemnation, reiterating its long-held claim that Taiwan is an inalienable part of China, something Taipei which completely rejected.

"The Taiwan question is required to help the island the core of China's core interests and the first red line that must not be crossed in China-US relations," Foreign Ministry spokesperson Lin Jian told reporters in Beijing.China's military has dramatically increased its operations around Taiwan in recent years, flying larger numbers of warplanes and sailing naval vessels near the island, as part of its pressure and intimidation tactics by projection of its military might. The approval of the arms package comes shortly after Trump and Chinese President Xi Jinping met in South Korea late last month, where economic negotiations took centre stage.

The meeting had prompted concern in Taipei that Taiwan's security interests could become entangled in the broader US-China bargaining.

#### **China cracks** down on Al deepfakes of public figures in

Beijing, Nov 14 (UNI): Chinese cyberspace authorities said on Friday they were cracking down on the use of Artificial Intelligence (AI)generated deepfakes to impersonate public figures in live-streaming ecommerce, targeting false propaganda and online infringement.

The Cyberspace Administration of China said in a statement that authorities had recently "severely dealt with" several online accounts that used AI to mimic celebrities to promote products in live-streams and short videos, misleading users.

The regulator said online platforms have been urged to launch a cleanup, which has so far removed over 8,700 pieces of non-compliant content and dealt with more than 11,000 accounts that impersonated others.

Cyberspace authorities would maintain a "highpressure" stance, continuing to hold platforms accountable and to "dispose of and expose" malicious marketing accounts to maintain a positive online environment, it added.

## **Poland receives full** delivery of 180 South **Korean K2 Black Panther tanks**

Warsaw, Nov 14 (UNI): Poland has received the delivery of 180 K2 Black Polish-made Panther tanks from South Korea, Polish Minister of National Defense Wladyslaw Kosiniak-Kamysz announced, a move aimed at transforming its armed forces into one of Europe's most powerful land forces.

"We are growing stronger. Another 20 K2 Black Panther tanks for the 16th Mechanized Division have just arrived in Poland, meaning we now have a full complement of 180 tanks under the first contract," Kosiniak-Kamysz wrote on X. He added that Warsaw and Seoul will begin implementing the next contract, signed in August, in 2025.

The initial USD 6.7 billion contract, signed on August 1, 2022, covers 180 K2 Black Panther tanks. Kosiniak-Kamysz said, "The new units will be better equipped than the existing ones, and production will be launched next year. Between 2028 and 2030, we plan full-scale domestic production."

Under the framework agreement, Poland can acquire up to 1,000 K2 tanks, which could become the mainstay of its land forces. The first 64 tanks configuration—a 5 percent in 2026.

## **Awami League** ineligible for contesting elections

Dhaka, Nov 14 (UNI): Bangladesh Chief Advisor Muhammed Yunus has told a visiting UK Minister that the Awami League has been barred from contesting the February 2026 polls, due to its current ban and suspension of all its political activities under the country's anti-terrorism laws.

Speaking to visiting British Minister for International Development Baroness Jenny Chapman, Yunus however reaffirmed his administration's determination to ensure that the upcoming polls are "free, fair, and inclusive". "The election will be participatory. There will be a big turnout," he added.

He told Chapman that the Election Commission had also subsequently removed the party's name from its official list of registered political parties, as per Daily Star.

In May 2025, the interim government, led by Muhammad Yunus, issued an executive order banning all activities of the Awami League and its affiliated organizations under the country's anti-terrorism laws.

The Awami League, founded in 1949, played a significant role in the struggle for Bangladesh's independence from Pakistan. Since then, it has remained one of the country's major political forces, with its longstanding association with the ideals of democracy, secularism, and social justice garnering a substantial voter base.

Yunus also said that tens of millions of the nation's youth are expected to cast their first ballots, since the fall of the Sheikh Hasina led AL regime last year, who he accused of rigging polls for three consecutive terms.

The 85-year-old added that the country's new constitutional overhaul document - the July National Charter – would "mark the beginning" of a new Bangladesh, as it will restructure and overhaul much of the country's existing political, legislative, social, institutional framework in favour of a new one, based on the values of the July Uprising.

While proponents have called the Charter a step toward strengthening democracy, and electoral process, it has been condemned for its pandering to Islamic hardliners, as well as their influence in shaping it, leading many to view the document as reinventing Bangladesh's once secular democracy to one striving closer for the establishment of an Islamic theocratic regime.

The July Charter was signed by Bangladesh's largest Islamist party, Jamaat-e-Islami, and several allied Islamist groups. Critics point out that during the drafting process, the word "secularism" was reportedly removed from the nation's guiding principles and replaced with "pluralism," a change viewed by some as a concession to Islamist demands.

## **Venezuelan President Maduro** calls on US public to unite with Caracas 'for peace of the Americas'

Caracas/Washington. Nov 14 (UNI) Venezuelan President Nicolás Maduro has called on the people of the US to unite with Venezuela "for the peace of the Americas," amid tensions escalating following the deployment of US warships to the Caribbean.

Maduro has continued insist that his government seeks peace, and refused to comment on the possible missile threats of Washington, adding that his administration's sole focus was on the peaceful governance of his country and ensuring the welfare of his people, indirectly dismissing the US' allegations of Venezuelan aggression.

Speaking to CNN during a mass rally in Caracas on Thursday, Maduro urged Americans to oppose what he described as Washington's "imperialist aggression," warning against another cycle of foreign wars.

"To unite for the peace of the Americas — no more endless wars, no more unjust wars, no more Libya, no more Afghanistan," Maduro said in Spanish, addressing the American public directly. Asked if he had a message for President Donald Trump, he switched

to English, replying simply "Yes peace, yes peace."

The Venezuelan leader was attending a rally organised for the country's youth, where he urged them to "resist the threat of invasion" and remain united in defending national sovereignty.

His remarks came as the United States intensified its military presence in the Caribbean, citing the need to intercept drug trafficking routes allegedly linked to Venezuela.

Washington claims the ongoing operation is focused on disrupting the flow of narcotics to the US, though Caracas has accused the Trump administration of using its so-called anti narcotics campaign as a cover for its attempts at a "regime change".

Over the past three months, Washington has deployed an estimated 15,000 personnel and more than a dozen warships, including an aircraft carrier described by the Navy as its "most lethal combat platform." The build-up represents the largest US military presence in the region since the 1989 invasion of Panama.

According to Pentagon officials, the US military forces have conducted at least 20 strikes against what they claim are drug trafficking vessels in the Caribbean and the Pacific, reportedly killing around 80


The administration is also reportedly considering expanding operations to target cocaine processing facilities and smuggling routes inside Venezuela, though the country ranks quite low among Washington's list of illegal narcotic suppliers to the

In recent Congressional briefings, US officials acknowledged that Washington currently lacks legal justification for direct strikes on Venezuelan territory but confirmed that legal avenues are being explored to authorise potential action.

In response, Venezuela has launched large-scale military mobilisations, deploying regular troops and militia forces across the country for defensive drills. Satellite imagery from November 10 showed antivehicle "hedgehog" obstacles placed along the Caracas-La Guaira highway, a critical route connecting the capital with the coast — a move seen as part of broader preparations against a possible incursion.

New Delhi, Nov 14(UNI) Indian shooting contingent left for Tokyo on Friday to participate in the 25th Summer Deaflympic Games, scheduled from November 15 to 26, 2025. The 15member squad, including three coaches, will represent India across five individual events in men's and women's category, one event in men's category, and two mixed team shooting events at the Ajinomoto National Training Center (East). The squad will be led by Deaflympic double gold medallist Dhanush Srikanth who will lead India's challenge alongside fellow Deaflympic medallists Shourya Saini and Abhinav Deshwal. The contingent also features World Deaf Championship medallists Mahit Sandhu, Anuya Prasad, Pranjali Dhumal, Natasha Joshi, Chetan Sapkal, Kushagra Singh Rajawat, and Mohammed Vania, forming one of India's most experienced line-ups at the Games.Two newcomers, Komal Waghmare and Rudar, will make their international debut, marking an important step in expanding India's emerging talent pool in deaf sport shooting. The athletes are accompanied by coaches Anuja Jung, Priti Sharma, and Harmit Patel.

## **Bumrah's Stump-Mic Remark Steal Day 1 Spotlight**

Day 1 of the first Test between India and South Africa at Eden Gardens was highlighted not only by Jasprit Bumrah's masterful five-wicket haul but also by a minor stump-mic incident that drew attention off the

During South Africa's innings, Bumrah reportedly remarked "bauna bhi hai" to Proteas captain Temba Bavuma while debating whether to take a DRS. The comment, picked up by the stump microphone, was widely discussed in the media, though it did not affect the spirit of the game.

South Africa opted to play down the incident, with batting coach Ashwell Prince saying: "No, there will be no discussion. It's the first time, obviously, it's

Kolkata, Nov 14 (UNI) don't think there'll be any issues with what's happened out in the middle."On the field, India's pacers and spinners combined expertly to dismantle the South African batting lineup. Bumrah, leading the attack on a tricky Eden Gardens pitch, finished with 5 wickets for 27 runs in 14 overs, earning plaudits for his control, patience, and tactical acumen. Speaking at the post-day press conference, Bumrah said: "If you want success in Test cricket, you need patience. This is a ground where the outfield is very fast and the wicket is hard, so if you are more desperate or if you go to bowl more magic balls, then the runs come very fast. If you bowl continuously in come to my attention. I a good area, then you will

get wickets."

Bumrah also reflected on adapting to overseas conditions and challenging pitches: "This is the challenge of Test cricket. We go to England, the atmosphere is different. We go to Australia, the challenge is different. We as a team will not point fingers and complain... It is our job to adapt and find ways because that's how professional cricket works."

The match also saw a tactical surprise, with Washington promoted to No.3 in the batting order following the exclusion of Sai Sudharsan. Sundar remained unbeaten on 6 runs at stumps. Bumrah, when asked about the decision, said: "I am not really aware of what was the whole thought process. We

back all our players to do the job. But I don't know what was the conversation behind it."

India's strategy of deploying two fast bowlers and four spinners, a combination not used since 2012, proved effective. Kuldeep Yadav and Ravindra Jadeja, in tandem with Bumrah, triggered a mini-collapse after lunch, leaving South Africa's remaining wickets to fall for just 39 runs. Clever field placements, including a backward short leg, ensured maximum pressure

on the visitors. South Africa, missing their star pacer Kagiso Rabada due to injury, struggled to recover after an early promising start by openers Ryan Rickelton and Aiden Markram. The visitors reached 57/0 in 10 overs but collapsed to 159 all out, highlighting India's depth and adaptability in both bowling and strategy.

India ended Day 1 at 37/ 1, trailing by 122 runs, with KL Rahul and Washington Sundar negotiating the final overs under fading light to

prevent further damage.

While the stump-mic comment drew attention off field, India's performance underscored the team's professionalism, tactical intelligence and dominance in home conditions. With Day 2 ahead, India will look to leverage their bowling advantage and maintain pressure on the South African batting lineup, while the stump-mic incident remains a talking point about the fine line between competitive banter and controversy in modern Test cricket

Gandas' professional win saw him pick up a cheque worth INR 15 lakh that also lifted him from 14th to seventh position in the PGTI Order of Merit.Seventeen-yearold rookie Manoj S, the third-round leader, who was looking to become the youngest player to win as a professional on the

PGTI, shot a last round of 75 to finish tied fourth at six-under 282 along with Shaurya Bhattacharya (71),

I had posted seven top-10s in the last nine events, so the game was trending well and I knew that it was just a matter of time before I won.

"I was a little frustrated with the double-bogey on the 16th but then just decided to let it pass and rather focus on what I had thought I would play it like I had done through the week by ensuring that I found the centre of the fairway. That's exactly what I did and it paid off for me. "This year has become even more special forme as I became a father just two months back. This is the first time my twomonth-old son has travelled to an event and I'm delighted to lift the trophy with him in my arms and my wife beside me."

## **ISSF Cairo World Shooting Championship:** Esha wins bronze in women's 25m pistol

New Delhi, Nov 14 (UNI): Former Asian, Mixed Team and Junior World champion Esha Singh nailed a maiden individual world championship medal, claiming bronze in the women's 25m Pistol Olympic event at the Olympic Shooting range in Cairo on Friday.

The Indian shot a score of 30 in the final to finish behind in-form Chinese Yao Qianxun (silver, score: 38) and Korea's reigning Olympic Champion Yang Jiin (gold, score: 40).

Esha's effort came as India wrapped up engagements in the 10-Olympic events on schedule at the **International Shooting** Sport Federation (ISSF) World Championship Rifle/Pistol, Cairo 2025,

with a historic haul of one gold, four silver and two bronze medals. Overall, India lie third on the table with three gold, five silver and four bronze medals, behind leaders China with 10 golds and Korea, who are second with six gold medals.

Beginning the day in fourth and seventh spots respectively, Esha and double Olympic medalist Manu Bhaker, shot confident rapid-fire rounds to sail into the top eight with scores of 587 and 586 respectively. Esha took fifth while Manu took the sixth qualifying spot in the field of 86.

Yang topped qualifications as well with 591, which came on the back of a stunning 300/ 300 in the rapid round.

Mixed team silver medalist in Paris Sevval Tarhan of Turkey along with the experienced Iranian Haniyeh Rostamiyan and France's former European and junior world champion Lamolle Mathilde, also went through. Unknown North Korean Kim Hyon Suk made up the final eight.Rahi Sarnobat's 572 was not enough for the Indian trio to win a team medal as they finished fourth with a tally of 1745, three short of the bronze winning French team.

Yang laid the gauntlet with a perfect five to start the 10-series final comprising of five rapidfire shots each. Both the Indians began with four hits, but at the first elimination stage after series four, Esha was third and Manu joint fourth, as Sevval was the first to bow out.

Yang and Yao broke away at this stage and the fight for bronze reached a climax, when Esha, Manu and Lamolle tied at 23-hits each after the seventh series. That brought about Manu's exit as she managed two hits even as Esha and Lamolle shot a perfect five.

The Frenchwoman then shot three as Esha struck a four to confirm her medal, bowing out after the ninth series as Yang outgunned Yao for gold.It was Esha's third individual ISSF medal of the year, having won gold and silver in the World Cup stages earlier. Her final international engagement will be at the ISSF World Cup Finals in Doha in December.
